Each AOG unit represents a right to receive one share of Class A Common Stock, subject to the restrictions and provisions set forth in the Agreement Among Principals, dated July 13, 2007, as amended and restated, by and among Joshua Harris, Leon Black and Marc Rowan, and the Exchange Agreement, as amended and restated, between the Issuer, AP Professional Holdings, L.P. and the other parties thereto. The AOG units were fully vested as of December 31, 2011.
