TABLE 1 ENFORCEMENT MILESTONES FISCAL 2015

- Obtained orders in SEC judicial and administrative proceedings requiring securities violators to disgorge illegal profits of approximately \$3.019 billion and to pay penalties of approximately \$1.175 billion.
- Sought orders barring 111 defendants and respondents from serving as officers or directors of public companies.
- Sought emergency relief from federal courts in the form of temporary restraining orders (TROs) to halt ongoing fraudulent conduct in 27 actions, and sought asset freezes in 41 actions.
- Filed 10 actions to enforce investigative subpoenas.
- Halted trading in securities of 334 issuers about which there was inadequate public disclosure.

In SEC-related criminal cases, prosecutors filed 134 indictments, informations, or contempts in Fiscal 2015.
