General

- THE NOTES OFFER A HIGHER INTEREST RATE THAN THE YIELD ON DEBT SECURITIES OF COMPARABLE MATURITY ISSUED BY US OR AN ISSUER WITH A COMPARABLE CREDIT RATING The notes will pay interest at a rate per annum depending upon the applicable Reference Stock, as indicated on the cover of this term sheet no. 14-S. We believe that the applicable interest rate is higher than the yield received on debt securities of comparable maturity issued by us or an issuer with a comparable credit rating. Because the notes are our senior unsecured obligations, any interest payment or any payment at maturity is subject to our ability to pay our obligations as they become due.
- MONTHLY INTEREST PAYMENTS The notes offer monthly interest payments at the applicable Coupon Rate set forth on the cover of this term sheet no. 14-S. 









Because the Final Share Price of \$70.00 is greater than the Initial Share Price of \$69.00, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 2: The lowest closing price of the Reference Stock during the Monitoring Period was \$34.50 and the Final Share Price is \$68.00. Because the Final Share Price of \$68.00 is less than the Initial Share Price of \$69.00 and the closing price of the Reference Stock declined by more than the Protection Amount on at least one day during the Monitoring Period, you will receive the Physical Delivery Amount of shares of the Reference Stock, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$68.00, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$985.51.

Example 3: The closing price of the Reference Stock between the Pricing Date and before the Observation Date does not reflect a decline of more than the Protection Amount. However, the closing price of the Reference Stock on the Observation Date is \$34.50, a decline of more than the Protection Amount. Because the Final Share Price of \$34.50 is less than the Initial Share Price of \$69.00 and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$34.50, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$500.

Example 4: The Final Share Price of \$55.20 is less than the Initial Share Price of \$69.00 but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note, even though the Final Share Price of \$55.20 is less than the Initial Share Price of \$69.00.

Regardless of the performance of the Reference Stock or the payment you receive at maturity, you will receive interest payments, for each \$1,000 principal amount note, in the aggregate amount of approximately \$90.50 over the term of the notes. If we had priced the notes on April 2, 2007, you would have received 14 shares of the Reference Stock or, at our election, the Cash Value thereof, at maturity, provided the Final Share Price declined from the Initial Share Price and the closing price of the Reference Stock declined by more than the Protection Amount from the Initial Share Price on at least one day during the Monitoring Period. The actual number of shares of the Reference Stock, or the Cash Value thereof, you receive at maturity and the actual Protection Amount applicable to your notes may be more or less than the amounts displayed in this hypothetical and will depend in part on the closing price of the Reference Stock on the pricing date.

The actual commission received by JPMSI may be more or less than \$35.80 and will depend on market conditions on the pricing date. In no event will the commission received by JPMSI, exceed \$60.00 per \$1,000 principal amount note.

If the notes linked to the common stock of Garmin priced on April 3, 2007, JPMSI, acting as agent for JPMorgan Chase & Co., would receive a commission of approximately \$35.00 per \$1,000 principal amount note and would use a portion of that commission to allow selling concessions to other dealers of approximately \$27.50 per \$1,000 principal amount note. The concessions of \$27.50 include concessions to be allowed to selling dealers and concessions to be allowed to an arranging dealer. The actual commission received by JPMSI may be more or less than \$35.00 and will depend on market conditions on the pricing date. In no event will the commission received by JPMSI, exceed \$60.00 per \$1,000 principal amount note.

If the notes linked to the common stock of Goldman Sachs priced on April 3, 2007, JPMSI, acting as agent for JPMorgan Chase & Co., would receive a commission of approximately \$39.00 per \$1,000 principal amount note and would use a portion of that commission to allow selling concessions to other dealers of approximately \$29.50 per \$1,000 principal amount note. The concessions of \$29.50 include concessions to be allowed to selling dealers and concessions to be allowed to an arranging dealer. The actual commission received by JPMSI may be more or less than \$39.00 and will depend on market conditions on the pricing date. In no event will the commission received by JPMSI, exceed \$60.00 per \$1,000 principal amount note.

If the notes linked to the common stock of Lehman Brothers priced on April 3, 2007, JPMSI, acting as agent for JPMorgan Chase & Co., would receive a commission of approximately \$40.80 per \$1,000 principal amount note and would use a portion of that commission to allow selling concessions to other dealers of approximately \$30.40 per \$1,000 principal amount note. The concessions of \$30.40 include concessions to be allowed to selling dealers and concessions to be allowed to an arranging dealer. The actual commission received by JPMSI may be more or less than \$40.80 and will depend on market conditions on the pricing date. In no event will the commission received by JPMSI, exceed \$60.00 per \$1,000 principal amount note.
