**PLEASE TAKE NOTICE** that the Order Appointing Distribution Agent entered on May 2, 2006, by the U.S. District Court, For the District of Columbia, ("the Court") directed the Distribution Agent ("Agent") in said action, Richard Weissman, to determine the lawful claims of investors in PAY POP, INC. arising out of the alleged conduct of, among others, CIBC Mellon Trust Company, Daryl G. Desjardins, Sean Nevett, Warren J. Soloski, Robert Zaba, and Ronald Brouillette (collectively, "Pay Pop")

**PLEASE TAKE FURTHER NOTICE** that with respect to filing proofs of claim:

**LAST DAY TO FILE PROOF OF CLAIM**

Any person or entity that asserts a claim or interest against Pay Pop Inc., for the payment for stock of Pay Pop, Inc., **must file** a proof of claim with the Distribution Agent **on or before January 15, 2007**. That is the last day by which a claim may be filed. **This date is called the "Bar Date". Claims filed after the Bar Date may be denied by the Court. Denial of a claim will result in no distribution to a claimant of any portion of the funds held by the Court.**

All original Proofs of Claim must be filed with the Agent at 5959 Topanga Canyon

Boulevard, Suite 255, Woodland Hills, California 91367 **on or before the Bar Date.** THE PROOF OF CLAIM FORMS ARE AVAILABLE AT THE DISTRIBUTION AGENT'S OFFICE.

YOU ARE REQUIRED TO FILE A FULLY COMPLETED AND SIGNED PROOF OF CLAIM IF YOU SEEK RECOVERY OF MONEY FROM THE FUNDS HELD BY THE AGENT.

### **CONSENT TO JURISDICTION OF THE COURT**

By filing a proof of claim with the Agent, you agree that the Court shall have jurisdiction over all claims identified in your proof of claim ("Claims") and over all aspects of your Claims, including but not limited to, (a) the allowed amount; (b) priority in distribution; (c) scheduling and allocation of the funds available to satisfy your Claims (if any are available); and (d) objections or disputes as to the allowed amount. All objections and disputes shall be submitted to the Court upon motion practice for hearing and a final ruling thereon. The matter shall be heard by the Court without a jury.

**WARNING:** A PROOF OF CLAIM MUST BE TIMELY DELIVERED TO AND RECEIVED BY THE AGENT OR YOU MAY BE COMPLETELY BARRED AND PRECLUDED BY THE COURT FROM PARTICIPATING IN ANY DISTRIBUTION OF THE ASSETS OF PAY POP, INC., CIBC, et al. HELD BY THE COURT.
