<u>Summary of Application</u>: Applicants request an order under sections 6(c) and 23(c)(3) of the Act for an exemption from certain provisions of rule 23c-3 to permit certain registered closed-end investment companies to make repurchase offers on a monthly basis.

<u>Applicants</u>: Nuveen Enhanced Floating Rate Income Fund, Nuveen Fund Advisors, LLC, Nuveen Asset Management, LLC, and Nuveen Securities, LLC.

<u>Filing Date</u>: The application was filed on December 6, 2023.
