COMMISSION ANNOUNCEMENTS

ADDITION TO WEEKLY CALENDAR

David S. Ruder, Chairman of the Commission, will testify before the Senate Banking Committee on Thursday, March 31, in Room 538 of the Dirksen Senate Office Building. The subject will be recommendations based on the October 1987 stock market break. The time will be announced.

ADMINISTRATIVE PROCEEDINGS

NASD SANCTIONS AGAINST ZESTER HERBERT HATFIELD REDUCED

The Commission reduced sanctions imposed by the NASD on Zester Herbert Hatfield, an Alexandria, Virginia securities salesman. The NASD censured Hatfield, fined him \$25,000, and barred him from association with any NASD member. The Commission reduced Hatfield's sanctions to a \$12,500 fine and censure.

The Commission found, as had the NASD, that in 1982 and 1984, while in the employ of two different NASD member firms, Hatfield sold securities in his own ventures without giving his employers prior written notice of his activities, as required. However, the Commission concluded that the nature of Hatfield's misconduct did not warrant the extremely severe sanctions imposed by the NASD. (Rel. 34-25488)

CIVIL PROCEEDINGS

RECEIVER ORDERED FOR OREO MINES, INC. AND OREX, INC.

The Fort Worth Regional Office announced that on March 15 U.S. District Judge Robert B. Maloney, Northern District of Texas (Dallas), entered an order of preliminary injunction against OREO Mines, Inc., OREX, Inc., William R. Cook, Bill W Schmidt, Tyrus Rex Mulkey, and Douglas Litchfield to prohibit further violations of the securities and broker-dealer registration and antifraud provisions of the securities laws. Judge Maloney also appointed a receiver for OREO and OREX and extended freeze orders over the assets of Cook, Schmidt, Mulkey, and Litchfield.

The Complaint alleges that defendants engaged in a boiler-room solicitation campaign to fund gold mining and processing activities in California. After a three-day hearing, the Court found that the defendants' ore mining and processing agreements were investment contract securities and that these securities had been sold absent registration or exemption, and that defendants had made misrepresentations and omissions of material facts in their presentations and sales brochures. (SEC v. OREO Mines, Inc., et al., Civil Action No. CA 3-88-0364-T). (LR-11683)

INVESTMENT COMPANY ACT RELEASES

FREEDOM INVESTMENT TRUST

A notice has been issued giving interested persons until April 18 to request a hearing on an application filed by Freedom Investment Trust (Trust), formerly filed under Freedom Telecommunications Fund, Tucker, Anthony & R.L. Day, Inc., and Tucker Anthony Management Corporation. The application requests an order approving the exchange of shares of a new portfolio of the Trust, an open-end, management investment company, for securities of The Telephone Exchange Fund--AT&T Shares, a unit investment trust, and amends prior orders to permit certain waivers of contingent deferred sales charges. (Rel. IC-16334 - March 23)

HOLDING COMPANY ACT RELEASES

GEORGIA POWER COMPANY

An order has been issued authorizing Georgia Power Company, subsidiary of The Southern Company, to sell certain utility assets for approximately \$2.7 million. (Rel. 35-24606 - March 23)

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation (GPU), a registered holding company, to amend its Articles of Incorporation and By-Laws to (a) provide staggered terms for the Board of Directors and increase the minimum number of directors from four to five; (b) increase the number of authorized shares of stock; and (c) provide for a notice period before the next annual meeting during which any shareholder proposal must be submitted. GPU was also authorized to solicit proxies for its May 2, 1988 Annual Meeting of Shareholders in connection with these proposed amendments to its Articles and By-Laws. (Rel. 35-24607 - March 23)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING SOUGHT

Notices have been issued giving interested persons until April 7 to comment on the application of the following stock exchanges for unlisted trading privileges in specified number of issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system: Midwest Stock Exchange - three and three issues [two separate applications. (Rel. 34-25490; 34-25491)]; and the Philadelphia Stock Exchange - five issues. (Rel. 34-25492)

SELF-REGULATORY ORGANIZATIONS

PARTIAL ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted partial accelerated approval to a proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-88-9) to add new series calculated on an arithmetic average to correspond with existing open series of the Value Line Composite Stock Index contracts that are calculated on a geometric average. (Rel. 34-25485)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-88-1) and the Pacific Stock Exchange (SR-PSE-87-21) to extend the market index option escrow receipt pilot program until June 30, 1988. (Rel. 34-25486)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by: The American Stock Exchange (SR-Amex-88-1) to extend the AUTO-EX pilot plan for emergency situations until June 30, 1988. (Rel. 34-25487); and The Municipal Securities Rulemaking Board (SR-MSRB-87-12) to amend its rules concerning the delivery of interchangeable municipal securities and the confirmation of transactions in those securities. The rule change takes effect September 18, 1988. (Rel. 34-25489)

ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
