## CIVIL PROCEEDINGS

### FINAL JUDGMENT OF PERMANENT INJUNCTION ENTERED AGAINST HARRY EDWARD THOMAS

The Denver Regional and Salt Lake City Branch Offices announced that on May 12 U.S. District Court Judge J. Thomas Greene, District of Utah, entered Final Judgments of Permanent Injunction against Harry Edward Thomas, of Sandy, Utah, and Petro Corp., a Nevada corporation. The Judgments enjoin defendants from future violations of the registration and antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934. Defendants consented to the Judgments without admitting or denying the allegations of the Complaint, which was filed on April 14, 1986. The Complaint also named Thomas R. Blonquist, of Salt Lake City, Utah, as a defendant in the action for permanent injunction. The civil action against Blonquist is still in progress. (SEC v. Harry Edward Thomas, et al., USDC UT, Civil Action No. 86-0313G). (LR-11751)

### TWO CIVIL ACTIONS SETTLED

The Commission settled two pending actions against N. Norman Muller [SEC v. Muller, Civil Action No. 87-1453, D.D.C.; and SEC v. American Land Company (ALC) and Muller, 87 Civ. 3669, DNE, SDNY]. In the first case, the Commission alleges that Muller issued and disseminated an acquisition offer containing materially false and misleading statements concerning his ability to acquire Talley Industries, Inc. In the second case, the Commission alleges that Muller aided and abetted ALC's failure to file numerous periodic reports, and that Muller aided and abetted ALC's failure to make and keep required books and records.

Muller consented, without admitting or denying the allegations, to a Final Order enjoining him from making any untrue statement of a material fact or omitting to state a material fact necessary in order to make the statement made, in light of the circumstances under which they were made, not misleading, in connection with the purchase or sale of any security; and from aiding and abetting or causing any issuer's violation of Exchange Act Sections 13(a) and 13(b)(2)(A) and Rules 12b-25, 13a-1, and 13a-13. ## INVESTMENT COMPANY ACT RELEASES

### AMERICAN HOME ACCEPTANCE CORPORATION
