## COMMISSION ANNOUNCEMENTS

---

### LORI RICHARDS NAMED AS ASSOCIATE ADMINISTRATOR OF THE LOS ANGELES REGIONAL OFFICE

Lori Richards has been named as the Associate Regional Administrator for Enforcement of the Commission's Los Angeles Regional Office. She will be responsible for the Commission's enforcement program in the states of California, Arizona, Hawaii and Nevada. Ms. Richards joined the Commission staff in 1985 and was formerly an Assistant Administrator in the Los Angeles office.

## ADMINISTRATIVE PROCEEDINGS

---

### GARY TODRYK BARRED

The Commission instituted public administrative proceedings against Gary J. Todryk (Todryk), a former registered representative for a broker-dealer registered with the Commission, under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934, based upon his felony criminal conviction on three counts of taking unfair advantage of a customer. Simultaneously, Todryk submitted an offer of settlement which the Commission accepted. Accordingly, the Commission entered an Order Instituting Public Proceedings, Making Findings and Imposing Remedial Sanctions which finds, among other things, that Todryk was convicted of a felony arising out of the business of a broker-dealer and involving the misappropriation of funds. The Commission barred Todryk from association with any broker, dealer, investment adviser, investment company or municipal securities dealer. (Rel. 34-31017)

### ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST DENIS LUSTIG

The Commission announced the entry of an Order Instituting Public Administrative Proceedings Pursuant to Rule 2(e) of the Commission's Rules of Practice, and Opinion and Order of the Commission against Denis Lustig. Solely for the purpose of the proceedings and without admitting or denying the findings, Lustig submitted an Offer of Settlement in which he consented to the findings of fact and the imposition of a permanent bar, denying him the privilege of appearing or practicing before the Commission as an accountant, which the Commission determined to accept.

Lustig was Treasurer of Coated Sales, Inc. (Coated) from 1987 to 1988. From 1976 through 1986, Lustig was associated with the accounting firm Finkle & Ross, located in Cedarhurst, New York. The Commission's complaint, filed on October 26, 1990, alleges that Lustig violated and aided and abetted violations of the federal securities laws through his participation in a massive financial fraud at Coated in the years 1985 through 1988. The complaint alleges that Lustig and others engaged in a scheme to inflate Coated's sales and earnings through, among other acts, the creation of phony invoices purporting to show sales of goods by Coated. Further, the complaint alleges that Lustig disguised the inflated accounts receivable by directing company clerks to create phony invoices in response to questions from Coated's auditors. #### CEASE AND DESIST ORDER ENTERED AGAINST DOUGLAS KASS

The Commission instituted public administrative proceedings against Douglas A. Kass (Kass) under Section 21C of the Securities Exchange Act of 1934. Simultaneously, Kass submitted an offer of settlement which the Commission accepted. Between April 1989 and November 1990, Kass was a member of two separate reporting groups for which Kass filed Schedules 13D with the Commission, in connection with the groups' holdings in the common stock of H.H. Robertson Company (HHR). The Commission's Order Instituting Proceedings finds, among other things, that the Schedules 13D and amendments which Kass filed were deficient in several respects and, ultimately, failed to timely and accurately disclose that Kass intended to dispose entirely of his group's HHR holdings. The Commission ordered that Kass cease and desist from committing or causing violations of, and from committing or causing any future violations of Section 13(d) of the Exchange Act and Rules 12b-20, 13d-1 and 13d-2 promulgated under the Exchange Act. ### CIVIL PROCEEDINGS

---

#### FINAL JUDGMENTS ENTERED AGAINST MALENFANT, PAYNE AND PAYNE FINANCIAL GROUP

The Commission announced that the U.S. District Court for the Southern District of New York entered Final Judgments of Permanent Injunction as to Mark Malenfant on August 3, and as to Thomas C. Payne and Payne Financial Group on August 13. Without admitting or denying the allegations of the Commission's complaint filed on May 1, 1991, the three defendants consented to be permanently enjoined from future violations of Sections 9(a)(1), 9(a)(2) and 10(b) of the Exchange Act and Rule 10b-5 thereunder. As part of his settlement with the Commission, Malenfant consented to be permanently barred from association with any broker, dealer, investment adviser, investment company or municipal securities dealer.

The complaint in SEC v. Malenfant et al., 91 Civ. 2996 (MBM) alleged that the defendants purchased or sold, or caused or solicited the purchase or sale, of common stock of Texscan Corporation (Texscan) for the unlawful purpose of manipulating upwards the price of Texscan stock, beginning on or about April 16, 1991. The manipulative scheme was interrupted on April 22, 1991 when the Commission suspended trading in Texscan common stock. [SEC v. Mark P. Malenfant, Thomas C. ## LISTING, DELISTING AND UNLISTED TRADING ACTIONS

---

### DELISTING GRANTED

An order has been issued granting the application of the Boston Stock Exchange to strike from listing and registration Dandees Enterprises, Inc., Common Stock, No Par Value. (Rel. 34-31040)

### WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until September 3, 1992 to comment on the application of First Republic Bancorp, Inc. to withdraw its Common Stock \$.01 Par Value, from listing and registration on the American Stock Exchange. (Rel. 34-31041)

## SELF-REGULATORY ORGANIZATIONS

---

### PROPOSED RULE CHANGES

The Pacific Stock Exchange filed a proposed rule change (SR-PSE-92-12) to list and trade index options on the Wilshire Small Cap Index, a broad-based, market-weighted index composed of 250 domestic stocks designed to reflect the characteristics and market performance of small stocks generally. Publication of the proposal is expected in the Federal Register during the week of August 17. (Rel. 34-31043)

The American Stock Exchange filed a proposed rule change (SR-Amex-92-22) to permit trading in Buy-Write Options Unitary Derivatives (BOUNDS), long-term options with a duration of up to 60 months which have the same economic characteristics as covered calls. The Amex also proposes to amend its existing rules to permit the listing of long-term equity options (LEAPs) with a duration of up to 60 months. Publication of the proposal is expected in the Federal Register during the week of August 17. (Rel. 34-31044)

The Cincinnati Stock Exchange filed a proposed rule change (SR-CSE-92-06) to amend Article VII, Section 1 of its Code of Regulations (By-Laws) to permit the same individual to serve as Exchange President and Chairman of the Board of Trustees. Publication of the proposal is expected in the Federal Register during the week of August 17. (Rel. 34-31045)

## ACQUISITION OF SECURITIES

---

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column - 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
