John Hancock Life Insurance Company of New York ("JH") and John Hancock Life Insurance Company of New York Separate Account B (the "Separate Account") submitted an application under Rule 406 requesting confidential treatment for information they excluded from three exhibits to a registration statement on Form N-6 (Post-Effective Amendment No. 9) filed on December 15, 2016.
