**bebe stores, inc. Announces April 2005 Sales;
Same Store Sales Increase 31.2%**

BRISBANE, CALIF. – May 5, 2005 – bebe stores, inc. (Nasdaq: BEBE) today reported retail sales of \$40.3 million for the four-week period ended April 30, 2005, an increase of 42.4% compared to sales of \$28.3 million for the four-week period ended May 1, 2004.

Same store sales for the four-week period ended April 30, 2005 increased 31.2% compared to an increase of 10.0% for April 2004. For fiscal April 2005, same store sales were determined using a comparable period of 28 days.

Retail sales for the year-to-date period beginning July 1, 2004 and ending April 30, 2005 were \$410.5 million compared to \$305.3 million for the year-to-date period beginning July 3, 2003 and ending May 1, 2004, an increase of 34.5%. Same store sales for the year-to-date period beginning July 1, 2004 and ending April 30, 2005 increased 23.7% compared to an increase of 9.7% for the year-to-date period beginning July 1, 2003 and ending April 30, 2004.

bebe stores, inc. designs, develops and produces a distinctive line of contemporary women's apparel and accessories, which it markets under the bebe, BEBE SPORT and bebe O brand names. bebe currently operates 208 stores, of which 178 are bebe stores and 30 are BEBE SPORT stores. These stores are located in the United States, Puerto Rico and Canada. In addition, we have an online store at www.bebe.com.
