**bebe stores, inc. Announces April 2006 Sales;
Same Store Sales Increase 5.7%**

BRISBANE, CALIF. – May 4, 2006 – bebe stores, inc. (Nasdaq: BEBE) today reported retail sales of \$46.2 million for the four-week period ended April 29, 2006, an increase of 14.6% compared to sales of \$40.3 million for the four-week period ended April 30, 2005. Same store sales for the four-week period ended April 29, 2006 increased 5.7% compared to an increase of 31.2% for April 2005.

Retail sales for the year-to-date period ending April 29, 2006 were \$472.1 million compared to \$410.5 million for the year-to-date period ending April 30, 2005, an increase of 15.0%. Same store sales for the year-to-date period ending April 29, 2006 increased 6.9% compared to an increase of 23.7% for the year-to-date period ending April 30, 2005.

As of April 29, 2006, finished goods inventory per square foot was approximately 6% higher as compared to the prior year.

bebe stores, inc. designs, develops and produces a distinctive line of contemporary women's apparel and accessories, which it markets under the bebe, BEBE SPORT and bebe O brand names. bebe currently operates 231 stores, of which 175 are bebe stores, 20 are bebe outlet stores and 36 are BEBE SPORT stores. These stores are located in the United States, Puerto Rico and Canada. In addition, there is an online store at www.bebe.com.
