- (1) Pursuant to the Merger Agreement dated June 29, 2005 between Capital Bank Corporation, a North Carolina corporation (the "Company") and 1st State Bancorp, Inc., a Virginia corporation ("FSBC"), each share of FSBC common stock has been automatically converted into the right to receive, at the election of the holder and subject to certain allocation and proration procedures described in the Merger Agreement, either: (i) 2.434788 shares of the common stock of the Company, rounded to the nearest whole share, (ii) an amount equal to \$37.15 in cash, or (iii) 1.684457 shares of the common stock of the Company, rounded to the nearest whole share, plus an amount equal to \$11.4486 in cash. The reporting person had been making annual filings on Schedule 13G for FSBC. In the merger, the reporting person elected to take the first option which became effective January 26, 2006. At that time the reporting person converted his FSBC shares and he received 661,495 shares of the Company. Subsequently the reporting person has acquired an additional 49,019 shares of the Company in his own name and 139,000 shares were acquired by the Maurice & Ann Koury Charitable Trust (the "Charitable Trust") which is a charitable remainder trust in which the reporting person is the sole trustee.
- (2) The aggregate number of shares does not include any of the following: 42,608 shares held by the Maurice J. Koury Foundation, Inc. ("Foundation"), 79,260 shares held by Carolina Hosiery Mills, Inc. (the "Company"), and 10,226 shares held by the Carolina Hosiery Mills, Inc. Employee Profit Sharing Trust ("Trust"). The reporting person is: (a) one of four directors and president of the Foundation; (b) a director, president and 23.6% shareholder of the Company, and (c) a trustee of the Trust. In all such cases, the reporting person may have input into decisions concerning the voting power over the shares held by the Foundation, the Company and the Trust in certain limited circumstances.
