We note your response to comment three in our letter dated June 25, 2009 and your submission on EDGAR of the supplemental letter to us stating that you are registering the exchange offer in reliance on our position enunciated in the *Exxon Capital Holdings Corp.*, SEC No-Action Letter (April 13, 1989), *Morgan Stanley & Co. Inc.*, SEC No-Action Letter (June 5, 1991) and *Shearman & Sterling*, SEC No-Action Letter (July 2, 1993). Further, we note in that submission that you have included the representations contained in the *Morgan Stanley* no-action letter. However, it does not appear that you have included the representations contained in the *Shearman & Sterling* no-action letter. Therefore, please submit on EDGAR a revised supplemental letter including the representations contained in both the *Morgan Stanley* and *Shearman & Sterling* no-action letters.
