The date of report on the cover page should be the date such conclusion was reached. Also, please revise to specifically state that previously issued financial statements for the second quarter of 2007 should

no longer be relied upon or otherwise advise. Refer to the requirements of Item 4.02(a)(1) of Form 8-K.

2. Please incorporate by reference the information previously reported in Form 8-K/A filed November 7, 2008 or provide a brief description of the error. Refer to general instruction B.3. and Item 4.02(a)(2) of Form 8-K.
3. Please disclose whether the audit committee, or the board of directors in the absence of an audit committee, or authorized officer(s), discussed with your independent accountant the matters disclosed in the filing. Refer to Item 4.02(a)(3) of Form 8-K.

As appropriate, please amend your filing and respond to these comments within five business days or tell us when you will provide us with a response. You may wish to provide us with marked copies of the amendment to expedite our review. Please furnish a cover letter that provides any requested information. Detailed cover letters greatly facilitate our review. Please understand that we may have additional comments after reviewing your amendment and responses to our comments. Please submit your response letter on EDGAR.

We urge all persons who are responsible for the accuracy and adequacy of the disclosure in the filing to be certain that the filing includes all information required under the Securities Exchange Act of 1934 and that they have provided all information investors require for an informed investment decision. Since the company and its management are in possession of all facts relating to a company's disclosure, they are responsible for the accuracy and adequacy of the disclosures they have made.

In addition, please be advised that the Division of Enforcement has access to all information you provide to the staff of the Division of Corporation Finance in our review of your filing or in response to our comments on your filing.
