Item 1. Security and Issuer.

This Schedule 13D relates to the acquisition of shares of Common Stock (the “Shares”) of Extensions, Inc., whose principal executive offices are located at:

Item 2. Identity and Background.

BTR Nest LLC is a Wyoming LLC whose business address is 3720 West Alabama # 7104, Houston, Texas 77027. Its sole member and manager is Morgan Dahse. Its principal business is making private investments. During the last five years, the Reporting Person and its affiliates have not been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors), and have not been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction that resulted in a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws, or that found any violation with respect to such laws.

Morgan Dahse is a United States citizen whose business address is 770 South Post Oak Dr, Houston, TX 77056, and whose principal occupation is as a private investor. During the last five years, the Reporting Person has not been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors), and has not been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction that resulted in a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws, or that found any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration.

The Reporting Persons acquired the Shares in December, 2008 from a shareholder in a private transaction in consideration for \$15,000. This consideration was paid from the working capital of BTR Nest LLC.

Item 4. Purpose of Transaction.

The Reporting Persons acquired the Shares for investment purposes. The Reporting Persons do not have any present plan or proposal as a stockholder which relates to, or would result in any action with respect to, the matters listed in paragraphs (b) through (j) of Item 4 of Schedule 13D. In the future, the Reporting Persons may decide to acquire additional shares of Common Stock in the open market or through a private transaction, or to sell any or all shares of Common Stock.

Item 5. Interest in Securities of the Issuer.

The Reporting Person beneficially owns the amount and type of shares first reported in Part II of the Cover Page hereto, hereby incorporated by this reference into this Item 5. The Reporting person has sole voting and disposition rights to all shares reported. During the past sixty days, no transactions in the class of securities reported were effected by the Reporting Person.
