1. Please revise your Form 8-K to clarify who concluded that your previously issued financial statements should no longer be relied upon (i.e. board of directors, a committee of the board of directors or the officers of the company authorized to take such action).
2. Please revise your Form 8-K to include a statement about whether the audit committee discussed the non-reliance of previously issued financial statements with your independent accountant.
3. Please revise your Form 8-K to describe your plans for filing an amended Form 10-Q for the three and nine month period ended September 30, 2006 (including estimated filing date).
4. Please tell us if your certifying officers have considered the effect of the error on the adequacy of your previous disclosures regarding internal controls and the effectiveness of disclosure controls and procedures as of the end of the period covered by your Form 10-Q for the period ended September 30, 2006. Additionally, tell us what affect the error had on your current evaluation of disclosure controls and procedures as of the end of your fiscal year ended December 31, 2006.

As appropriate, please amend your filing and respond to these comments within five business days or tell us when you will provide us with a response. You may wish to provide us with marked copies of the amendment to expedite our review. Please furnish a cover letter with your amendment that keys your responses to our comments and provides any requested information. Detailed cover letters greatly facilitate our review. Please understand that we may have additional comments after reviewing your amendment and responses to our comments.

We urge all persons who are responsible for the accuracy and adequacy of the disclosure in the filing to be certain that the filing includes all information required under the Securities Exchange Act of 1934 and that they have provided all information investors require for an informed investment decision. Since the company and its management are in possession of all facts relating to a company's disclosure, they are responsible for the accuracy and adequacy of the disclosures they have made.
