We invite you to attend our annual meeting ("Meeting") of holders of common shares of Enerplus Corporation ("Enerplus"), which will be held on Thursday, May 3, 2018 at 1:00 p.m. (Calgary time) at the Bankers Hall Auditorium, Lower Level, 315 – 8<sup>th</sup> Avenue SW, Calgary, Alberta. The Meeting will have the following purposes:

1. To receive the consolidated financial statements of Enerplus for the year ending December 31, 2017, together with the auditors' report on those statements;

4. To vote, on an advisory, non-binding basis, to accept Enerplus' approach to executive compensation; and
