1. In accordance with Item 304(a)(1)(iv) of Regulation S-B, please revise paragraph two of your Form 8-K filing to disclose whether there were any disagreements with S.W. Hatfield, CPA during the two most recent fiscal years and any subsequent interim period.
2. Upon review of your Form 10-KSB for each of the fiscal years ended March 31, 2006 and March 31, 2005, we noted a going concern audit opinion modification. Please

revise paragraph three of your Form 8-K to address this opinion modification (e.g. uncertainty) in accordance with Item 304(a)(1)(ii) of Regulation S-B.

3. Please file an updated letter from S.W. Hatfield, CPA as an Exhibit 16 in accordance with Item 304(a)(3) of Regulation S-B. This letter should reflect their agreement or disagreement with any disclosures in your amended Form 8-K filing.

As appropriate, please amend your filing and respond to these comments within five business days or tell us when you will respond. You may wish to provide us with marked copies of the amendment to expedite our review. Please furnish a cover letter with your amendment that keys your responses to our comments and provides any requested information. Detailed cover letters greatly facilitate our review. Please understand that we may have additional comments after reviewing your amendment and responses to our comments.

We urge all persons who are responsible for the accuracy and adequacy of the disclosure in the filing to be certain that the filing includes all information required under the Securities Exchange Act of 1934 and that they have provided all information investors require for an informed investment decision. Since the company and its management are in possession of all facts relating to a company's disclosure, they are responsible for the accuracy and adequacy of the disclosures they have made.

In addition, please be advised that the Division of Enforcement has access to all information you provide to the staff of the Division of Corporation Finance in our review of your filing or in response to our comments on your filing.
