### Positioning:

- Offers 100% principal protection. If the Underlying Index never closes above the Upper Index Barrier or below the Lower Index Barrier on any trading day during the Observation Period, at the Maturity Date investors will receive 100% of their principal amount plus a return equal to the Absolute Index Return up to a maximum return of 20.0% to 23.0% (to be determined on the Trade Date) if the index return is positive and 15.0% if the index return is negative, paid at maturity.

### Best Case Scenario:

- Investors will receive their principal *plus* an amount equal to their principal *multiplied* by the Absolute Index Return, subject to the maximum return of 20.0% to 23.0% if the index return is positive and 15.0% if the index return is negative, paid at maturity.

### Worst Case Scenario:

## Selected Risk Factors

- **MARKET RISK** — The return on the Notes at maturity is linked to the performance of the Index and will depend on whether the Index closing level ever exceeds the Upper Index Barrier or falls below the Lower Index Barrier on any trading day during the Observation Period and the magnitude of the Absolute Index Return.
