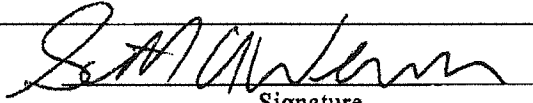


Opinion on the Financial Statements
