

Report of Independent Registered Public Accounting Firm

We have reviewed management's statements, included in the accompanying Assertions Regarding Exemption Provisions, in which (1) Woodbridge Financial Group, LLC identified the following provisions of 17 C.F.R. § 15c3-3(k) under which Woodbridge Financial Group, LLC claimed an exemption from 17 C.F.R. § 240.15c3-3: (k)(2)(i) (the "exemption provisions") and (2) Woodbridge Financial Group, LLC stated that Woodbridge Financial Group, LLC met the identified exemption provisions throughout the year ended December 31, 2015, without exception. Woodbridge Financial Group, LLC's management is responsible for compliance with the exemption provisions and its statements.

A review is substantially less in scope than an examination, the objective of which is the expression of an opinion on management's statements. Accordingly, we do not express such an opinion.

Based on our review, we are not aware of any material modifications that should be made to management's statements referred to above for them to be fairly stated, in all material respects, based on the provisions set forth in paragraph (k)(2)(i) of Rule 15c3-3 under the Securities Exchange Act of 1934.

## Assertions Regarding Exemption Provisions

We, as members of management of Woodbridge Financial Group, LLC ("the Company"), are responsible for compliance with the annual reporting requirements under Rule 17a-5 of the Securities Exchange Act of 1934. Those requirements compel a broker or dealer to file annual reports with the Securities Exchange Commission (SEC) and the broker or dealer's designated examining authority (DEA).
