Business and Anticipated Business Plan

- 6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.**

Voise acquires and organizes information to help defend against cyber attacks before they occur. We believe that Voise is a pioneer in applying advanced proprietary Library/Data Science & AI technology for extracting deep insight in understanding language well beyond that provided by conventional computer science applications. Its extensive history in delivering real-world, on-the-ground solutions for major brands such as Microsoft and eBay enables its successful application to the world's most challenging data interpretation problems. Voise's near-term strategy is to productize its Intelligence Briefing (IB) product line with initial application to cybersecurity. Our IB, basically a report of the external environmental status in a particular domain, identifies and ingests all publicly available information on cybersecurity, normalizes, standardizes, and correlates the data to extract maximum semantic meaning for use in security applications. We believe current cybersecurity solutions are falling short. Cybersecurity in general is plagued by the too much data, too little information problem where "you can't see the forest for the trees". Also, many current methods cannot convert data to timely, actionable intelligence. The health sector, for example, has a time lag between an attack and on average 255 days to detect with an additional 103 days to contain it based on our research. And it is getting worse. Our very method of intelligence gathering is under attack by hostile nations. The Wall Street Journal reports that small teams have outperformed major intelligence agencies like the CIA by using only publicly available data (articles, videos, messages, news reports, etc.). The Chinese have 100,000 analysts using this "Open Source" data while we have fallen way behind. We need to have our own automated method of Open Source Intelligence (OSINT) to catch up and excel. Voise offers proprietary breakthrough advances in actionable Intelligence Briefings (IB) for improved cybersecurity performance and reduced risk. Our IB is essentially a report filtered for relevance and delivered on an hourly, daily or weekly basis. It opens the eyes of the security analyst to have a clear picture of the cybersecurity landscape so he or she can determine effective courses of action. We believe Voise's Intelligence Briefing (IB) product is precisely in line with the OSINT initiative. It accesses all available data and processes it into high-quality, threat ontology yielding fresh insights. Voise's plan is to simply productize IB based on existing prototypes. Minimal or no software development is required, which

we believe will ensure rapid time to market. Voice is a business-to-business play. Engagements proceed in two phases. Phase I, Configuration, involves setting up the solution for the particular customer configuration, and typically takes from a few days to a month or so. Costs are borne by the customer or as a result of strategic R&D investment from the company. Phase II, Operational, involves a monthly fee for use of the configured solution. This phase is typically cost-free for the company, potentially resulting in very high margins.

7. Material factors that make an investment in Linguastat, Inc. speculative or risky:

1. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.
2. The Company may never receive a future equity financing, or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). If a liquidity event does not occur, such as a sale of the Company or an IPO, the purchasers could be left holding Company securities in perpetuity. The Company's securities have numerous transfer restrictions and will likely be highly illiquid, with potentially no secondary market on which to sell them. The securities have only a minority of voting rights and do not provide the ability to direct the Company or its actions.

3. In order to expand, the Company is raising funds, and may raise additional funds in the future, either by offerings of securities or through borrowing from banks or other sources. The terms of future capital raising, such as loan agreements, may include covenants that give creditors greater rights over the financial resources of the Company.
4. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
5. Potential customers may be less willing to invest in innovation and forward-looking improvements if they are facing an economic downturn. This may temporarily reduce our market size. Furthermore, a global crisis might make it harder to diversify.
6. The Company may extend the Offering deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the maximum offering amount even after the Offering deadline stated herein is reached. Your investment will not be accruing interest during this time and will simply be held until such time that Offering is closed, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you.
7. No governmental agency has reviewed the Company's offering and no state or federal agency has passed upon either the adequacy of the disclosure contained herein or the fairness of the terms of this offering.
8. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
9. The Company does not anticipate paying any cash dividends for the foreseeable future. The Company currently intends to retain future earnings, if any, for the foreseeable future, to repay indebtedness and to support its business. The Company does not intend in the foreseeable future to pay any dividends to holders of its shares of common stock.
10. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
11. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. Before investing, you should carefully consider the specific risks and disclosures related to both this offering type and the Company.
12. Your shares are not easily transferable. You should not plan on being able to readily transfer and/or resell your security. Currently there is no market or liquidity for these shares and the Company does not have any plans to list these shares on an exchange or other secondary market. While the Company must disclose certain information, since the Company is at an early-stage they may only be able to provide limited information about its business plan and operations because it does not have fully developed operations or a long history. The Company may also only be obligated to file information periodically regarding its business, including financial statements. A publicly listed company, in contrast, is required to file annual and quarterly reports and promptly disclose certain events — through continuing disclosure that you can use to evaluate the status of your investment.

15. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. Furthermore, the human and capital resources of the Company could be adversely affected by the need to defend actions under these laws, even if the Company is ultimately successful in its defense.

16. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. 17. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the

Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

18. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. It is not currently contemplated that registration under the Securities Act or other securities laws will be affected. Investors will not have the right to inspect the books and records of the Company or to receive financial or other information from the Company, other than as required by Regulation CF. Other security holders of the Company may have such rights. Regulation CF requires only the provision of an annual report on Form C and no additional information – there are numerous methods by which the Company can terminate annual report obligations, resulting in no information rights, contractual, statutory or otherwise, owed to Investors. This lack of information could put Investors at a disadvantage in general and with respect to other security holders.

20. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

21. *The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. Failure to obtain such financing on favorable terms could dilute or otherwise severely impair the value of the investor's Company securities.*

22. *There is no present public market for these Securities and we have arbitrarily set the price.*

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the

Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

23. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Each prospective Investor is encouraged to carefully analyze the risks and merits of an investment in the Securities and should take into consideration when making such analysis, among other, the Risk Factors discussed above.

Linguastat, Inc., doing business as Voise, is a company organized on December 19, 2005 under the laws of California. Voise acquires and organizes information to help defend against cyber attacks before they occur. Under the Company’s articles of incorporation, the total number of shares the Company shall have the authority to issue is 32,419,904 shares of common stock and 17,480,498 shares of preferred stock. 954,437 shares of the authorized preferred stock of the corporation are designated “Series A Preferred Stock”, 2,117,215 shares of the authorized preferred stock of the corporation are designated “Series AA Preferred

Stock”, and 14,408,846 shares of the authorized preferred stock of the corporation are designated “Series B Preferred Stock”. As of the date of the filing of this offering 6,421,985 shares of common stock are issued and outstanding, 954,437 shares of Series A Preferred Stock are issued and outstanding, 2,012,602 shares of Series AA Preferred Stock are issued and outstanding, and 7,204,429 shares of Series B Preferred Stock are issued and outstanding. The Preferred Stock shareholders have a right to receive dividends on each outstanding share of Preferred Stock in an amount at least equal to at least \$0.08 per share of Series A Preferred Stock, \$0.08 per share of Series AA Preferred Stock, and \$0.04 per share of Series B Preferred Stock, (subject to adjustments for splits and recapitalizations), before or simultaneously with any dividends paid to any other shareholders. Preferred Stock shareholders also have rights and preferences greater than common stock shareholders with regard to liquidation, dissolution or winding up, certain mergers, consolidations and asset sales. On any action or consideration at any meeting of shareholders, each holder of outstanding shares of Preferred Stock is entitled to cast the number of votes equal to the number of whole shares of common stock into which the shares of Preferred Stock are convertible. The Preferred Shares have certain anti-dilution provisions that could result in an adjustment of their conversion price into common stock upon issuance of additional shares of common stock. Please refer to the Second Amended and Restated Articles of Incorporation of the Company for significant details regarding the rights and privileges of Preferred Stock shareholders. In the year ended December 31, 2022, net revenue amounted to \$30,000, while the cost of goods sold was \$0. After operating expenses and other expenses, the Company recorded a net loss of \$169,465. Additionally, during the same year, the Company received a loan from one of the Company's advisors, Gerry Mason. The principal amount of the loan is \$2,530. Furthermore, in 2022, the company issued three SAFE notes totaling \$125,000. The notes are convertible into equity and have a valuation cap of \$10 million. They do not have a maturity date, nor do they carry any interest. Although the face amount of the three SAFE notes total \$125,000, the fair value of the notes is recorded as \$135,417 in the December 31, 2022 financial statements. The increase in the fair value of the notes is recorded as a non-operating expense of \$10,417 in the Company's statement of operations for the year ended December 31, 2022. In the year ended December 31, 2021, net revenue amounted to \$30,000, while the cost of goods sold was \$0. After operating expenses of \$393,536 and other income of \$105,297, the Company recorded a net loss of \$258,239. Additionally, the Company raised \$400,000 through the sale of Series B preferred stock in 2021. With this raise, the Company plans to use the proceeds primarily for research & development, general & administrative expenses, sales & marketing, commissions, and payroll.
