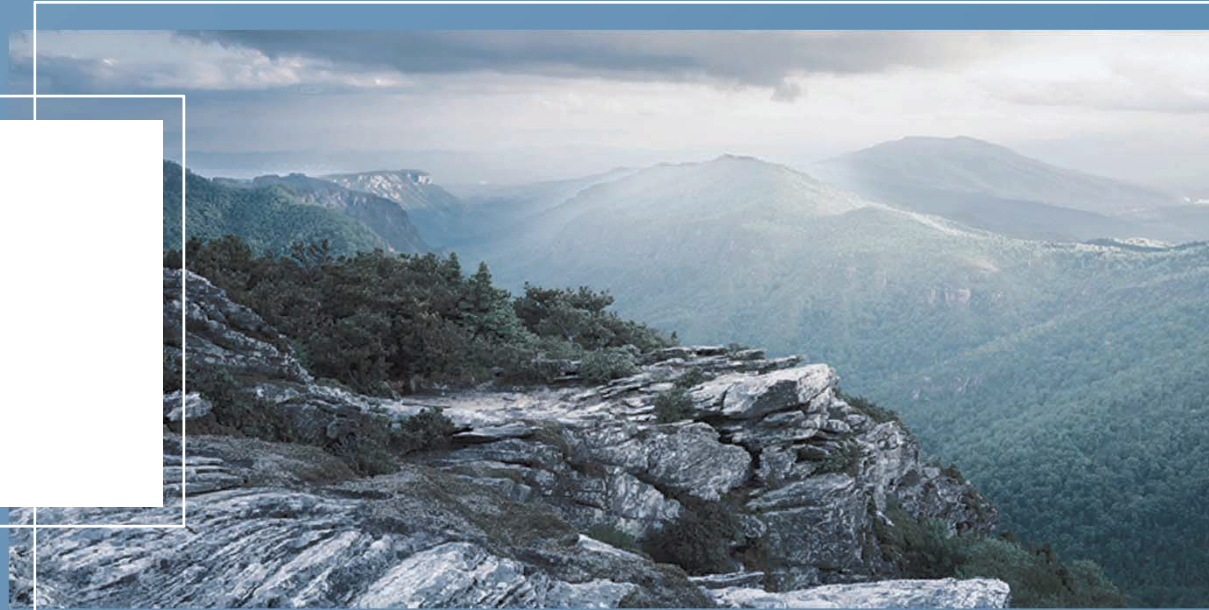

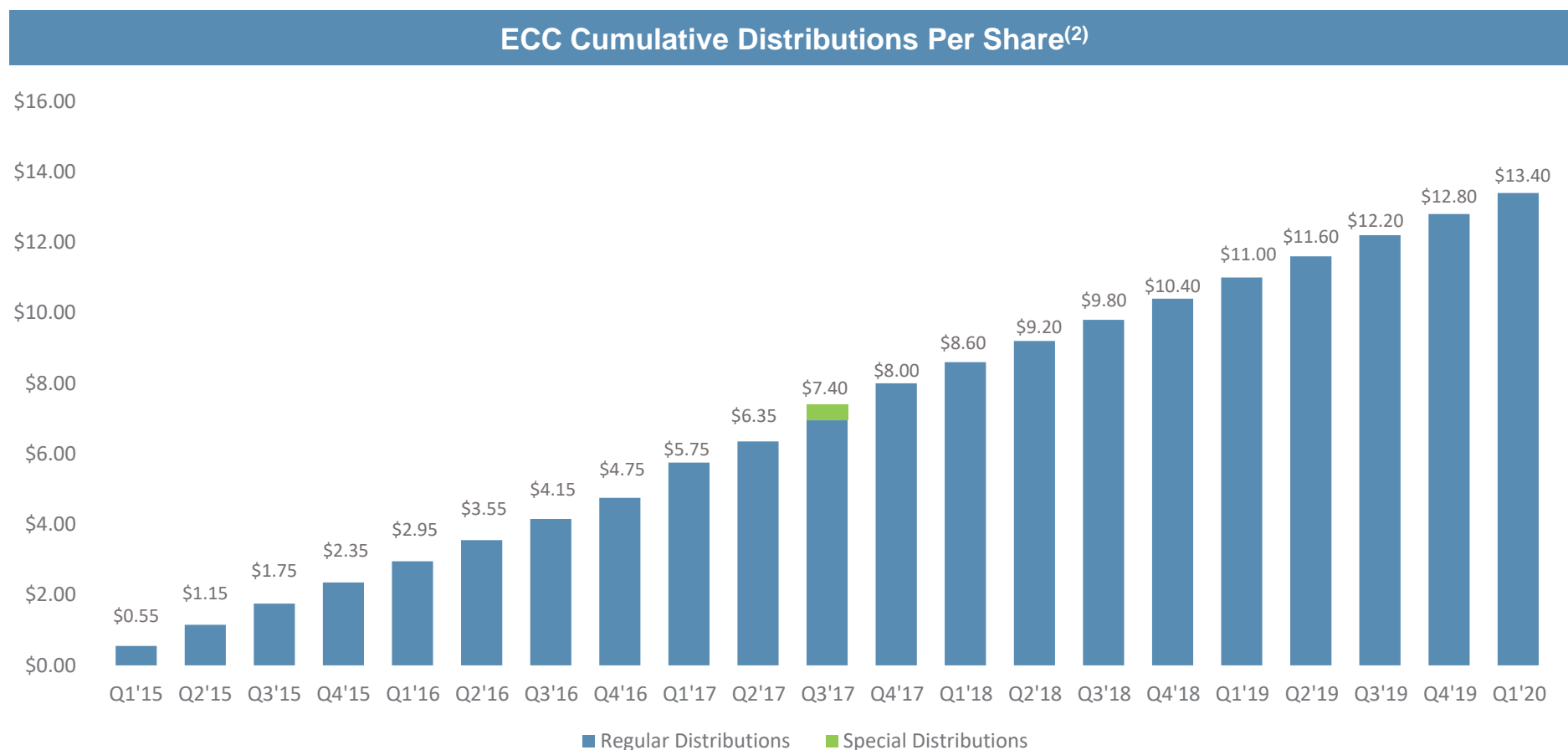

## Track Record: Total Return and Price to Book Ratio



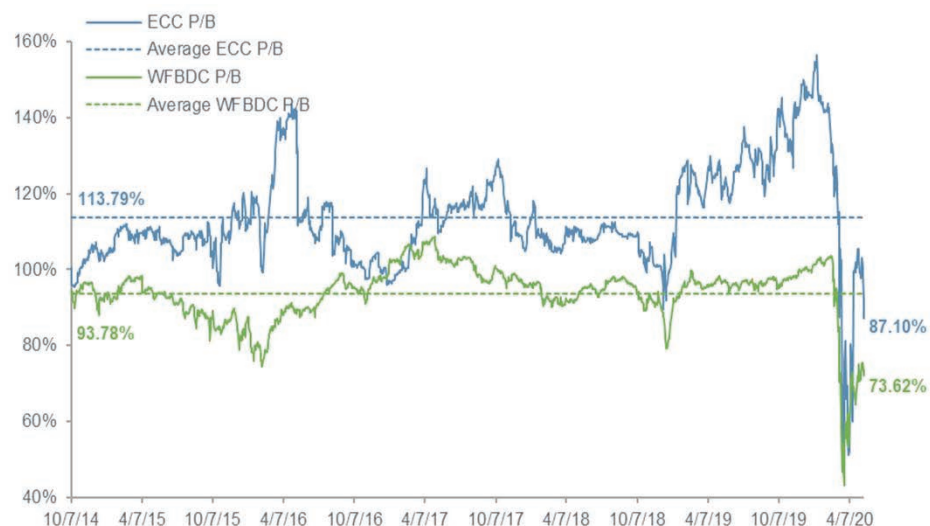
**For the period of October 7, 2014 – May 14, 2020:**

- ECC generated a total return<sup>(1)</sup> of -40.57% versus -11.67% for the Wells Fargo BDC Index<sup>(2)</sup> (annualized net total return of -8.9% for ECC versus -2.2% for the Wells Fargo BDC Index)
- ECC traded at an average premium to book value of 13.8% during a time in which the Wells Fargo BDC Index<sup>(2)</sup> has traded at an average discount of -6.2%

## Private Equity Approach to Fixed Income Investing

### Investment Strategy and Process

- Proactive sourcing of investment opportunities
- Utilization of our methodical and rigorous investment analysis and due diligence process
- Involvement at the CLO formation and structuring stage enables us to influence the key terms and conditions of the investment for significant primary market investments
- Ongoing monitoring and diligence

### Objective of the Process

- Outperformance relative to the CLO market
  - In the primary market, we seek to invest in CLO securities that have the potential to outperform other similar CLO securities issued within the respective vintage period

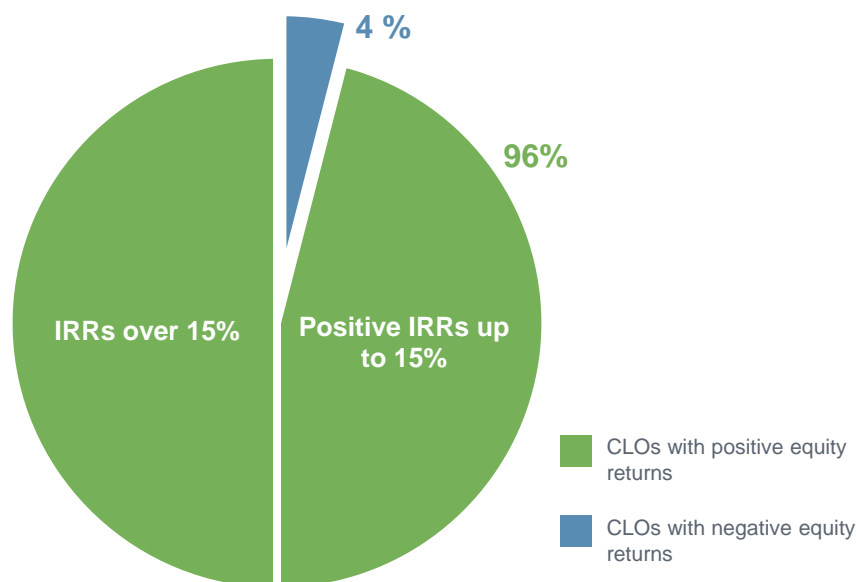

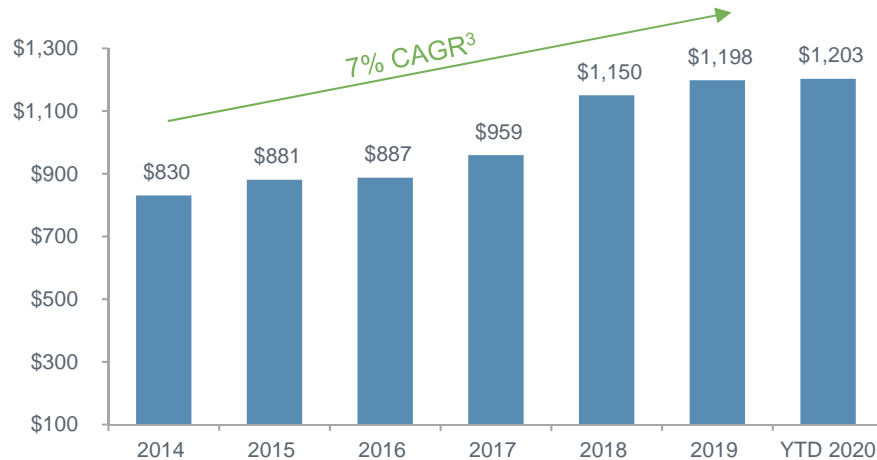

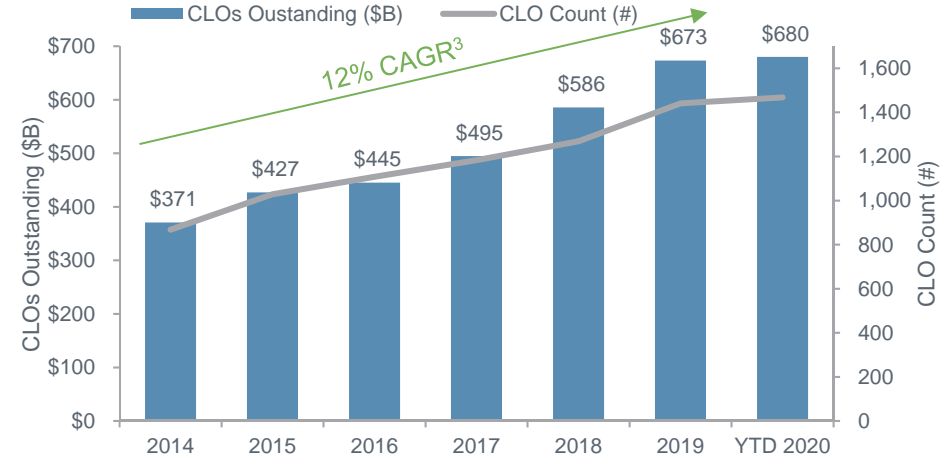


*The CLO market is the largest source of capital for the U.S. senior secured loan market*

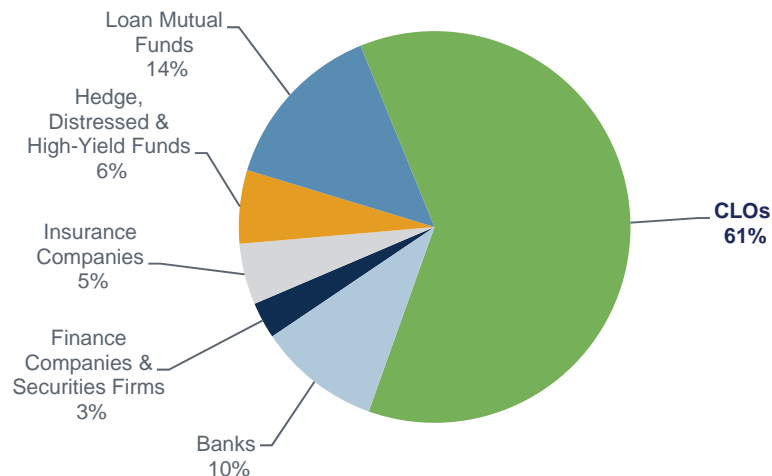
## U.S. Leveraged Loans Outstanding (\$ Billions)<sup>1</sup>



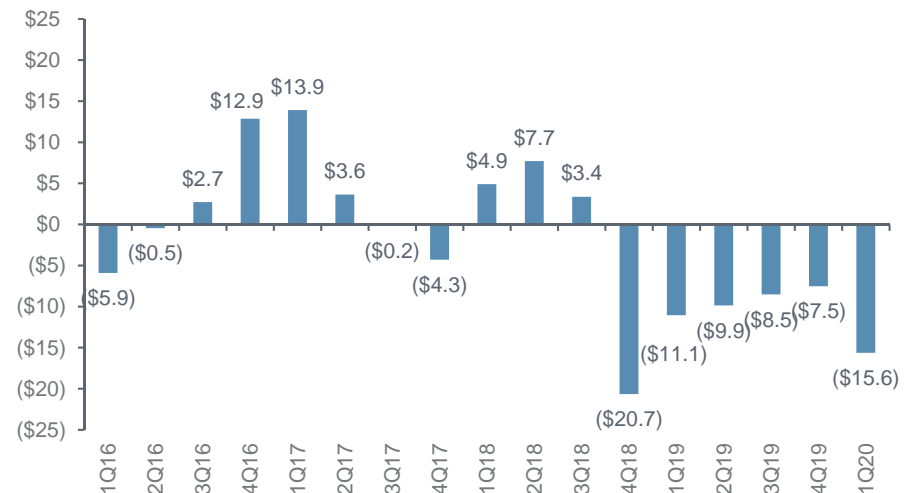
## U.S. CLO Outstanding (\$ Billions)<sup>2</sup>

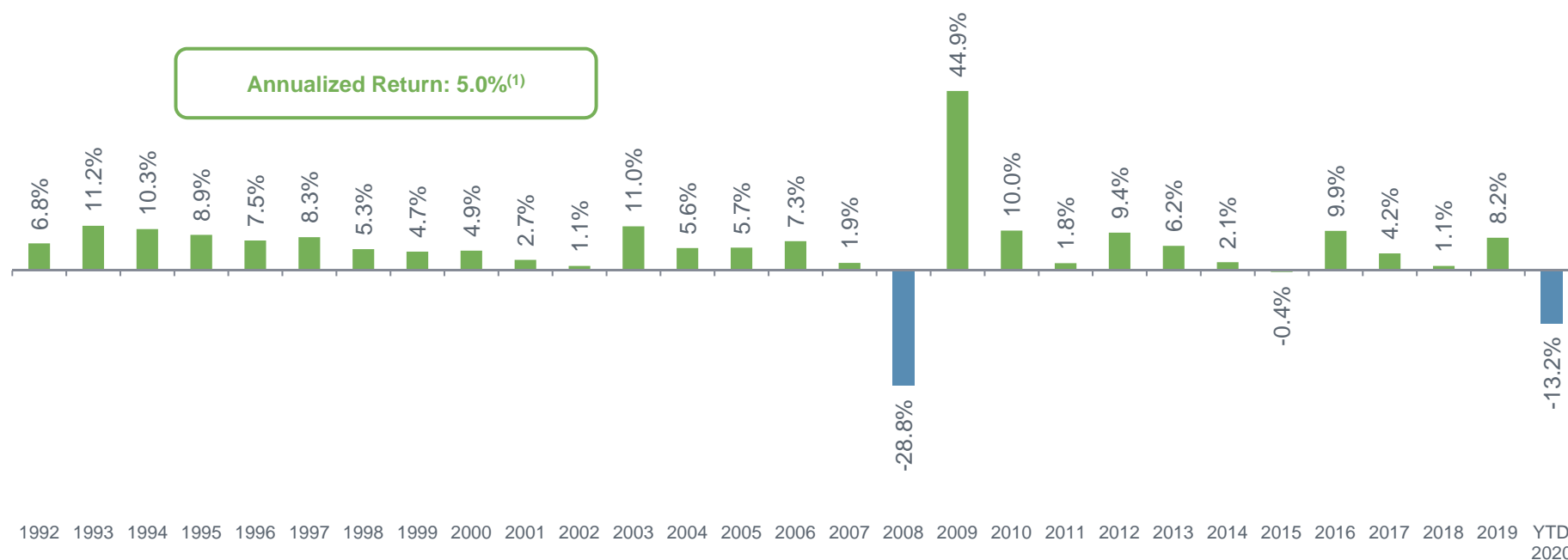

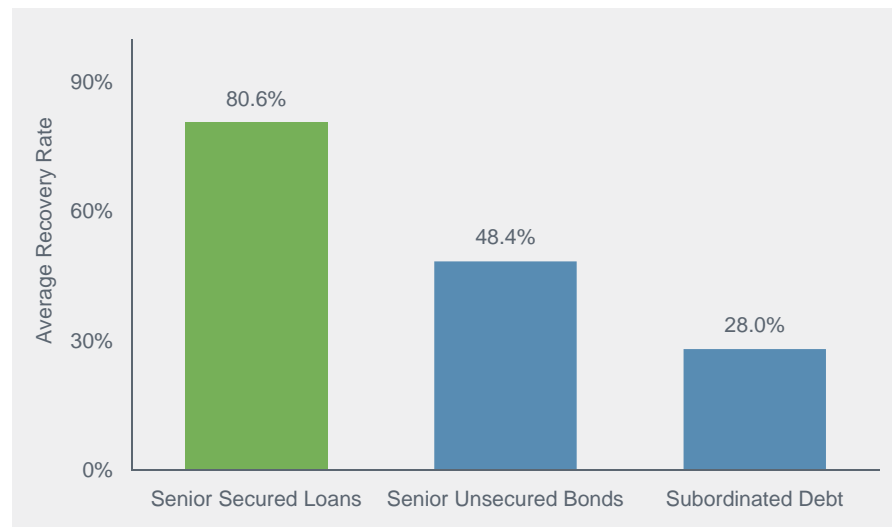
### Senior secured loans represent direct credit exposure

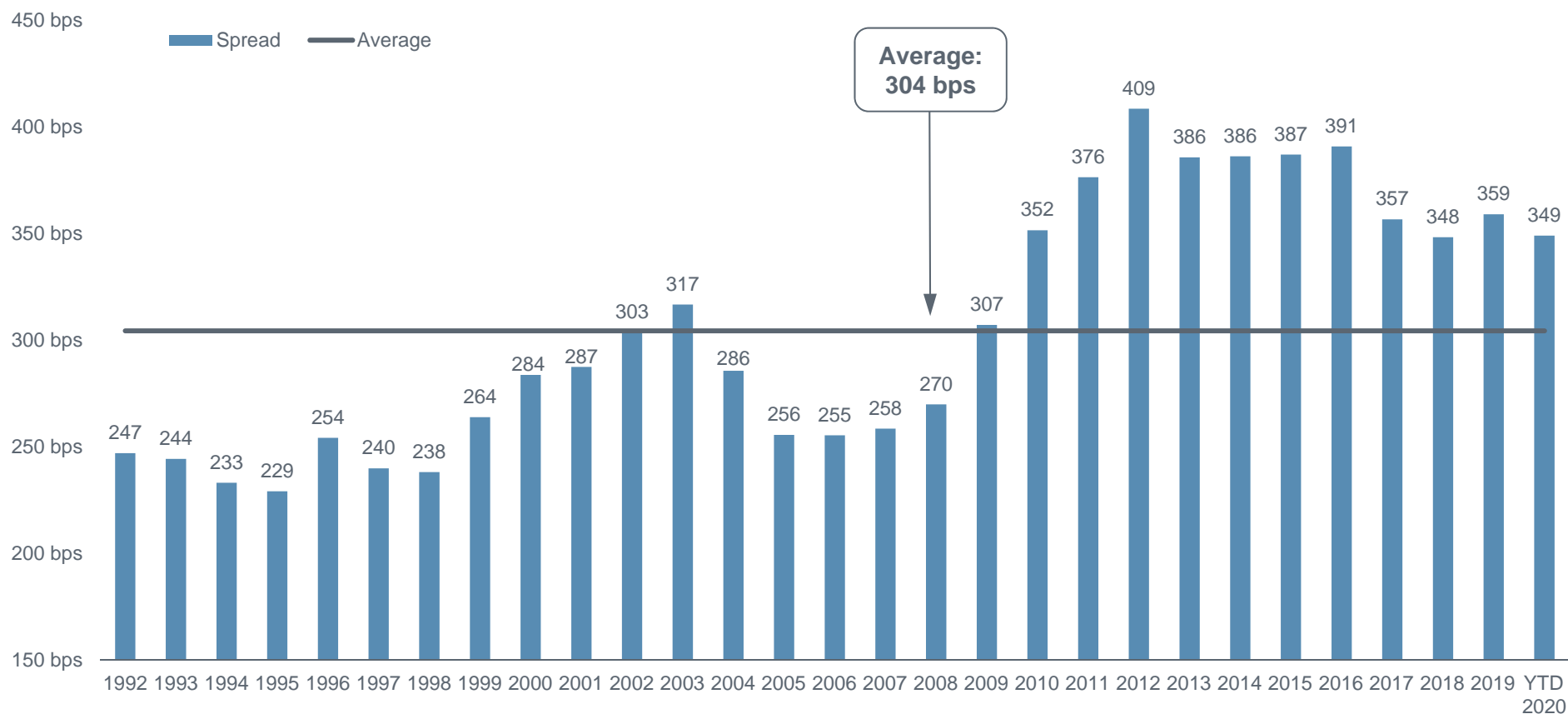

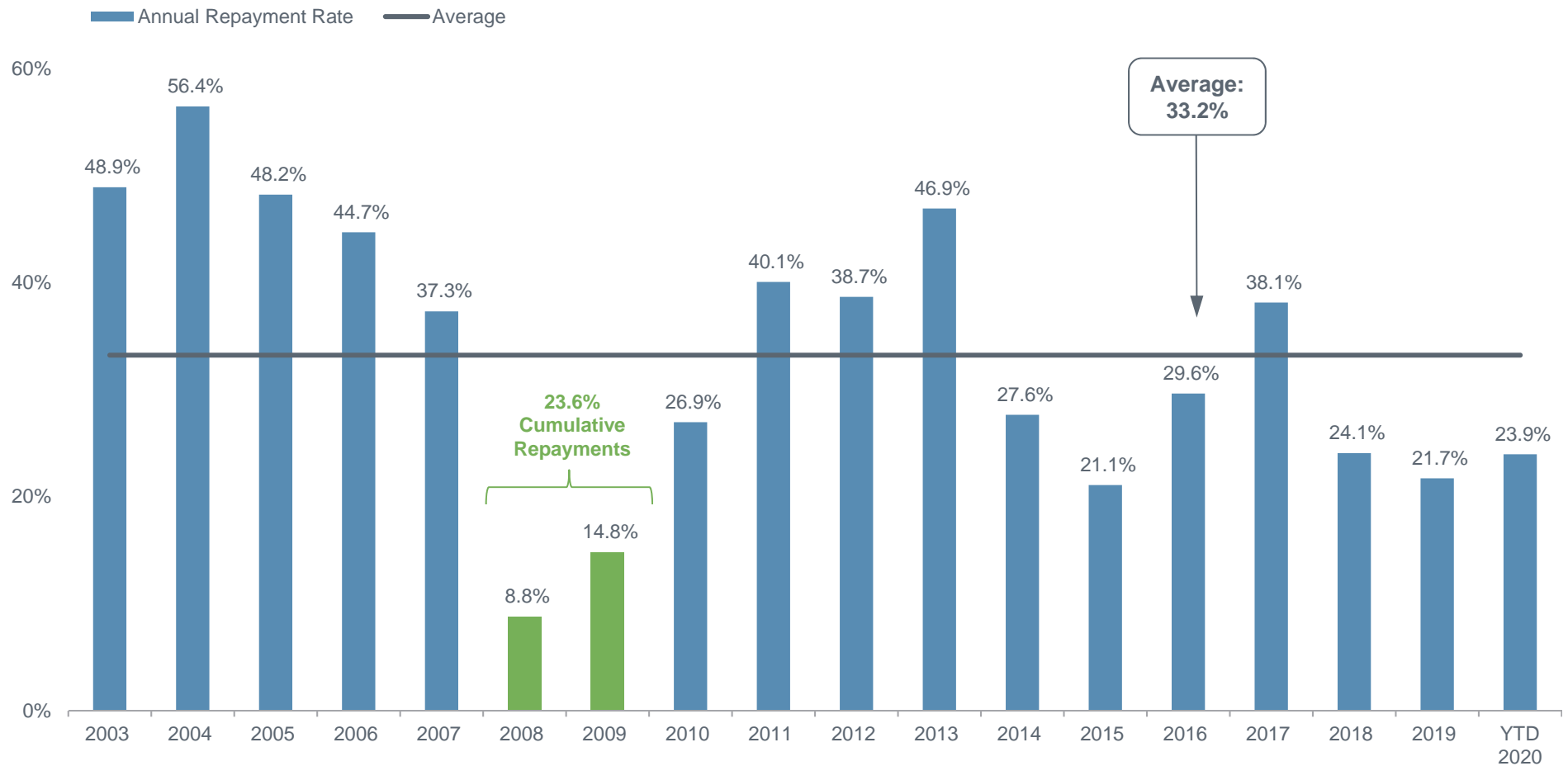

### Annual Repayment Rate



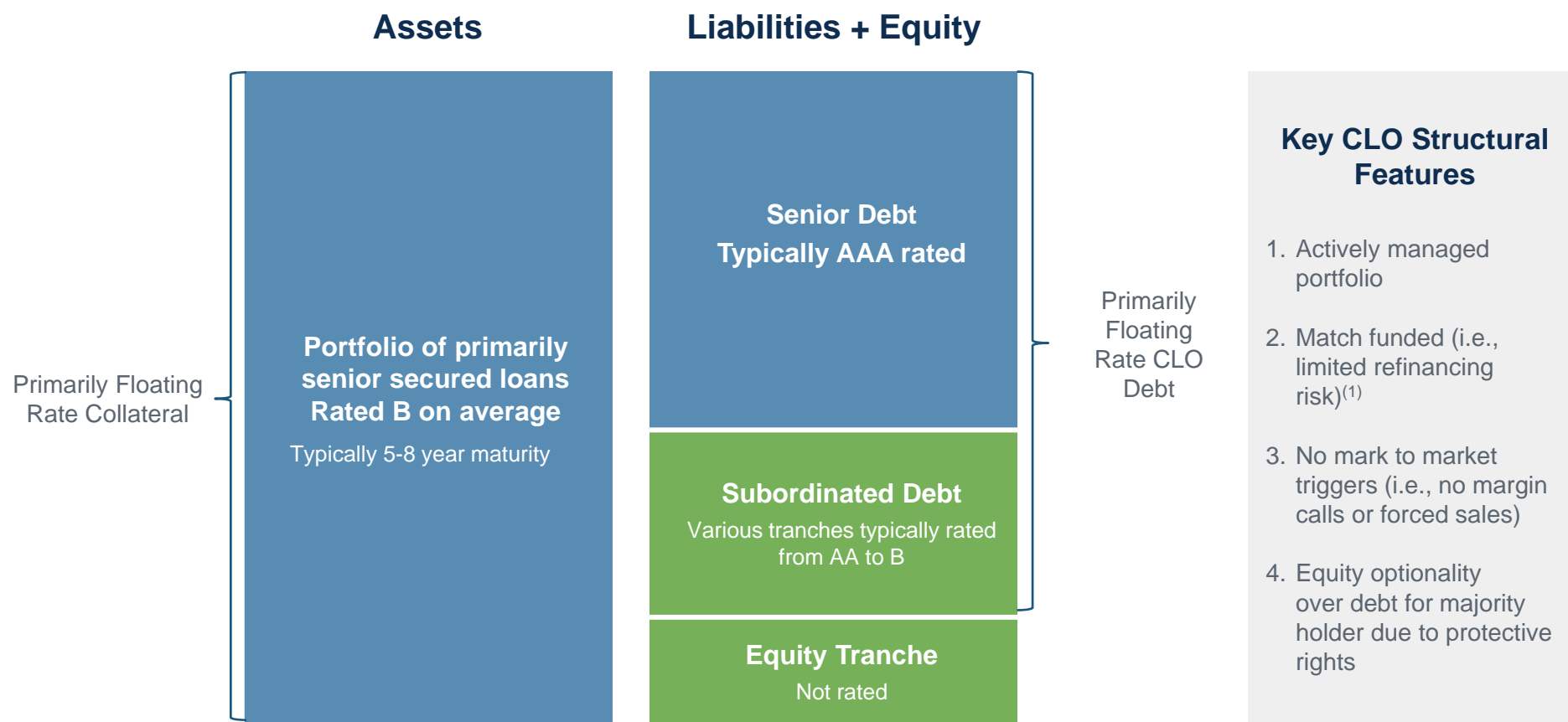

## CLOs are Securitizations of a Portfolio of Senior Secured Loans



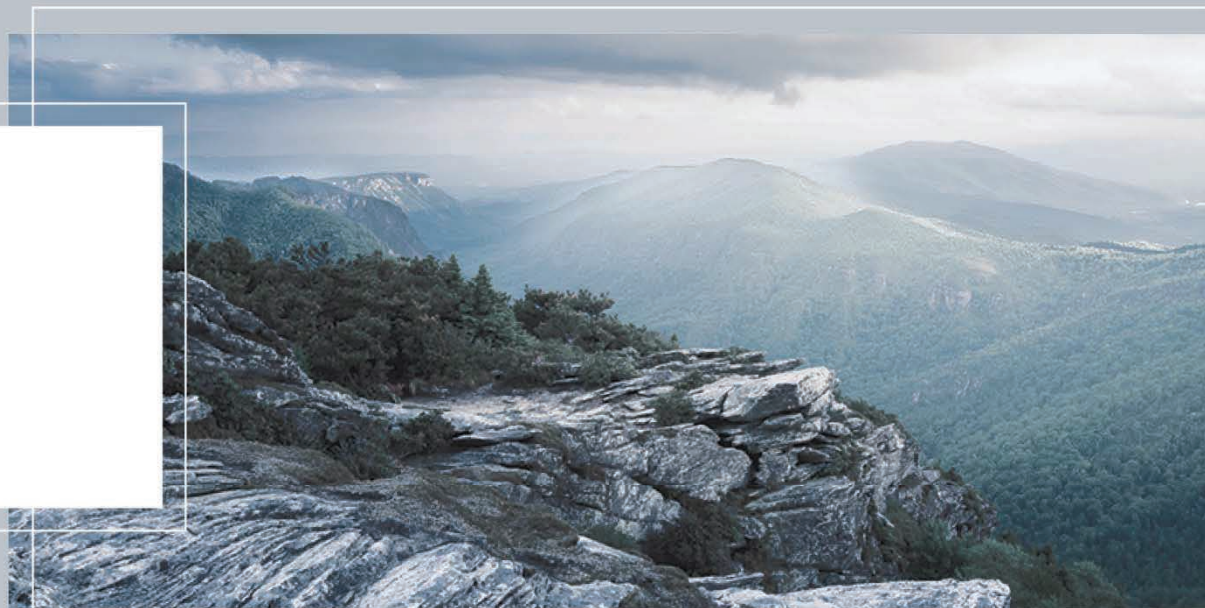

However, CLO investors do face reinvestment risk with respect to a CLO's underlying portfolio. In addition, in most CLO transactions, CLO debt investors are subject to prepayment risk in that the holders of a majority of the equity tranche can direct a call or refinancing of a CLO, which would cause the CLO's outstanding CLO debt securities to be repaid at par.

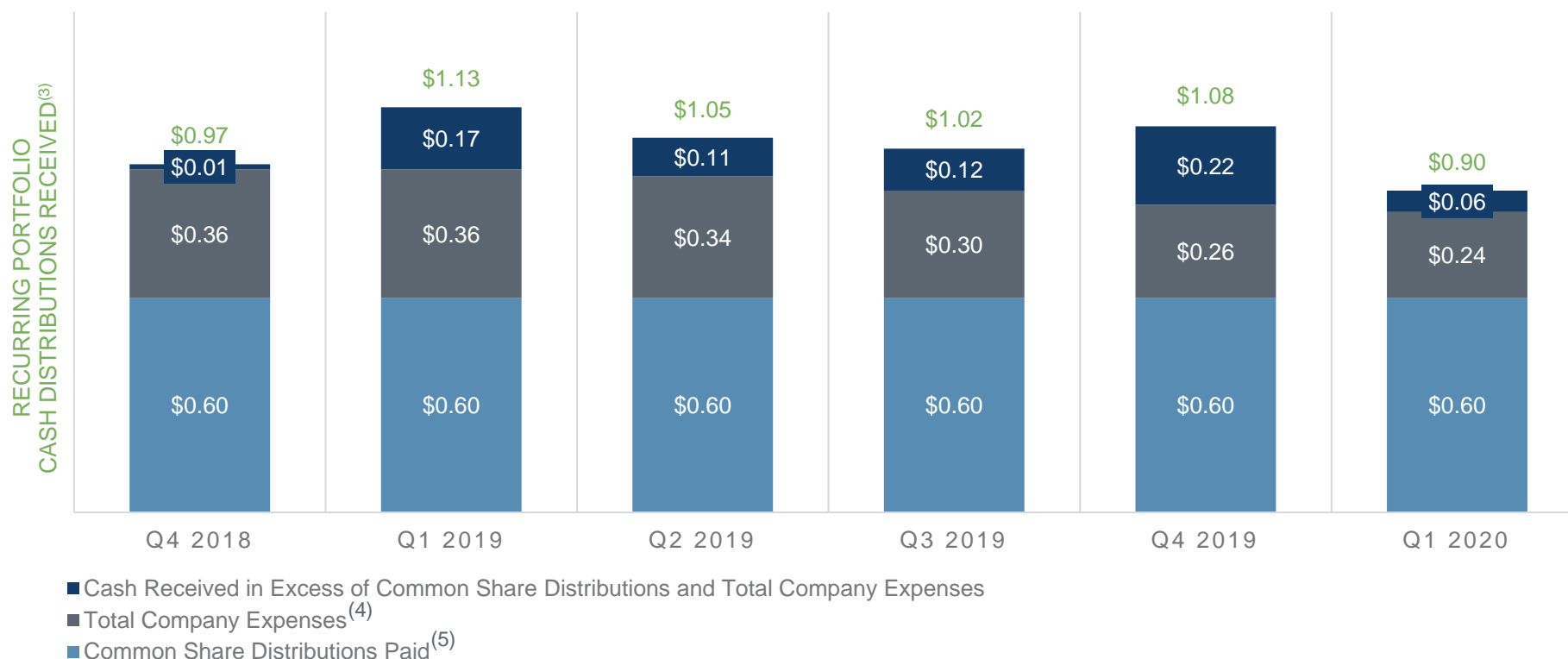

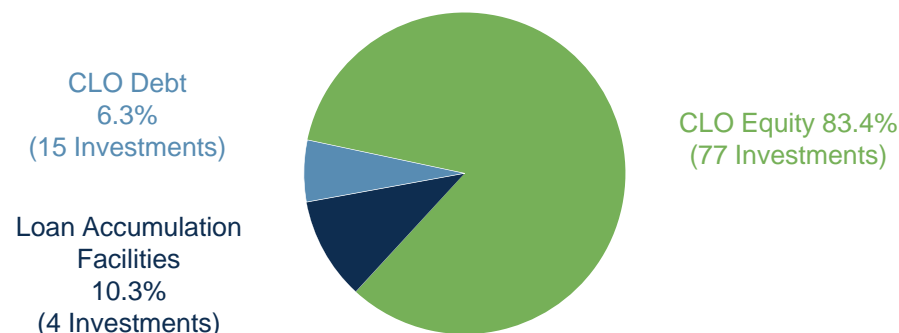

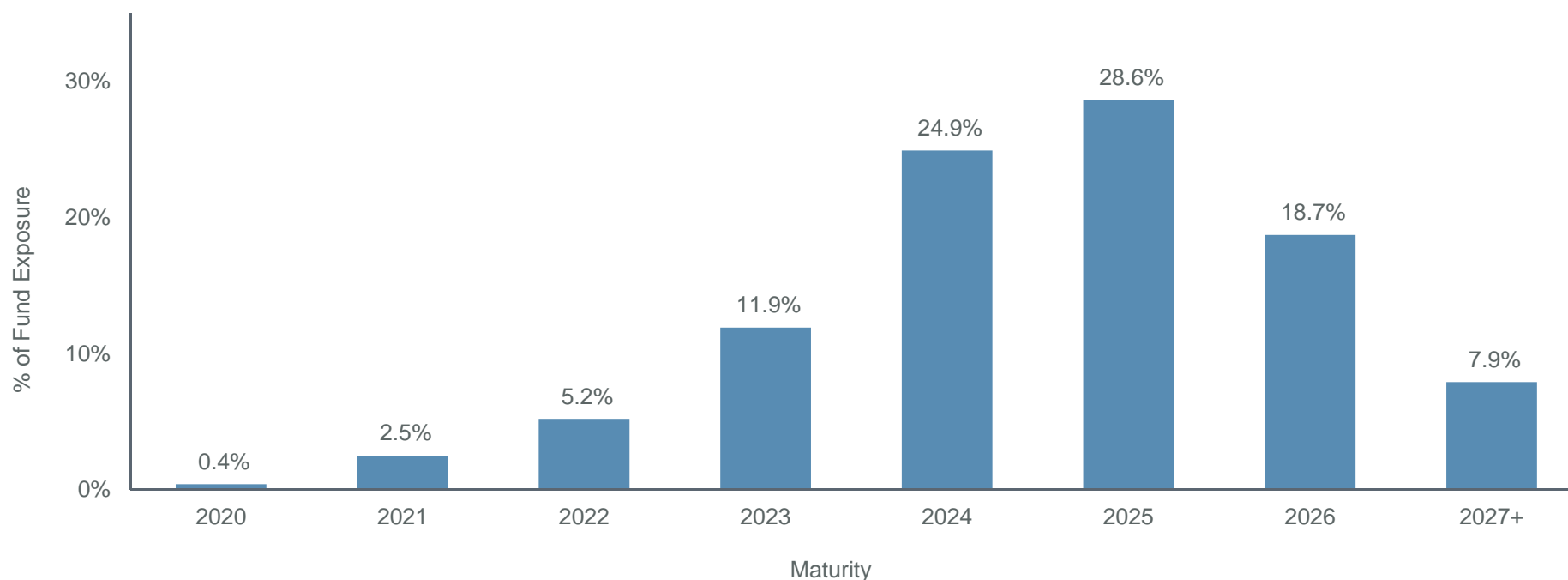

(Debt/EBITDA)<sup>1</sup>



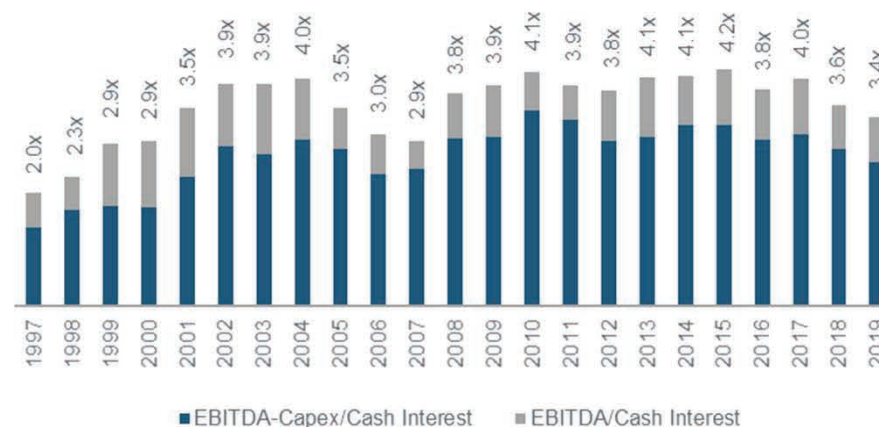
Average Interest Coverage Multiples of Outstanding Loans

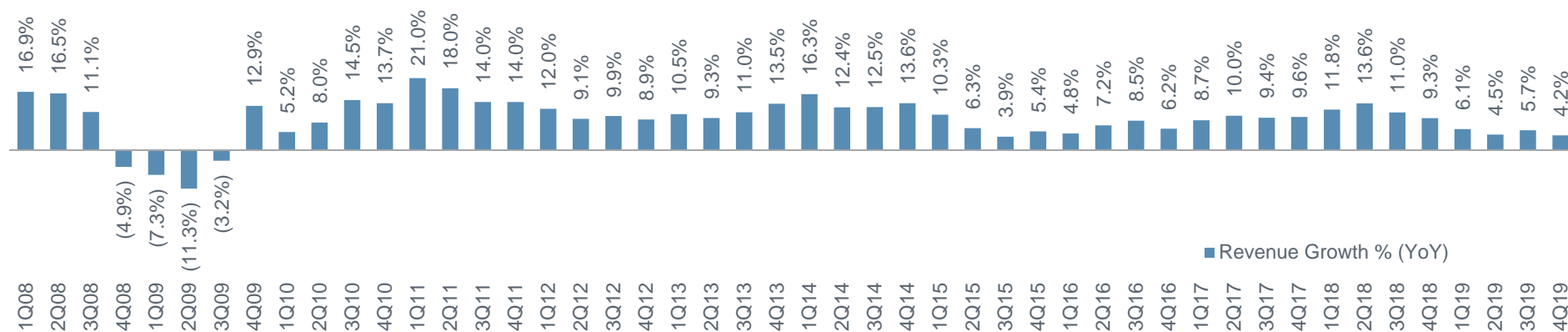

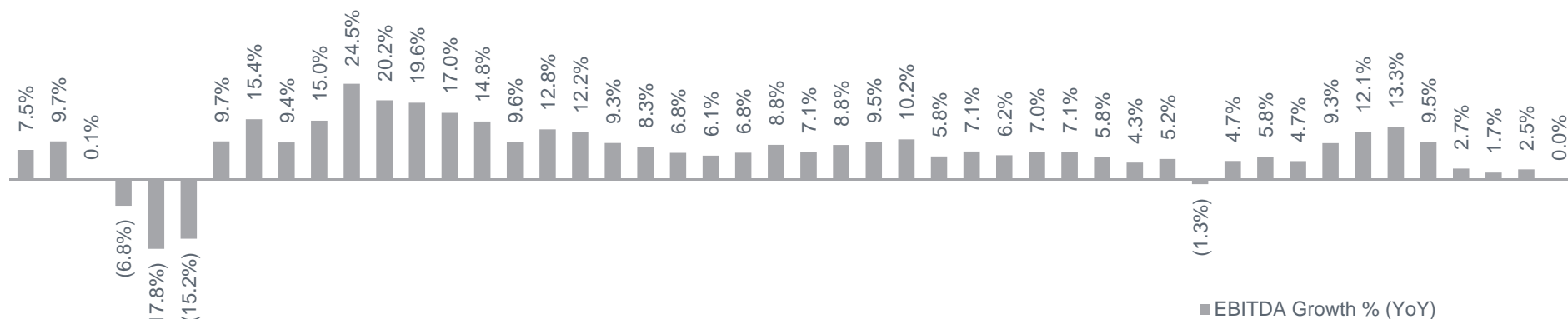

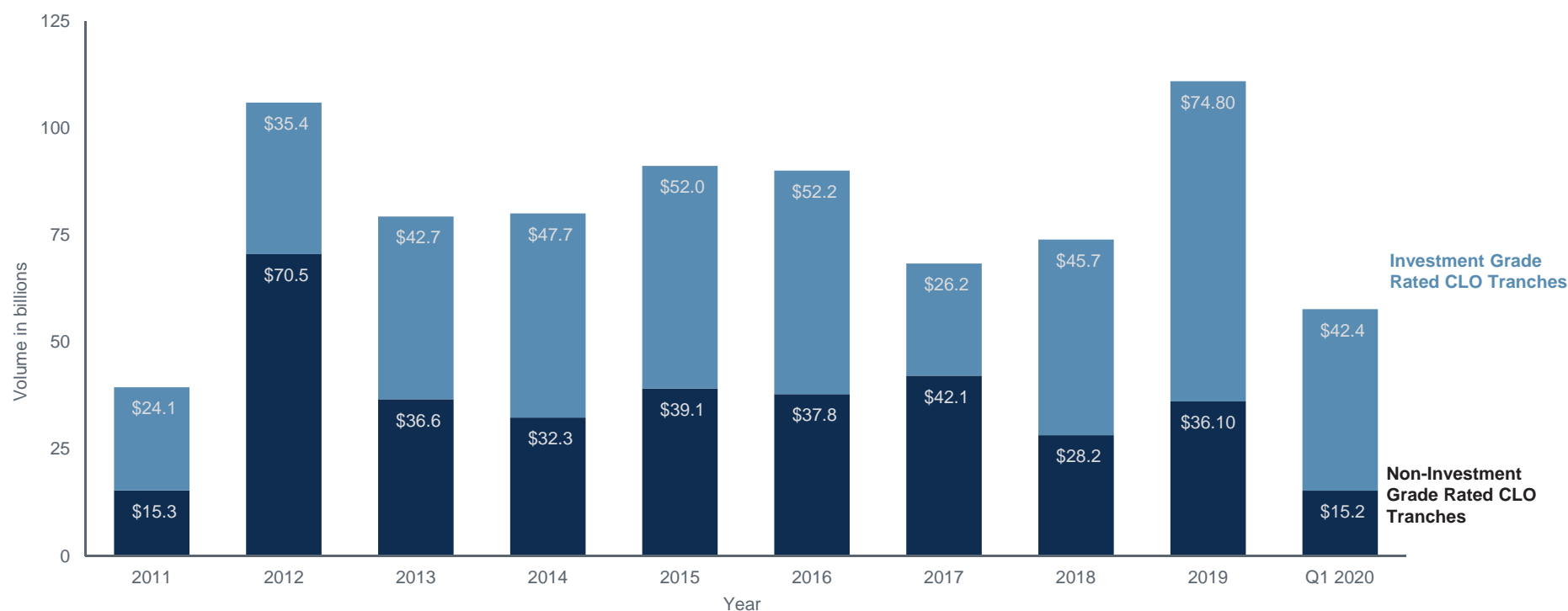

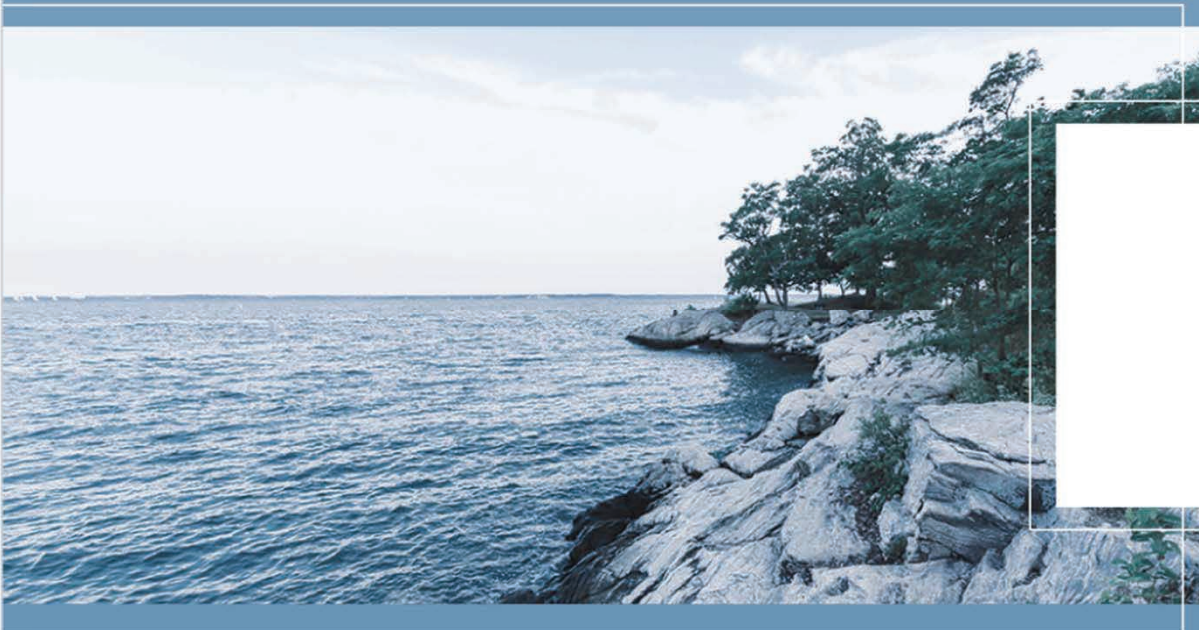
### Annual CLO Trading Volume
