1. You state that DNA Florida issued 19,999,998 shares to acquire the company. This disclosure conflicts with your disclosure in Note 1- Description of Business. Please revise for consistency.

We urge all persons who are responsible for the accuracy and adequacy of the disclosure in the filing to be certain that the filing includes the information the Securities Act of 1933 and all applicable Securities Act rules require. Since the company and its management are in possession of all facts relating to a company's disclosure, they are responsible for the accuracy and adequacy of the disclosures they have made.
