We are still not profitable and can not assure you that the future revenues generated will be sufficient to offset the costs to maintain and grow our business without additional equity funding. We will continue mitigating this uncertainty through prudent management of our costs and focus on increasing our top-line revenues and product margins.

We are in the process of restructuring our current debt terms. While the negotiations are going well we hope to complete them in the next few weeks, however, there are no guarantees we will be successful.

We may be unable to protect and enforce the intellectual property rights associated with the SOKO brand which is a key asset and a revenue driver. We have a registered trademark on the SOKO brand which we protect by monitoring and enforcing our rights should they be infringed. However, should we have to enforce our rights through litigation we will need to spend significant resources in terms of management time and also legal costs.

Because there is significant competition for talent with branding, digital marketing, supply chain, and operational capabilities, we are not certain that we will be able to always attract and retain key personnel. SOKO uses equity incentives, its social impact provenance, and other perks to attract and retain senior members of our management team. However, we note that these may not be adequate to attract, retain and motivate employees which negatively may affect our operations and financial condition.

We rely on attracting new customers and encouraging existing customers to make repeat purchases for our growth. We need to attract and appeal to these customers through cost-effective efforts including organic and paid digital marketing, strategic partnerships, and other methods of customer acquisition. If we fail to effectively acquire customers or acquire customers in a cost-ineffective manner we will have difficulty maintaining or increasing our growth rate which will affect our financial condition. We have put in place tools to track customer acquisition, satisfaction, and are always monitoring our customer base engagement to address any concerns.

The COVID-19 pandemic has impacted our business and although we are back on track, we can not predict future resurgence which may result in disruption to our workforce and supply chain including the ability to continue shipping products in a timely manner from our artisans. Our workforce is already trained on all COVID-19 prevention and we have put in place protocols to prevent the spread of the virus in our workplace. In addition, we work with multiple shipping partners to ensure that any supply chain disruptions do not have an adverse impact on our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

We have recently undergone a reorganization to lower operating expenses and get to profitability in 2022. A leaner team could feel challenged by the increased workload. Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the

Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$100,000**

Use of Proceeds: 94.5% towards marketing (social media, digital advertising, influencer campaigns), and 5.5% towards Wefunder fees.

If we raise: **\$500,000**

Use of Proceeds: 72% towards marketing (social media, digital advertising, influencer campaigns), 12.5% towards inventory, 10% hiring additional e-commerce and tech support, and 5.5% towards Wefunder fees.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

## Ownership and Capital Structure

### THE OFFERING

13. Describe the terms of the securities being offered.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

1. the total value of the Investor's investment, divided by
  1. the price of **preferred stock** issued to new Investors or
2. if the valuation for the company is more than **\$12,000,000** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time.

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

### Voting Rights

If the securities offered by the Company and those offered by the SPV have

voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

- i. the Investor or
- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
  - A. the Purchase Amount may not be amended, waived or modified in this manner,
  - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
  - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

### Management's Discussion and Analysis of Financial Condition and Results of Operations

#### Overview

We are a female-founded and led ethical jewelry brand and manufacturing platform bringing modern, handcrafted designs to the global market. We're on a mission to support artisan entrepreneurship by disrupting manufacturing in the fashion industry. Using mobile technology, we connect distributed workforces (like the artisan communities we work within Kenya) to the global market.

Our innovative supply chain technology can organize hundreds of independent artisans into a "virtual factory" with unlimited unit capacity and the ability to deliver goods within a 3 to 4 week turnaround time.

We are a rapidly growing ethical and sustainable jewelry brand sold across the world via wholesale accounts and on digital platforms.

In 5 years, we would like SOKO's solution to have an impact on Nairobi's underserved communities, primarily in Kibera, Dandora, and Rongai. We believe we have the solution for the future of manufacturing and can take our technology and manufacturing platform and apply it to other businesses and not solely Jewelry. We believe our technology in the future can turn into a SaaS model and revolutionize the manufacturing business. We aim to be the largest ethical and sustainable jewelry brand in the world. These are forward looking projections and are not guaranteed.

#### Milestones

SOKO Inc was originally founded in 2012 to create a manufacturing platform that would bring ethical and sustainable handcrafted products from Kenyan artisans to the global market. We needed to validate the platform to ensure this distributed manufacturing model would work so we created SOKO jewelry. Here are the key milestones in the development of our business:

**2012-2014** - Developed manufacturing platform

**2015** - Launched SOKO brand in department stores to validate the platform



**2016-2017** - Launched SOKO brand in specialty stores and boutiques to validate the platform

**2018** - Launched shopsoko.com

**2019** - Monetized the platform by manufacturing for other brands/retailers

**2020** - Launched dropship partnership with Nordstrom.com

**June 2021** - Launched a "digital-first" strategy and restructuring of the company. Reduced turnaround time by 50%.

By creating an innovative approach to product development, manufacturing and delivery, we have reduced inefficiencies, waste, and costs, while staying at the forefront of fashion trends. The flexibility of our manufacturing and production model caters to a single e-commerce order or brand purchasing large quantities.

Despite the challenges of 2020, we improved our supply chain efficiency, reducing our order-to-product delivery time by 50%.

Although our business did not grow in 2020 due to the pandemic, we consider it a big win that we were able to retain 95% of our 2019 revenue by focusing on digital/e-commerce channels.

SOKO is conservatively forecasted to grow by a total of 22% this year despite the challenges presented by the pandemic in 2020-2021. Our total digital revenue has grown by 86% year to date and now represents 54% (vs 41% LY) of our total business.

In May of 2021, we announced a companywide reorganization after rigorously reviewing our overhead and operating expenses. It's now imperative that we raise this capital, and will invest 70% of it to expand our digital presence through social media, PR, paid advertising, and other channels.

#### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$2,569,975 compared to the year ended December 31, 2019, when the Company had revenues of \$2,625,606. Our gross margin was 55.12% in fiscal year 2020, compared to 57.29% in 2019.

- *Assets.* As of December 31, 2020, the Company had total assets of \$2,319,376, including \$1,299,589 in cash. As of December 31, 2019, the Company had \$1,610,550 in total assets, including \$498,225 in cash.

- *Net Loss.* The Company has had net losses of \$3,113,085 and net losses of \$4,809,325 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

- *Liabilities.* The Company's liabilities totaled \$6,106,215 for the fiscal year ended December 31, 2020 and \$3,579,642 for the fiscal year ended December 31, 2019.

#### Related Party Transaction

#### Liquidity & Capital Resources

To-date, the company has been financed with \$3,286,700 in debt, \$6,309,992 in equity, and \$3,500,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

SOKO, Inc. cash in hand is \$125,000, as of Sept 2021. Over the last three months, revenues have averaged \$286,121.47/month, cost of goods sold has averaged \$123,181.99/month, and operational expenses have averaged \$291,370.63/month, for an average burn rate of \$128,431.15 per month. Our intent is to be profitable in 12 months.

Mid-year 2021 we made some significant changes and improvements:

- 1) Restructured the company by downsizing the organization by 35%
- 2) Instituted a "digital-first" strategy
- 3) Significantly reduced operating expenses

- 4) Improved out turnaround time by 50%
- 5) Launched several new dropship partnerships

Overall in 2021 the trend in wholesale has begun to rebound. We have exceeded our total company revenue forecast by 36% for the past 3 months (May, June, July 2021).

In 6 months, we expect revenues to total \$1,710,000 and expenses to be \$1,055,000. We are confident in our projections for the full year of \$3.1M but believe there is additional new revenue potential of \$350K based on several new large accounts coming on board pre-holiday. Pending their performance, our net revenue total could hit \$3.5M or 40% + growth vs. 2020.

The execution of a digital-first strategy is expected to generate revenues of \$6M by 2023. The key pillar of this growth will be focusing on our digital channels including (a) our own storefront (shopsoko.com), (b) drop-ship partnerships with online retailers such as nordstom.com, neimanmarcus.com, and madewell.com (fulfilled by SOKO), and (c) online marketplaces such as shopbop.com, revolve.com, and theiconic.com (who purchase inventory from SOKO and fulfill the orders themselves). These online channels offer predictable channel performance, direct interaction with end-consumers, and simpler warehousing and inventory management. The company will also continue focusing on delivering very strong product margins which have been historically between 65% and 85%.

Although there is no guarantee that our predictions are correct, we generally expect to see new trends in our revenue and cash flows in the coming years. Nonetheless, it may be years before investors see a return on their investment if they do at all.

With continued use of smart marketing to acquire and retain customers and prudent management of costs we expect the proceeds of this offering to enable us to achieve profitability, assuming we raise at least \$350,000. It will improve our liquidity and provide additional working capital for our company, mainly to support our digital advertising efforts which drive the demand for our product. The proceeds will be used to fulfill already existing demand through payment of artisans and procurement of production materials such as gold, brass, and others.

SOKO does not have other resources of capital at this time apart from revenue from Digital/ Ecommerce and Wholesale.
