Our operations are subject to new innovations in product design and function. Staying current with successful deployment of new technology is important to achieve and maintain profitability in this industry segment.

Existing electric utility industry regulations, and changes to regulations, may present technical, regulatory and economic barriers to the purchase and use of solar energy systems that may significantly reduce demand for our solar energy systems.

Our business currently depends on the availability of rebates, tax credits and other financial incentives. The expiration, elimination or reduction of these rebates, credits and incentives would adversely impact our business.

We rely on net metering and related policies to offer competitive pricing to our customers in some of our key markets.

We currently have high concentration and therefore currently rely heavily on one equipment procurement vendor and one financing partner. This by choice, a shift from this model could be made quickly and would not have long term implications.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. Powur, PBC is offering up to 521,376 shares of Class B Common Stock, at a price per share of \$9.59.

The campaign maximum is \$4,999,995.84 and the campaign minimum is \$500,003.42.

#### Securities issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those votings rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transfereesor assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

There are 297,445 authorized preferred shares that have yet to be designated as a specific class.

407,047 of the 5,600,000 options listed above have been exercised and are also a part of the total outstanding Class B Common share count.

The holders of the Preferred Stock have the following rights and preferences:

Voting

The holders of Preferred Stock are entitled to vote, together with the holders of Class B common stock as a single class, on all matters submitted to stockholders for a vote and have the right to vote the number of shares equal to the number of shares of Class B common stock into which each share of Preferred Stock could convert on the record date for determination of stockholders entitled to vote.

Dividends

Dividends shall be payable only when, as and if declared by the Company's Board of Directors, in preference and priority to the payment of dividends on any shares of common stock. The Company shall not declare, pay or set aside any dividends on shares of any other class or series of capital stock unless the holders of Preferred Stock then outstanding shall first receive, or simultaneously receive, a dividend on each outstanding share of Preferred Stock in an amount equal to the aggregate accrued dividends on such share of Preferred Stock which has not been previously paid. Holders of Preferred Stock are entitled to receive, in liquidation preference order, an annual cumulative dividend of a) \$0.02 per share for Series 1 Preferred Stock, b) \$0.017 per share for Series 3 Preferred Stock, c) \$0.029 per share for Series 2 Preferred Stock and d) \$0.173 per share for Series 4 Preferred Stock. The dividends shall be payable for a period of five years after the date of issuance of the respective class of Preferred Stock. The Company may at any time accelerate the payment of the accrued dividends by paying to the preferred stockholders the accrued dividends in the amount of a) \$0.10 per share for Series 1 Preferred Stock, b) \$0.085 per share for Series 3 Preferred Stock, c) \$0.145 per share for Series 2 Preferred Stock and d) \$0.0865 per share for Series 4 Preferred Stock (please note that Footnote 4 of the Company's Audited Financials should be revised to reflect that the Series 3 Preferred Stock will not automatically convert to Class B common stock upon the payment of the accrued dividends).

Liquidation

In the event of any voluntary or involuntary liquidation, dissolution or winding up of the Company or deemed liquidation event, the preferred stockholders shall be entitled to a liquidation preference, in the following order, equal to:

- a) Series 1 Preferred Stock \$0.40 per share ("Series 1 Original Issue Price") plus all accrued dividends whether or not declared
- b) Series 3 Preferred Stock: \$0.34 per share ("Series 3 Original Issue Price") plus all accrued dividends whether or not declared
- c) Series 2 Preferred Stock: \$0.58 per share ("Series 2 Original Issue Price") plus all accrued dividends whether or not declared
- d) Series 4 Preferred Stock: \$0.346 per share ("Series 4 Original Issue Price") plus all accrued dividends whether or not declared.

After the payment of all preferential amounts to preferred stockholders, the remaining assets available for distribution shall be distributed among common stockholders on a pro-rata basis.

The total liquidation preferences as of December 31, 2020 and 2019 amounted to \$2,584,179.

Conversion

Each share of Preferred Stock is convertible into Class B common stock, at the option of the holder, at any time after the date of issuance. In addition, each share of Preferred Stock will be automatically converted into shares of Class B common stock at the applicable conversion ratio then in effect upon the closing of a firm-commitment public offering resulting in at least \$25,000,000 of gross proceeds to the Company.

The conversion ratio of each series of Preferred Stock is determined by dividing the Original Issue Price of each series by the Conversion Price of each series. The Conversion Price per share is \$0.40 for Series 1 Preferred Stock, \$0.58 for Series 2 Preferred Stock, \$0.34 for Series 3 Preferred Stock and \$0.346 for Series 4 Preferred Stock, each subject to appropriate adjustment in the event of any stock dividend, stock split, combination or other similar recapitalization. Accordingly, as of December 31, 2020 and 2019, each share of each series of Preferred Stock was convertible into shares of Class B common stock on a one-for-one basis.

Common Stock:

Class A and Class B common stockholders have voting rights of one vote per share. The voting, dividend, and liquidation rights of the holders of common stock are subject to and qualified by the rights, powers, and preferences of preferred stockholders.

During the year ended December 31, 2020, the Company issued 36,200 shares of Class B common stock pursuant to exercises of stock options for proceeds of \$7,727. During the year ended December 31, 2019, the Company issued 194,697 shares of Class B common stock pursuant to exercises of stock options for proceeds of \$38,339.

As of December 31, 2020 and 2019, there were 8,500,000 shares of Class A common stock issued and outstanding. As of December 31, 2020 and 2019, there were 3,167,804 and 3,131,604 shares of Class B shares of common stock outstanding, respectively.

- 1,103% Y-O-Y Revenue Growth in 2020.

- 2021 forecast is \$206 million in revenue (not guaranteed).
- Over 4,600 active independent solar sales consultants.
- 120+ solar installers using our platform servicing 14 states.
- Our Revenue-to-capital investment ratio is 57x.

#### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$96,086,389 compared to the year ended December 31, 2019, when the Company had revenues of \$8,419,929. Our gross margin was 40.16% in fiscal year 2020, compared to 55.12% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$29,023,147, including \$18,556,007 in cash. As of December 31, 2019, the Company had \$3,749,211 in total assets, including \$2,067,911 in cash.
- *Net Income.* The Company has had net income of \$4,795,255 and net losses of \$229,515 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

To-date, the company has been financed with \$505,506 in debt and \$2,469,338 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 60 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Powur, PBC cash in hand is \$13,000,000, as of August 2021. Over the last three months, revenues have averaged \$12,665,542/month, cost of goods sold has averaged \$8,253,147/month, and operational expenses have averaged \$4,507,614/month, for an average burn rate of \$95,219 per month. Our intent is to be profitable in 1 month.

Since the date of our financials, we have seen the following changes:

- 1) Unforeseen supply chain constraints temporarily limited Powur's ability to complete installations sold in Q2. That issue has been solved, the backlog of contracts and corresponding revenue that would have been recognized in Q2 will shift to Q3 and Q4.
- 2) Margin compression in Q2 was a temporary result of operational changes that will in time result a more scalable infrastructure, faster installation throughput, and a higher margin upside.
- 3) Increase in operating expenses was the result of a planned increase in staff to catch up to the company's 2020 growth and support future growth.

expectations.

Revenue for July-December 2021 is forecasted to be \$119,862,422. Forecasted COGS for that same period is \$77,570,996, and Operating Expense at \$41,002,233, resulting in a net income before tax of \$1,289,193 for the remaining 6 months of 2021. These projections cannot be guaranteed.

For additional capital outside of this offering, Powur procured \$5M of solar panel inventory in July 2021 to take advantage of some cost savings available. That equipment will sold through by the end of September, increasing cash and cash equivalents to a projected \$18-19M by the end of Q3. With a cash generating working capital model, cash is expected to increase to \$20-21M by year end excluding capital financings.
