Paragraph 2(c) still appears to assume material facts related to the issue of whether the directors' actions complied with applicable laws and regulations and included all actions necessary to legally issue the shares. Please revise your opinion to remove paragraph 2(c), refile the legal opinion after the Corporate Approvals have been passed or provide us with an explanation as to why this assumption is necessary and appropriate.
