1. ORGANIZATION AND PURPOSE

Aptdeco I, a series of Wefunder SPV, LLC (the "Company", "we", "us", or "our") is a limited liability company organized on April 7, 2023 under the laws of Delaware.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Company's significant accounting policies applied in the preparation of the accompanying financial statements follows:

a) Basis of Accounting

Nature of Operations

d) Legal Fees
