It remains unclear from your response to prior comment 6 how you concluded you are not a shell company, as defined in Securities Act Rule 405, as you state in your response that you plan to commence operations; therefore, it appears you have not yet commenced operations. Please provide an expanded analysis of how you determined that your shareholders may rely on Rule 144 to resell securities, or revise your disclosure, as applicable to clearly reflect that you are a shell company and the impact that has upon the availability of Rule 144.
