## **Business and Anticipated Business Plan**

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Revohloo.com is a music video platform featuring a patent-pending interactive AdDefender technology. Our technology allows artists to create interactive music videos. The artist's fans get to choose from different beginnings, middles, and endings of the artist's music video. The alternative beginnings - middles - endings are created with the unused footage from the official music video. When an artist/director creates a music video, on average they shoot 75 - 90 minutes of footage. The actual music video is 3 minutes which leaves on average 72 - 87 minutes of the expensive footage unused. In post-production, it is often difficult for artists/directors/editors to choose what footage to use for the official music video. Revohloo aims to solve that problem by creating a viable new music video product for artists and labels to monetize. A Revohloo Music Video is comprised of four unique beginnings, eight unique middles, and four endings. Created with the same official content, the end result is 256 unique versions of the artist's Official Music Video. Demo <https://www.revohloo.com/Revohloo/Create/4310> We want artists and labels to get that YouTube check. From monetizing one music video on YouTube to monetizing 256 Official interactive versions. This could not only create revenue, but engagement with fans. Revohloo is an ad-supported service. This can be problematic because many people use ad-blocking technologies to skip viewing ads, resulting in lost revenue for content creators and lost opportunities for advertisers to reach their target market. A Revohloo music video with AdDefender solves this problem. Simply put, when you watch content online and you're shown an ad, there are actually two separate "file packages" that are delivered to you. Revohloo AdDefender combines both files, the ad & music video, and sends the viewer one file. This makes viewing the music video without viewing the ad impossible. Advertisers who advertise with Revohloo content can be assured that their target market

viewing that Revohloo is also viewing their ad. Advertisers can now run hyper-targeted ad campaigns based on the demographics of the artist in the Revohloo music video. Problem: There has been relatively little innovation with regard to how creators monetize their content. Most creators earn much less than they should on existing platforms if they earn anything at all. Our Solution: The merging of Revohloo with BitClout Node, creating a "Crypto Social Music Video Network" accessible via the Revohloo App & Revohloo.com How a Revohloo Bit Clout Node could potentially make money: Finding legitimate ways for artists and creators to earn revenue online is difficult. The Revohloo App aims to feature M.A.P.'s (monetized artists pages), a combination of Revohloo Ads, and BitClout Rewards. Why add BitClout: BitClout is not a company, it doesn't have a board, and there is no CEO-- it is just code that runs on nodes across the internet similar to other digital assets. This adds value for the cost of running a server.

Revohloo currently has 5 employees.

1. Risks from Pandemics We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are

highly uncertain and cannot be predicted.

2. Third parties might infringe upon our technology. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
3. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
4. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
5. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. 13. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. The Company may also end the Offering early; if the Offering reaches its target offering amount after 21-calendar days but before the deadline, the Company can end the Offering with 5 business days' notice. 14. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

15. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

18. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. ## The Offering

Revohloo, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$250,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

### 8. What is the purpose of this offering?

App Development: We plan to use an estimated \$67,325 of the funds raised to finish building our native apps. Marketing: We plan to use \$85,663 to market our platform to the world. We are planning to give away a Mercedes Benz Sprinter to 1 lucky artist who downloads the app and uploads a music video. We believe this promotion will help us reach our two hundred thousand downloads. Content Dev & Acquisition: We plan to use \$23,775 for content acquisition and creating our first Revohloo music video with a recording artist. Accounting services are estimated to cost \$12,000. We plan to use \$6,987 for office expenses. We plan to use \$30,000 for salaries. We plan to use \$12,000 for legal fees.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Revohloo, Inc. must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. Our average monthly burn rate is approximately \$1,000, with an average allocation of 75% towards salaries and wages, 15% to general and administrative, 10% to advertising and marketing. We currently have metrics around the user base. With this raise, we plan to allocate a higher percentage to application development, marketing, and content development & acquisition. We believe these activities will result in the traction we will need to court venture capital funding. We will continue to keep a tight rein on expenses in order to keep a secure runway for the duration of the time it will take to raise this round. During the year ended on December 31, 2020, we received \$20,000 in grant income. Our expenses for the year ended on December 31, 2020, amounted to \$12,759, which resulted in net income of \$7,241. Our operating expenses for the year ended on December 31, 2019, amounted to \$5,806, which resulted in a \$5,806 loss.
