The founders (Ricardo Grant, Jordan Crone) and UpTech Accelerator hold common shares in the company that retain voting rights & informational rights. The offered future equity shares will convert into common shares upon an institutional financing event.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

Ricardo has the largest share of voting rights and control of the company decisions as CEO.

In September in 2017 the company was valued \$833,000 for 6%. Crownmob has since launched and begun generating revenue. They now believe they can set a valuation cap for this SAFE agreement at a pre-money valuation of \$1.5 million with a 20% conversion discount on future shares.. The minimum and maximum target raise is \$25,000 to \$107,000 which would dilute up to 8.32% of the company's shares when converted.
