Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Finnest is creating a new age mobile banking experience specifically designed for school kids and their parents. Our platform combines an app, a secured debit card and behavior affecting components that help minors to experience the world of digital money by letting them participate in it. Where others in this market offer digital spending solutions for this customer only, we offer innovative “learning by doing” training by guiding kids as they earn, save, and responsibly spend money all while parents maintain control. Finnest is bridging the gap between parents using primarily digital money while their kids being tied to cash. We started Finnest with the true belief that early and relevant experience with handling money improves financial capability later in life. Many products try to teach financial literacy. They are all either using play money or are purely digital spending solutions for teens and miss out on one thing: a real and positive change in behavior and attitude. Finnest's platform is available in the iOS appstore while the onboarding process to open up an account is a 4 minutes process only, done entirely through the app. Finnest has a simple price structure that is an annual subscription of \$35 to the parent. In addition, the company earns interchange revenue that is based on spending activity of the users. Clemens, founder of Finnest, started working on the venture full time in September of 2016, and since then the core team has grown to 6 people with incredible experience in the finance and software industry.

Risk Factors

1. This is an early stage company. It has limited history, clients and revenues. If you are investing in Finnest, it's because you think this is a great product and team entering a fairly new market segment, and that they can continue to generate interest and increase customer base in order to succeed.
2. New competitors could enter the market and could therefore prevent the company from growing as anticipated. This can result in significantly reduced revenues and larger operating losses.
3. If the Company is unable to raise additional capital on acceptable terms, it may be unable to complete product development or commercialize its products.
4. The Company will require substantial future capital in order to acquire customers and grow operations. There can be no assurance that additional funding will be available on acceptable terms. Failure to satisfy our capital requirements will adversely affect the Company's business, financial condition and results of operations because the Company would be left without the capital required to complete product development, or establish sales and marketing capabilities.
5. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if he fails to perform in his current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
6. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. The Offering

Finnest, Inc. ("Company") is offering securities under Regulation D, through Livingston Securities, LLC ("Livingston"). Livingston is a registered broker-dealer, and member FINRA/SIPC. Livingston will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation D. Investments made under Regulation D involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$107,000 through an offering under Regulation D. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

The majority of the capital will be used to finish development of the Finnest banking platform including a fully established banking program with our banking vendor. While our development is almost entirely done in-house, there are costs we are going to incur with our vendors. Once established, a limited public launch is planned. The rest of the proceeds are general operational costs. 10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Finnest, Inc. must agree that a transfer agent, which keeps the records of all of our outstanding Common Stock, will issue digital securities in the investor's name (a paper stock certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of shares that they own in our company. These securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

11. How can an investor cancel an investment commitment?

You may cancel an investment commitment for any reason until 48 hours prior to the deadline identified in the offering by logging in to your account with Netcapital, browsing to the Investments screen, and clicking to cancel your investment commitment. Netcapital will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment. Thereafter, we may conduct additional closings until the offering deadline. We will issue shares in connection with each closing. Oversubscriptions will be allocated on a first come, first served basis. 13. Describe the terms of the securities being offered.

We are issuing Common Stock at an offering price of \$0.41 per share.

14. Do the securities offered have voting rights?

The Common Stock are being issued with voting rights. However, so that the crowdfunding community has the opportunity to act together and cast a vote as a group when a voting matter comes before the shareholders, a custodian will cast your vote for you. Please refer to the custodian agreement that you sign before your purchase is complete.

15. Are there any limitations on any voting or other rights identified above?

You are giving your voting rights to the custodian, who will vote the shares on behalf of all shareholders who purchased shares on the Netcapital crowdfunding portal.

16. How may the terms of the securities being offered be modified?

We may choose to modify the terms of the securities before the offering is completed. However, if the terms are modified, and we deem it to be a material change, we need to contact you and you will be given the opportunity to reconfirm your investment. Your reconfirmation must be completed within five business days of receipt of the notice of a material change, and if you do not reconfirm, your investment will be canceled and your money will be returned to you.

Restrictions on Transfer of the Securities Offered

The securities being offered may not be transferred by any purchaser of such securities during the one-year period beginning when the securities were issued, unless such securities are transferred:

- to the issuer;
- to an accredited investor;

The issuance of additional shares of our common stock will dilute the ownership of the crowdfunding investors. We may need to negotiate with a related party for additional capital. Financial Condition of the Issuer

Finnest is currently self funded with extremely low overhead costs. We have been operating in this mode for the past 18 months to fully develop our first product in-house. In order to launch the Finnest platform we are facing one-time set-up costs with our banking vendor. This includes due diligence, security scans and software testing. Upon launching the product we are expecting general operating costs. Once the product is launched and optimized we will need substantial capital to initiate growth. For the period January 22, 2017 (inception) to December 31, 2017, we incurred \$9,202 in expenses, which included \$5,000 for contract work and \$2,775 for legal fees. These expenses were offset by other income of \$5,250, resulting in a net loss of \$3,952. We anticipate we will begin to generate revenues in 2018.
