Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Kare Mobile is a technology company with a focus on improving access to care. The first phase of the company focuses on dentistry, with a mobile application that is designed to decrease the inefficiencies that currently exist in providing dental appointments for the uninsured and underinsured of America. Kare Mobile's software connects patients to the optimum provider for same day appointments using a variety of proprietary factors. We are revolutionizing the healthcare process. The company also has a provisional patient for an intraoral camera that we plan to develop in the second phase to integrate with the mobile application to improve diagnosis and access outcomes, especially in remote and rural areas. We plan to generate revenue by obtaining strategic partnerships with Fortune 500 insurance companies and marketing our application to their participants. We do not expect to achieve profitability in the next 18 months and intend to focus on brand marketing, customer experience, and product development. We have a mutual NDA with a large insurance company, that we plan to partner with after beta testing is completed.

Risk Factors

We are subject to income taxes as well as non-income based taxes, such as payroll, sales, use, value-added, net worth, property and goods and services taxes in the US
- 2. Health care industry is highly regulated. If we fail to comply with these regulatory requirements, or if allegations are made that we failed to comply, our operations and financial condition could be adversely affected.
- 3. Political, economic and regulatory influences are subjecting the healthcare industry to potential fundamental changes that could substantially affect our results and operations. Privacy laws and regulations could restrict the ability of our customers to obtain, use or disseminate patient information, or could require us to incur significant additional cost to re-design our products.
- 4. If the Company is unable to raise additional capital on acceptable terms, it may be unable to complete planned research and development or commercialize its products. 10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Kare Mobile Incorporated must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). For the period from May 24, 2017 (Inception) to December 31, 2017, we recorded \$0 in revenues and \$59,064 in total operating expenses. The majority of our operating expenses consisted of \$39,506 in software development costs. We believe Kare Mobile currently has 3 months of working capital and we hope to obtain additional capital from the offering through Netcapital. Kare is starting beta testing in Kentucky. In the first four days of being on the Google Play Store, there were 50 downloads and 5 usages. We anticipate that we need to fundraise \$50,000 for iOS development, as well as \$15,000 for legal counsel as we pursue strategic partnerships with Managed Care Organizations and Dental Service Organizations. We anticipate the remaining money raised will be for development of a working prototype for our teledentistry component. We do not anticipate seeing revenue until 100,000 downloads have been achieved. Some of the potential issues we foresee is first changing patient behavior. Secondly, once we change the patient behavior, we need to solicit appropriate dentist provider levels to meet the needs of the patients. We have concerns about sustaining the operation while attempting to grow organically, while ensuring that we remain compliant with all federal and state regulations. We believe that we will be able to, with the addition of a strategic partner, grow rapidly.
