Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Summary: Proctor360 is an emerging EdTech company which provides a broad range of remote exam proctoring services that encompasses both SaaS platform tools as well as full, “turn key” services for proctoring exams remotely and securely online. We believe that Proctor360 provides the most comprehensive and highly secure solution in the remote testing industry to deliver remote high stakes exams. Company Overview: CEO Ganga Bathula and CTO Kranthi Bathula formed Proctor360 with the goal of developing a more secure way to proctor exams online. They adapted the use of 360-degree webcam technology and developed a proprietary testing headset that incorporates a 360 webcam, a microphone, and earphones that a test taker can wear while taking an exam online. The remote proctor monitors video views from both the test taker’s standard webcam and a 360° view of the room from the headset along with audio from the microphone and screen capture from the test taker’s computer. This leaves virtually no way for a test taker to cheat without it being captured. In addition to monitoring by a live proctor remotely, all of the video and audio feeds can be archived on Proctor360’s servers for later review if there is ever any question about the integrity of an exam session. Proctor360 replicates the test center type environment monitoring by using 360-degree camera technology. Colleges, vocational schools, and professional certification organizations can sanction Proctor360 to proctor exams for their students, and there are multiple ways a test taker can obtain a headset in order to take an exam. In the most direct fashion, the student registers in advance for a date and time to take a sanctioned exam through the Proctor360 website, and a headset is shipped to them along with a return shipping label. Prior to the exam, the student verifies their identity and that their computer is set up properly with the headset and meets all the necessary hardware requirements. Then, at the scheduled time, the

student takes the exam through Proctor360's online platform while their exam session is monitored remotely. When the exam is finished, the student simply returns the headset using the included shipping label. This method is perfect for test candidates who would normally have to travel to a live testing center-- a process which is often constrained by available time and capacity at the testing center. Now, a student can schedule the exam for whatever date and time is most convenient for them and take the exam from anywhere they have accessed to a stable internet connection. For colleges and universities, Proctor360 can now also ship a batch of headsets directly to them that they keep in stock to check out to individual students for an exam. This makes it easier for the student to obtain the headset and also helps ensure that all students at that school will have access to them as needed. Our current plan is to produce enough headsets to distribute them to public libraries all over the country. This way, a test taker can check out a headset at their local library, take the exam in a quiet space either at the library or at home, and simply return the headset to the library when their exam is finished. Proctor360 also offers other forms of remote proctoring as well. In addition to our 360° Total View service described above, we also offer standard "single cam" remote proctoring using the test takers own webcam. While less secure, we offer this remote proctoring option as well which may be most suitable for less critical tests. With both Total View and Single Cam proctoring, we offer AI-assisted proctoring and "Auto Proctoring" (which is completely monitored by AI rather than a human proctor). Our goal in offering these less secure methods is to have a wide array of options that meet either the financial or security requirements of our customers. With live testing centers straining capacity before Covid and many testing centers having reduced capacity during the pandemic, Proctor360 leveraged its own remote proctoring server software to make it available as an "Institutional SaaS" proctoring service. If a school or testing center has their own proctoring staff and they simply wish to proctor their students' exams on their own remotely, we can train & certify their proctors to use our software. This option is fairly unique in the remote proctoring industry. It allows an entire university or private testing center to immediately begin offering secure remote testing to their students without the burden of developing their own technology or systems, and that's a valuable benefit for these institutions. Notes on Patent: A full patent application is on file with the USPTO by owners Gangadhar Bathula and Kranthidhar Bathula. The founders plan to transfer it to Proctor360 Inc. once awarded. Competitors and Industry: There are many companies on the market that offer live and automated proctoring services and, as such, is highly fragmented. This lowers the barrier to entry for new players like Proctor360 who offer innovative and unique products. None of our competitors have the necessary security to protect the test and test content. Most of these systems are with single front-view monitoring systems. They are focused on lower security level exams that don't require a high degree of security and only provide surveillance through a single front facing laptop camera. Higher security exams require a full 360-degree view to prevent any cheating; this is a level of surveillance that other competitors like Proctou, Examity, Proctorio, and Proctorfree are unable to provide and is what sets Proctor360 apart from competitors. Current Stage: Production of Version 1.0 of our headsets has been completed and they are exceeding our expectations in the field. In addition to the production of the headsets, we also completed the development of our Total View Remote Proctoring software that allows our proctors to monitor exams with this specialized hardware. We currently have multiple schools using our headsets for critical exams, and we are continually providing demos to new prospective customers. We have validated the need for this service as we're seeing more demand than we can currently meet with our existing inventory of headsets. That means we will need to start a new, larger production run, and we are actively working on Version 2.0 in preparation for this need. Our Institutional SaaS service allowed us to acquire multiple customers during the pandemic, and our platform has now been used to proctor thousands of exam sessions for multiple colleges and organizations. We even offer a version of this service for ECI regulated industries such as nuclear energy where federal regulations require stringent control of access to sensitive data.

Proctor360 currently has 5 employees.

The extent to which the coronavirus impacts our operations will depend on future developments, which are highly uncertain and cannot be predicted with confidence, including the duration of the outbreak, new information which may emerge concerning the severity of the coronavirus and the emergence of variants, among others. In particular, the spread and treatment of the coronavirus globally could adversely impact our operations, and could have an adverse impact on our business and our financial results.
2. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
3. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if he fails to perform in his current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.

The Offering

Proctor360 Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$2,000,001 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. 10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Proctor360 Inc. must agree that a transfer agent, which keeps records of our outstanding Class B common stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. Financial Condition of the Issuer

Proctor360 Inc. is a new company that is not yet profitable. Our average monthly burn rate is approximately \$5,000. Net revenue for the year ended December 31, 2020, totaled \$52,667, as compared to net revenue of \$1 for the year ended December 31, 2019. Gross profit for the year ended December 31, 2020, totaled \$28,931, as compared to gross profit of \$1 for the year ended December 31, 2019. Our operating expenses for the year ended on December 31, 2020, amounted to \$62,034, which resulted in a \$33,103 net loss. Our operating expenses for the year ended on December 31, 2019, amounted to \$67,802, which resulted in a \$67,801 net loss. With the funds raised from Regulation Crowdfunding offering in 2019, the company has completed the manufacture of an initial production run of its proprietary 360-degree testing headsets and also expanded its proctoring software into a SaaS product for its customers. The company began acquiring customers and generating revenue in 2020 and has invested in continued product development and scaling operations, generating net losses as a result. In the year ended December 31, 2020, we were able to generate \$52,667 in revenue and incurred \$23,736 in cost of goods sold, which resulted in a 54.9% gross margin. With this raise, we plan to allocate a higher percentage of funds to generally expand the current operations and product development with particular respect to hardware production, software feature expansion, and marketing/sales activities. As the company is already generating revenue, the goal with this Offering is to raise the funds necessary to accelerate its current growth and achieve profitability. Based on that valuation and in consideration of the traction the company has developed including revenue growth year over year since its last offering, the price per share for this offering is \$3.00.
