CF Temporary Rule 201(z)(2), which provides temporary relief from certain financial information requirements by allowing issuers to omit the financial statements required by Rule 201(t) in the initial Form C filed with the Commission. Possibility for copyright infringement allegations; to this end, we've indemnified Univoice for any such allegations, in our direct licensing agreements with music content owners.

Music owners threatening to take down their content from our platform, if we don't increase their % revenue / royalty share (upon expiration of our 3-year licensing agreement); to this end, we're diversifying our music catalogue between many different content owners, such that takedowns from a few owners would have marginal impact.

Risk of technological infeasibility - we're breaking new grounds with AI/ML-based development undertakings; in the event that we are unsuccessful in building in-house tools for streamlined operations and increased product precision, we will be forced to rely on 3rd party tools; in addition to inefficiencies this may pose, this approach may become cost-prohibitive, as we scale our user base.

While the effects of COVID-19 have resulted in a general upward trend for the gaming industry, the pandemic may adversely influence buying behaviors. This could mean targets and growth milestones are not met.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Alvon Dampier is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Univoice Corporation is offering up to 568,182 shares of Series Seed Preferred Stock, at a price per share of \$0.44.

Investors in the first \$25,000.36 will also receive:

- (i) lifetime free access to the product
- (ii) opportunity to participate in 60-minute language exchange session with Sami Halabi, Founder | CEO at Univoice.

The campaign maximum is \$250,000.08 and the campaign minimum is \$50,000.28.

Redemption: The Corporation shall have the right to redeem the Series Seed Preferred Stock at a price of \$0.66 during the first six months after the initial issuance of the Series Seed Preferred Stock and at a price of \$0.88 thereafter until the expiration of the 18th month following the issuance of the Series Seed Preferred Stock. Thereafter, the Series Seed Preferred Stock will not be redeemable.

Financial Information: Purchasers who have invested at least \$20,000 ("Major Investors") will receive standard information and inspection rights.

Participation Right: Major Investors will have the right to participate on a pro rata basis in subsequent issuances of equity securities.

These changes could result in further limitations on the voting rights the investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. 

Runway & Short/Mid Term Expenses

Univoice Corporation cash in hand is \$30,000, as of March 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$35,000/month, for an average burn rate of \$35,000 per month. Our intent is to be profitable in 18 months.

To cover short term operations, we can cut over half of our expenses by limiting product development.

Since the date of our financials, we believe have made significant progress on our product (in the testing environment, not yet live to the public). However, while the effects of COVID-19 have resulted in a general upward trend for the gaming industry, the pandemic may adversely influence buying behaviors. This could mean targets and growth milestones are not met.

We released the 1st official version of our product in February 2021, and plan to go to market with our 2.0 product in August 2021. We expect needing \$50,000 in order to make that happen. Six months after launching, we hope to generate \$275,000 in revenues & \$700,000 in expenses, over the 6 month term. We expect to need a total of \$8.15M in capital to eventually reach a break-even point. These projections cannot be guaranteed.

For additional capital, we have one \$100,000 line of credit, against which we have an outstanding balance of \$20,692. We have another \$150,000 line of credit, against which we have an outstanding balance of \$98,757. Hence, we have the remaining \$130,551 available for use.

XX Team (acting through the Lead Investor) may further benefit both the Company and Investors by providing consulting services to the Company that are intended to maximize both the value of the Company's business and also the value of its securities.
