On the ground journalism may pose physical risks as well as legal risks for covering certain individuals and topics

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. A community-owned, decentralized news network

Media has become corrupted by sensationalism and polarization. The purely surveillance, ad-driven model is dying and now readers are directly supporting creators they love. We want to facilitate civil discourse and media in a way that gets real information into the minds of our audience.

We create news showing both sides of the argument. Our mission is to fuel a paradigm shift in civil discourse with fact-based news and analysis, diversity of thought and groundbreaking media and entertainment. We aim to be a community-owned, independent, decentralized newsroom.

We would like to be cash-flow positive and totally self-sustainable. Ideally we will launch satellite newsrooms globally and have millions of subscribers.

Milestones

Subverse Inc. was incorporated in the State of Connecticut in June 2019.

Since then, we have:

- 140K Subscribers on YouTube
- Track record of independent journalism

Historical Results of Operations

Our company was organized in June 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$921 compared to the year ended December 31, 2020, when the Company had revenues of \$20,979. Our gross margin was 0% in fiscal year 2021, compared to % 0 in 2020.

- *Assets.* As of December 31, 2021, the Company had total assets of \$143,016, including \$86,176 in cash. As of December 31, 2020, the Company had \$222,863 in total assets, including \$158,943 in cash.

- *Net Loss.* The Company has had net losses of \$63,286 and net losses of \$793,780 for the fiscal years ended December 31, 2021 and December 31, 2020, respectively.

- *Liabilities.* The Company's liabilities totaled \$0 for the fiscal year ended December 31, 2021 and \$16,561 for the fiscal year ended December 31, 2020.

Liquidity & Capital Resources

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Subverse Inc. cash in hand is \$158,943, as of December 2020. Over the last three months, revenues have averaged \$5,200/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$202,000/month, for an average burn rate of \$196,800 per month. Our intent is to be profitable in 12 months.

YouTube advertising revenue dropped due to changes with YouTube algorithms and advertisers. Expenses decreased after we left our office facility and started working remotely.

Revenue and expenses will increase as we will be focusing on commissions and syndication of content to TV broadcasters and streaming services.

Yes, private backing in the form of principals who may or may not inject financing into the company as needed. We do not, however, anticipate that this will be needed.

All projections in the above narrative are forward-looking and not guaranteed.
