Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

We are a component manufacturer for wheelchairs. We manufacture and sell components that are used to build wheelchairs. We do not manufacture or sell any medical devices and have no requirements to register with the FDA. We may be viewed as producing the "nuts and bolts" required to build a wheelchair. In addition, we also sell recreational electric vehicles. We are in talks with the nation's biggest wheelchair companies and distributors to add our components to their order forms and catalogs, respectively. This is essentially a business-to-business channel, which decreases our customer-acquisition-cost. Our strategy is to manufacture the lightest components in the world. Wheelchair users care about this more than anything, and this can be viewed as a winner-take-all market. This is evident by the market-share of companies manufacturing the lightest wheelchair chassis. Typically, these components are sold at 75% gross margin.

Ramp USA, Inc. currently has 3 employees.

Risk Factors

7. Material factors that make an investment in TriniCorp, Inc. speculative or risky:

1. We face the standard consumer hardware risks that are faced by other companies, such as product defects, recalls, and user liability.
2. If the Company is unable to raise additional capital on acceptable terms, it may be unable to maintain sufficient growth or commercialize its products. The Company may require substantial future capital in order to continue to conduct the research, product development, and marketing required to scale the business. There can be no assurance that additional funding will be available on acceptable terms. Failure to satisfy our capital requirements may adversely affect the Company's business, financial condition, and results of operations because the Company would be left without the capital required to complete product development or establish sales and marketing capabilities.
3. Because the Company has a history of operating losses, and expects to generate operating losses for the foreseeable future, it may not achieve profitability for some time, if at all. The Company is in an early stage of development and, therefore, has a limited history of operations.
4. The Company is faced with all of the risks associated with a company in the early stage of development. In addition, the Company's business is subject to numerous risks associated with a new company engaged in work building hardware products for personal transportation. Such risks include, among other things, competition from well-established and well-capitalized companies and unanticipated development difficulties and risks associated with the need for regulatory approval. Because the Company is focused on product development, the Company has not generated significant product revenues to date. The Company has incurred losses each year of its operations and expects to continue to incur losses for the foreseeable future.
5. The process of developing the Company's products requires significant research and development which is costly and does not result in revenues or profits. There can be no assurance that the Company will ever generate sufficient commercial sales or achieve profitability. Should this be the case, investors could lose their entire investment.
6. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
7. The Company does not anticipate paying any cash dividends for the foreseeable future. The Company currently intends to retain future earnings, if any, for the foreseeable future, to repay debt and to support its operations.
8. Our future growth depends on our ability to develop and retain customers. Our future growth depends to a large extent on our ability to effectively anticipate and adapt to customer requirements and offer services that meet customer demands. If we are unable to attract customers and/or retain customers, our business, results of operations and financial condition may be materially adversely affected.
9. Intense competition in the markets in which we compete could prevent us from generating or

sustaining revenue growth and generating or maintaining profitability.

10. *The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.*

11. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. 12. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. 13. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

14. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. Other security holders of the Company may have such rights. Regulation CF requires only the provision of an annual report on Form C and no additional information – there are numerous methods by which the Company can terminate annual report obligations, resulting in no information rights, contractual, statutory or otherwise, owed to Investors. This lack of information could put Investors at a disadvantage in general and with respect to other security holders.

16. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

17. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. Failure to obtain such financing on favorable terms could dilute or otherwise severely impair the value of the investor's Company securities.

18. *There is no present market for the Securities and we have arbitrarily set the price.*

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

19. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Each prospective Investor is encouraged to carefully analyze

the risks and merits of an investment in the Securities and should take into consideration when making such analysis, among other, the Risk Factors discussed above.

The Offering

TriniCorp, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$106,460 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

These funds are planned to be used for operating costs while we raise our first institutional equity round, that we hope to close in six to nine months. These costs include regulatory application costs, office space overhead, materials, and machinery. We anticipate we will be able to produce a first-run production model at low volume, at 75% gross margin, before we close our next financing round.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and TriniCorp, Inc. must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

11. How can an investor cancel an investment commitment?

You may cancel an investment commitment for any reason until 48 hours prior to the deadline identified in the offering by logging in to your account with Netcapital, browsing to the Investments screen, and clicking to cancel your investment commitment. Netcapital will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment. If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be cancelled and the committed funds will be returned.

12. Can the Company perform multiple closings or rolling closings for the offering?

If we reach the target offering amount prior to the offering deadline, we may conduct the first of multiple closings of the offering early, if we provide notice about the new offering deadline at least five business days prior (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Thereafter, we may conduct additional closings until the offering deadline. We will issue Securities in connection with each closing. Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

13. Describe the terms of the securities being offered.

We are issuing Securities at an offering price of \$0.83 per share.

14. Do the securities offered have voting rights?

The Securities are being issued with voting rights. However, so that the crowdfunding community has the opportunity to act together and cast a vote as a group when a voting matter arises, a custodian will cast your vote for you. Please refer to the custodian agreement that you sign before your purchase is complete.

15. Are there any limitations on any voting or other rights identified above?

You are giving your voting rights to the custodian, who will vote the Securities on behalf of all investors who purchased Securities on the Netcapital crowdfunding portal.

16. **How may the terms of the securities being offered be modified?**

We may choose to modify the terms of the securities before the offering is completed. However, if the terms are modified, and we deem it to be a material change, we need to contact you and you will be given the opportunity to reconfirm your investment. Your reconfirmation must be completed within five business days of receipt of the notice of a material change, and if you do not reconfirm, your investment will be canceled and your money will be returned to you.

Restrictions on Transfer of the Securities Offered

The securities being offered may not be transferred by any purchaser of such securities during the one-year period beginning when the securities were issued, unless such securities are transferred:

- to the issuer;
- to an accredited investor;
- as part of an offering registered with the U.S. Securities and Exchange Commission; or

18. **How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of securities?**

We are required to issue common stock if the provisions of existing convertible securities is triggered by this financing round or a future financing round. The existing convertible securities are subject to conversion into equity under certain circumstances, and if they convert you will be diluted by that conversion.

19. **Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?**

20. **How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?**

Currently, CEO Melvin Du and Amro Eltayeb, who together, comprise the Board of Directors. Their only incentives are to make the company successful. The Company's bylaws can be amended by the shareholders of the Company, and Directors can be added or removed by Shareholder vote. As minority owners, you are subject to the decisions made by the majority owners. The issued and outstanding common stock gives management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as the issuance of additional shares, or the sale of debt, convertible debt or assets of the company.

In the event of liquidation, minority owners may not get the returns they were hoping for. From our inception on May 1, 2018 to December 31, 2018, we expended \$29,250 and incurred a loss of \$28,426. We have not commenced planned principal operations nor generated revenue. Our activities have consisted of formation activities, research and development, and capital raising. We have raised \$155,000 by issuing convertible debt and SAFE agreements. At the time of this offering we have approximately \$40,000 in cash and a burn rate of \$10,000 per month. We believe we have approximately \$100,000 in additional funding available to us from investors that we know. We raised previous financings with convertible debt and SAFE agreements, all with a valuation cap of \$3,000,000. In 2019, we secured investments totaling \$125,000 from a nationally recognized accelerator program called TechStars, which only accepts 1% of applicants. Typically, a startup at our proven prototype, but pre-revenue stage, would raise an equity round at a valuation of \$3,000,000 to \$6,000,000. We believe the valuation of our common stock is appropriate and at the low-end of this accepted range.

Video Transcript: Good evening, everyone. My name is Yannick Roux. After leaving Tesla last year, I was bombarded by requests to advise electric mobility startups. When my friend Roman introduced me to Ramp, I was immediately struck by the young and passionate engineers Mel and Amro. They are on a mission to provide mobility to those who need it the most by making humans better, faster, stronger. Please welcome, Mel. Our story started 8 years ago. I got into a motorcycle accident and flipped over, breaking my spine and leaving me paralyzed from the chest down. Now I use a wheelchair, and everywhere I go has become a challenge. I didn't choose this problem, it chose me. The problem of grass, gravel, mud, snow, and really any unpaved surface anytime of year. And inclines, no matter what the internet tells you, the world isn't flat. But if you don't want to push yourself, you need a 300 pound power-chair that can't be transported without a hydraulic lift. So I opted for a manual chair and the shoulder strain that came with it. Over time, I learned how to wheelie in a manual, to wheelie over obstacles, maximizing ground clearance, and preventing the front wheels from getting stuck. I have to do this everywhere I go, it's exhausting. And I can only do this cause I work out a lot, obviously. But what if I didn't have to push or wheelie? What if no-one had to, ever again? Introducing the Ramp Chair, an attachment that converts any manual wheelchair into an off-road electric vehicle. It can self balance to wheelie over obstacles, wheeling over rocks, down curbs, and it can be controlled remotely, tearing through grass, gravel, mud, and snow. Hills are no problem. It can always be used as a manual chair, never leaving you stranded from a dead battery, like our competitors. It's portable enough to fit in any car, ride-share, or plane, and at under 35 pounds, its the lightest electric wheelchair in the world. So you can commute to work, or ride it anywhere you want. Before today, you would need three different wheelchairs to do what RAMP does with one. A manual for portability, an electric for mobility, and an off-road for the outdoors. Who carries around three wheelchairs? RAMP enables you to leave home with one vehicle that can do it all. We're launching our beta testing program in partnership with USA Shooting, the governing body for the U.S. Paralympic teams. These athletes are representing our country and winning metals, yet they can't always make it to practice because they're blocked by gravel or snow. They

deserve better. Everyone deserves better. We're also tapped into the communities of the nation's top three rehab hospitals, including patients, the therapists that make their purchasing decisions, and some amazing brand-ambassadors. Wheelchairs are purchased for between 4,000 and 20,000 dollars. We're launching with an 8,000 dollar recreational model, sold online and at retail. Launching in 2020, it's an electric mountain-bike for your butt. We're also in the process of FDA clearance for a 10,000 dollar medical model, reimbursed by insurance. One percent of the population need wheelchairs, and last year, two billion dollars were spent on electric wheelchairs in the U.S. alone. This market has eighteen percent year-over-year growth, and it's about to hit an inflection-point. The aged population, will grow faster in the next decade than any other time in history. By 2035, they'll outnumber minors, and guess what? They're gonna need a lot of wheelchairs. So, why choose electric vehicles for our first startup? Why not something easier, like B to B SaaS? If you didn't get it, then it's a startup joke. Well, the reason is that disability has affected the families of everyone on our founding team. We're mechanical engineers. Using hardware to solve real problems is what we do best. So if our mission can help you, or someone you know, go to our website, sign up, and tell everyone you know. But our mission doesn't stop at building wheelchairs. Our mission is to cure disability using robotics. Today, we're using the latest technology to make wheelchairs into electric vehicles. Tomorrow, we'll use exoskeletons to make wheelchairs obsolete, because I didn't choose this problem, but I won't stop working to solve it until I'm walking again. Thank you so much.
