



The legacy of the 2023 FIFA Women's World Cup will not only be incredible football - it will be indisputably proving that it's good business for brands to invest in women's sports.

For brands that are thinking about sponsoring women's sports (and need more proof that it's a good business proposition) there are two new reports from The Collective at **Wasserman** + RBC and from The Office for Women in Sport and Recreation in Victoria, Australia that use data to show how lucrative sponsoring women's sports can be.

I wrote a short article that summarizes the key takeaways from both reports - and shared my thoughts around why it won't be surprising if after this World Cup more brands sign-on to sponsor women's sports - even if it means moving dollars out of men's sports to invest more in women.
