- We offer a niche service at a premium price. It is possible our customers will no longer demand or pay higher for organic or sustainable services. Our margins may reduce and customer demand may fall.
- Changes in franchise regulations by government agencies or regulators could adversely affect our ability to grow. Changes could also lead to negative legal or financial exposure.
- State franchise regulators may not approve us to sell new franchises in their state. This would limit our core growth strategy in key states.
- We are waiting on approval of an EPA label for a product owned by a key partner for an organic herbicide that is part of our growth strategy. The delay or denial or approved wording may adversely affect our ability to use this product and execute this growth strategy. We would also lose this partnership and not have access to the product.
- Loan and interest risk. We could have loans called that could cause cash issues and put the overall company health at risk. We could have issues refinancing current loans that are not current or become not current.
- Finding employees may not be possible. Many of our locations are in high standard of living cities and it's difficult to find employees to work at the wages we can offer. Without employees, we would not be able to grow in these locations. Loss of employees could lead to closing locations.
- Changes in SEO and pay-per-click marketing practices could adversely affect our ability to grow. SEO and PPC campaigns are the primary strategy we employ to find new franchise owners. It can be difficult to stay on top of changes in these strategies.
- Delays in audit completion could reduce overall new location sales. We are required to have a completed annual audit by 4/30 every year to sell franchises in that year. If it's delayed, it can cause a gap in new location sales that would reduce overall sales.
- We can provide no assurance that our current or potential competitors will not provide products or services comparable or superior to those provided by us or adapt more quickly than we do to evolving industry or market trends. Increased competition may result in price reductions, reduced gross margins and loss of market share, any of which would materially and adversely affect our business, prospects, financial condition or results of operations. We cannot assure investors that we will be able to compete effectively against current and future competitors.
- Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Clean Air Lawn Care, Inc. is offering a total of 16,250 shares of Preferred Stock at a share price of \$50.00.

These shares do not have voting rights, rather rights are proxied to the CEO. Preferred Stock holders will receive liquidation preferences over Common Stock holders.

For investors up to the first \$250,000, the Company is offering up to 6,250 of Preferred Stock with a lower pre-money valuation of \$5,192,560 and a price per share of \$40.00.

Voting Proxy: Investors in this Offering do not have voting rights. Instead, the purchasers of shares of Common Stock in this Offering shall grant the Company's CEO a voting proxy to vote all of their shares of Common Stock.

SPV Reorganization. The undersigned hereby agrees to take any and all actions determined by the Company's managers in good faith to be advisable to reorganize this instrument and any Shares issued pursuant to the terms of this instrument into a special-purpose vehicle or other entity designed to aggregate the interests of holders of the Shares.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended, as required by Section 12(g) thereof, the Company shall have the option to repurchase the Shares from the undersigned for the greater of (i) the Purchase Price and (ii) the fair market value of the Shares, as determined by an independent appraiser of securities chosen by the Company (such repurchase, the "Repurchase," and such greater value, the "Repurchase Value"); provided, however, that, in the event an Equity Financing (as defined below) occurs within three months after the Repurchase and the Repurchase Value is less than the Aggregate Value (as defined below) of the Shares the undersigned would have received had the Repurchase not occurred (where such value is determined by multiplying the number of Shares by the Financing Price (as defined below) and is referred to as the "Aggregate Value"), the Company shall pay to the undersigned an amount equal to the difference between the Aggregate Value and the Repurchase Value promptly following the consummation of the Equity Financing. Such independent appraiser shall be regularly engaged in the valuation of securities. The foregoing repurchase option terminates upon a Change of Control or Dissolution Event (each, as defined below).

Investors in this Offering will receive Preferred Stock, which has liquidation preference over Common Stock, but does not have voting rights. To date, the Company has not authorized any Preferred Stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering or sale).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. 20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

We opened 17 new territories in the last two calendar years and see a clear path towards our 5-year goal. As consumer interest in organic lawn care options grows, so does entrepreneurial interest. There are a lot of "green entrepreneurs" out there, we just need to reach them through increased marketing efforts.

The Company that Investors are investing in during this Offering is the franchisor, not an individual territory owned by a specific franchisee.

Clean Air Lawn Care, Inc. was incorporated in the State of Colorado in January 2006.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 60 months. Runway & Short/Mid Term Expenses

Clean Air Lawn Care, Inc. cash in hand is \$19,624.01, as of September 2019. Over the last three months, revenues have averaged \$54,104.17/month, cost of goods sold has averaged \$3,115.30/month, and operational expenses have averaged \$34,302.03/month, for an average net margin of \$16,686.84 per month.

We opened 0 new locations in the first half of 2019. We have opened 3 in the last three months which is closer to average over the last 3 years. We increased short term debt to cover the losses incurred from low franchise income revenue in the first half of the year.

We expect revenues and expenses to be similar to last 3 months over the next 3 months. We expect royalty revenues to decrease 20-40% from January-March 2020 due to seasonality of revenue. We expect expenses from January-March 2020 to be similar to last 3 months.
