We do not own the inventory we sell. There is a risk that our suppliers decide not to sell through our platform any longer, leaving us with only a few products to sell from smaller manufacturers.

Lack of adoption of the Salon Management tool and sell-in of the Sampling program to Brands. These two programs represent a significant source of future revenue and profitability.

Technology could fail, resulting in an inability to deliver on product sales, sampling opportunities and other site issues.

Profits are not high enough for staff to be able to work full-time. High quality and highly experienced staff may not be possible without the proper funding to compensate for their time.

COVID-19 can materially impact our business.

It is unclear how long the COVID-19 pandemic will last and to what degree it could hurt our ability to generate revenues.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. Book Entry and Use of XX Investments LLC as Transfer Agent and Custodian. Investments will be in book entry form. ## Ownership and Capital Structure

### THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

1. the total value of the Investor's investment, divided by
  1. the price of Preferred Stock issued to new Investors multiplied by
  2. the discount rate (80%), or
2. if the valuation for the company is more than \$8,000,000.00 (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time, all as further described in the SAFE.

*Equity Financing.* If there is an Equity Financing before the expiration or termination of this Safe, the Company will automatically issue to the Investor a number of shares of Safe Preferred Stock equal to the Purchase Amount divided by the Conversion Price. In connection with the issuance of Safe Preferred Stock by the Company to the Investor pursuant to Section 1(a) of the SAFE: (i) The Investor will execute and deliver to the Company all transaction documents related to the Equity Financing; provided, that such documents are the same documents to be entered into with the purchasers of Standard Preferred Stock, with appropriate variations for the Safe Preferred Stock if applicable; and (ii) The Investor and the Company will execute a Pro Rata Rights Agreement, unless the Investor is already included in such rights in the transaction documents related to the Equity Financing.

*Liquidity Event.* If there is a Liquidity Event before the expiration or termination of this Safe, the Investor will, at its option, either (i) receive a cash payment equal to the Purchase Amount or (ii) automatically receive from the Company a number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price, if the Investor fails to select the cash option.

In connection with Section (b)(i) of the SAFE, the Purchase Amount will be due and payable by the Company to the Investor immediately prior to, or concurrent with, the consummation of the Liquidity Event. If there are not enough funds to pay the Investor and holders of other Safes (collectively, the "Cash-Out Investors") in full, then all of the Company's available funds will be distributed with equal priority and pro rata among the Cash-Out Investors in proportion to their Purchase Amounts, and the Cash-Out Investors will automatically receive the number of shares of Common Stock equal to the remaining unpaid Purchase Amount divided by the Liquidity Price. In connection with a Change of Control intended to qualify as a tax-free reorganization, the Company may reduce, pro rata, the Purchase Amounts payable to the Cash-Out Investors by the amount determined by its board of directors in good faith to be advisable for such Change of Control to qualify as a tax-free reorganization for U.S. federal income tax purposes, and in such case, the Cash-Out Investors will automatically receive the number of shares of Common Stock equal to the remaining unpaid Purchase Amount divided by the Liquidity Price.

*Dissolution Event.* If there is a Dissolution Event before this Safe expires or terminates, the Company will pay an amount equal to the Purchase Amount, due and payable to the Investor immediately prior to, or concurrent with, the consummation of the Dissolution Event. The Purchase Amount will be paid prior and in preference to any Distribution of any of the assets of the Company to holders of outstanding Capital Stock by reason of their ownership thereof. If immediately prior to the consummation of the Dissolution Event, the assets of the Company legally available for distribution to the Investor and all holders of all other Safes (the "Dissolving Investors"), as determined in good faith by the Company's board of directors, are insufficient to permit the payment to the Dissolving Investors of their respective Purchase Amounts, then the entire assets of the Company legally available for distribution will be distributed with equal priority and pro rata among the Dissolving Investors in proportion to the Purchase Amounts they would otherwise be entitled to receive pursuant to Section 1(c) of the SAFE.

*Termination.* This Safe will expire and terminate (without relieving the Company of any obligations arising from a prior breach of or non-compliance with this Safe) upon either (i) the issuance of stock to the Investor pursuant to Section 1(a) or Section 1(b)(ii); or (ii) the payment, or setting aside for payment, of amounts due the Investor pursuant to Section 1(b)(i) or Section 1(c).

*Irrevocable Proxy.* The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through [wefunder.com](#), and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

*Repurchase.* If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities, and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

"**Company Capitalization**" means the sum, as of immediately prior to the Equity Financing, of: (1) all shares of Capital Stock (on an as-converted basis) issued and outstanding, assuming exercise or conversion of all outstanding vested and unvested options, warrants and other convertible securities, but excluding (A) this Safe, (B) all other Safes, and (C) convertible promissory notes; and (2) all shares



or Common Stock reserved and available for future grant under any equity incentive or similar plan of the Company, and/or any equity incentive or similar plan to be created or increased in connection with the Equity Financing.

*Voting rights:* If the SAFEs convert into stock, investors will have voting rights subject to the proxy, and, upon conversion, may be further subject to an agreement among the stockholders relating to the voting of the shares of stock.

Any provision of this instrument may be amended, waived or modified only upon the written consent of the Company and the Investor. In addition, any term of this instrument may be amended or waived with the written consent of the Company and the Investors holding a majority of the outstanding Purchase Amount (the "Majority Investors") under all Safes with the same "Valuation Cap" and "Discount Rate" as this Safe (the "Safe Series"); provided that:

- (A) the Purchase Amount cannot be amended, waived or modified in this manner,
- (B) the consent of the Investor and each holder of a Safe in such Safe Series must be solicited (even if not obtained), and
- (C) such amendment, waiver, or modification treats all such holders in the same manner.

Upon the effectuation of such waiver or amendment with the consent of the Majority Investors in conformance with this paragraph, such amendment or waiver shall be effective as to, and binding against the holders of, all of the Safes in the Safe Series and the Company shall promptly give written notice thereof to the Investor if the Investor has not previously consented to such amendment or waiver in writing, provided that the failure to give such notice shall not affect the validity of such amendment or waiver.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor, provided it has the consent of the Company:

We are the Largest Black owned online Hair and Beauty retail platform in the US, with National Brands, niche and newly discovered Hair Care, Beauty and Personal Care products created by and/or for consumers of color.

In 5 years, we hope to be the #1 alternative community-powered retail ecosystem that outperforms traditional retail in the sale and distribution of products created by and/or for communities of color. These projections are not guaranteed.

#### Milestones

Eighttten LLC was founded in 2018 and launched 4thAveMarket.com in February 2019. Eighttten LLC was converted to a C-Corporation in the name of 4th Ave Market incorporated on October 28, 2020.

Since then, we have:

- Helped increase access, awareness, and distribution of health & beauty products for communities of color
- Team has worked with Fortune 500 brands including Urban Outfitters, GitHub, Jameson, Kotex and Axe
- High Growth! 2020 Sales +1274% vs. 2019
- Established partnerships with Hampton University, Conde Nast, UPS and other community organizations
- Business model generates profit while reinvesting directly back into communities of color.

#### Historical Results of Operations

Our company was organized as an LLC in 2018 and converted to a corporation in 2020.

OCTOBER 2020.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$234,410. Our gross margin was 8.31%. For the period ended December 31, 2019, the Company had revenues of \$3,048.
- *Assets.* As of December 31, 2020, the Company had total assets of \$77,984, including \$12,049 in cash. As of December 31, 2019, the Company had total assets of \$211,970, including \$158,675 in cash.
- *Net Loss.* The Company has had net losses of \$264,193 for 2020 and \$18,707 in 2019.
- *Liabilities.* The Company's liabilities totaled \$85,791 for 2020 and \$584 for 2019.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$230,000 in equity and \$45,000 in SAFES.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 8 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

4th Ave Market Inc. cash in hand is \$14,899, as of February 2021. Over the last three months, revenues have averaged \$11,000/month, cost of goods sold has averaged \$5,395/month, and operational expenses have averaged \$5,500/month, for an average net margin of \$105 per month. While we are currently profitable, we expect to become unprofitable for a period as we invest more heavily in building out revenue streams. Our intent is to be profitable again in 12 months.

Our trends have remained stable over the last two months. Recent investments will help to drive sales volume in the coming months (starting in March 2021).

Without any additional investment, in 3 to 6 months, trends would continue of ~\$11K per month in revenue and around \$5K in accompanying expenses.

We are looking to raise \$350K through Crowdfunding and a total of \$1.5MM overall. We will start this raise at the max of \$107K and complete the CPA review should we want to extend the round to a higher amount, which will depend on the speed of the raise. With \$350K in funds raised over the next 6 months we will be able to achieve sales of \$480K with on-going expenses of ~\$35K per month (\$210K total). These expenses will go towards building out two revenue streams: a salon program and a sampling program. For a period we will become unprofitable as we invest in those programs, but we expect to move into stable profitability by end of 2021. These projections are not guaranteed.

Apart from our Wefunder raise, we are planning to raise around \$1MM through private investors, Venture capital funds, accelerators and Angel investors.

XX Investments acts at the direction of XX Team, because XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. XX Investments will not charge Investors for its services. XX Investments does charge the Company \$1,000/year for services; however, those fees may be paid by Wefunder Inc. on behalf of the Company.

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf. XX Team will act, with respect to the Company, through our Lead Investor, who is a representative of XX Team. As compensation for its voting services, each Investor authorizes XX Investments to distribute to XX Team 10% of any distributions the Investor would otherwise receive from the Company. XX Team will share its compensation with our Lead Investor. XX Team, through our Lead Investor, may also provide consulting services to the Company and may be compensated for these services by the Company; although, fees owed by the Company may be paid by Wefunder Inc. XX Team will share its consulting compensation with our Lead Investor.

The Lead Investor is an experienced investor that we choose to act in the role of Lead Investor, both on behalf of the Company and on behalf of Investors. As noted, the Lead Investor will be a representative of XX Team and will share in compensation that XX Team receives from the Company (or Wefunder Inc. on the Company behalf) or from Investors. The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities.
