We need to secure enough viable locations across the US. We currently have a relationship with property managers that have 100 viable locations and we hope be developing the other 250 in 2020. Failure to meet these goals will impede our plans for future growth.

Negotiating location contracts can take longer than 3 months due to external reasons. We are assuming similar average conditions to what we encountered in Boston and Orlando however local difference may result in longer times to secure the locations.

If we do not raise this round fast enough to deploy the minimum number of kiosks, our future revenues may not be sufficient to fund additional growth.

Ramp up of revenue in each location might not be as predicted due to local differences in seasonality.

We might have to adjust product offering depending on local preferences to optimize revenue, resulting in longer revenue ramp up.

Unpredicted consumer trends might require an adjustment in product offerings in each location, resulting in longer revenue ramp up.

This offering is being conducted on an expedited basis due to circumstances relating to COVID-19 and pursuant to Reg. CF Temporary Rule 201(z)(3), which provides temporary relief from certain financial information requirements by allowing issuers to provide financial information certified by the principal executive officer of the issuer instead of financial statements reviewed by a public accountant that is independent of the issuer.

MagNet micro store sales performance depend on foot traffic. We are assuming that the current COVID-19 pandemic will gradually subside and foot traffic will show a trend to recovery within 12-18 month.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Investors in the first \$64,003.66 of the offering will receive stocks at a price per share of \$4.97, and a pre-money valuation of \$5,102,664.21.

The campaign maximum is \$249,995.05 and the campaign minimum is \$50,003.17.

**Participation Rights.** Each time the Company proposes to offer any Equity Securities (defined in the attached subscription agreement) at any time through and including the closing of the Next Equity Financing (defined below), the Company shall provide each Major Investor (defined in the attached subscription

agreement) with at least ten business days prior written notice or such offering, including the price and terms thereof. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. In the future, we will perform valuations of our common stock that take into account factors such as the following:

- unrelated third party valuations of our common stock;
- the price at which we sell other securities, such as convertible debt or preferred stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the lack of marketability of our common stock;
- the hiring of key personnel and the experience of our management;

- our stage of development and material risks related to our business;

MagNet micro stores provide a delightful experience with precise information (typically only offered by online shopping) and immediate gratification exactly at the point of need. We believe MagNet has the smallest footprint and highest efficiency in the market, reaching consumers where no other retailer can.

In 5 years, MagNet hopes to have more than 1000 locations in the US and the company will be an acquisition target of companies like Amazon, Google, Apple, and BestBuy that are trying to bridge the gap between online and location retail. At that time, our pilots have been successful. We have brand partnerships, relationships with property managing companies for viable locations across the US, hardware manufacturing partnerships, and team ready to scale. These projections cannot be guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

#### Milestones

MagNet Analytics, Inc. was incorporated in the State of Delaware in May 2018.

Since then, we have:

- 20 pilots including brand/location partners Disney & McDonalds proved people love our micro stores.
- CEO/Founder sold a company to market leader ZoomSystems, operator of BestBuy Express. (Team: MIT Sloan, Harvard Business, & Dartmouth).
- Proven Scalable Model: Boston pilots pay for themselves every 6 months.
- Exit Strategy: Within 2 years the company hopes (but not guarantees) to be acquired by a company like Amazon, Google, Apple, or BestBuy.
- Strong IP including patent (owned by MagNet Analytics,) for compact dispensing and container swap replenishment system.
- (We made the world's smallest and most-efficient product-dispensing kiosk)!
- Raising an investment round to scale to 350 locations in the top 20 cities in the U.S. (Based on successful pilot results).

#### Historical Results of Operations

Our company was organized in May 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$10,000 compared to the year ended December 31, 2019, when the Company had revenues of \$21,349.
- *Assets.* As of December 31, 2020, the Company had total assets of \$35,032.55, including \$35,032.55 in cash. As of December 31, 2019, the Company had \$139,228 in total assets, including \$22 in cash.
- *Net Loss.* The Company has had net losses of \$106,363.03 and net losses of \$344,288 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

To-date, the company has been financed with \$283,984 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

MagNet Analytics, Inc. cash in hand is \$34,000, as of February 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$8,000/month, for an average burn rate of \$8,000 per month. Our intent is to be profitable in 6 months.

The company successfully completed the revenue objectives of the micro store pilots at the end of 2019 and pilots were wrapped up to focus on the scaling stage and fund raising.

We expect to deploy new micro stores starting 4 months after we complete the funding round. We predict that we'll need \$450,000 in capital to complete that manufacturing run. Six month later, we hope to generate \$315,000 in revenue and \$486,450 in expenses.

We are negotiating an equipment lease agreement with Camber Road to mitigate the capital requirements.
