8. Discuss the material factors that make an investment in the issuer speculative or risky:

Maintaining proper inventory to consistently supply consumer demand is paramount to a high growth food cpg brand. If we do not hit our fund-raising targets we may not be able to adequately fund our production and meet the growing national purchase orders of our distribution and retail customers.

The Company relies heavily on the relationships it has with its contract manufacturers. If any of these co-packers are unable to consistently provide on-spec product on commercially reasonable terms, this could adversely affect the business.

The Company has approximately \$300,000 of debt maturing in 2020. Of this debt, \$200,000 is in the form of a convertible note set to convert into shares in 2020. If the note does not convert and the company is unable to re-finance on commercially reasonable terms or repay this debt, it could put a significant strain on the Company's finances.

Our future success depends on the efforts of a highly efficient, but small management team. The loss of services of the members of the management team may have an adverse effect on the company. Additionally, the future growth of the company is tied to our ability to grow the team through the hiring of talented employees.

Although we have never had a product recall in 9 years of doing business, product contamination is a risk for all food companies.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to

the rights of the Company's officers or directors to bring suits or bring or direct the Company or its actions.

Mark Guirgis (CFO) is a part-time officer. As such, it is possible the company may not make the same progress as it could if that were not the case.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$150,000**

Use of Proceeds: 15% towards business development, 62.5% towards product and inventory and 15% towards hiring and 7.5% toward Wefunder Fees

If we raise: **\$1,070,000**

Use of Proceeds: 30% towards business development, 42.5% towards product and inventory and 20% towards hiring and 7.5% toward Wefunder Fees

If we reach our target offering amount prior to the deadline, we may conduct an initial closing of the offering early if we provide notice about the new offering deadline at least five business days prior to the new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Wefunder will notify investors if we conduct an initial closing. Thereafter, we may conduct additional closings from time to time at our and Wefunder's discretion until the deadline date.

1. Investor Commitment. The Investor will submit, through Wefunder Portal, a requested investment amount. When doing so, the investor will also execute an investment contract with the Company ("Investment Agreement"), using the Investor's electronic signature.
2. Acceptance of the Investment. If the Investor Agreement is complete, the Investor's commitment will typically be recorded within a few minutes. The commitment will also be available on the Investor's "My Investments" screen on the wefunder.com website. After the offering closes, the contract will be counter-signed by the Company. The executed investment contract will then be sent to the investor via email, and is also available to download on the "My Investments" screen.
3. Investor Transfer of Funds. Upon receiving confirmation that an investment has been accepted, the Investor will be responsible for transferring funds from a source that is accepted by Wefunder Portal into an escrow account held with a third party bank on behalf of issuers offering securities through Wefunder Portal.
4. Progress of the Offering. The Investor will receive periodic email updates on the progress of the offering, including total amounts raised at any given time, and will be notified by email and through the "My Investments" screen when the target offering amount is met.
5. Closing: Original Deadline. Unless we meet the target offering amount early, Investor funds will be transferred from the escrow account to the Company on the deadline date identified in the Cover Page to this Form C and the Company's Wefunder Portal Profile.
6. Early Closings. 7. Book Entry. Investments may be in book entry form. This means that the Investor may not receive a certificate representing his or her investment. Each investment will be recorded in our books and records and will be recorded in each Investors' "My Investments" screen. The Investor will also be emailed the Investment Agreement again. The Investment Agreement will also be available on the "My Investments" screen. At the option of the Company, you may receive an electronic certificate.

12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment).

If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment.

If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be cancelled and the committed funds will be returned.

An Investor's right to cancel. An Investor may cancel his or her investment commitment at any time until 48 hours prior to the offering deadline.

If there is a material change to the terms of the offering or the information provided to the investor about the offering and/or the Company, the investor will be provided notice of the change and must re-confirm his or her investment commitment within five business days of receipt of the notice. If the investor does not reconfirm, he or she will receive notifications disclosing that the commitment was cancelled, the reason for the cancellation, and the refund amount that the investor is required to receive. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

If the investor cancels his or her investment commitment during the period when cancellation is permissible, or does not reconfirm a commitment in the case of a material change to the investment, or the offering does not close, all of the investor's funds will be returned within five business days.

Within five business days of cancellation of an offering by the Company, the Company will give each investor notification of the cancellation, disclose the reason for the cancellation, identify the refund amount the investor will receive, and refund the investor's funds.

The Company's right to cancel. The Investment Agreement you will execute with us provides the Company the right to cancel for any reason before the offering deadline.

If the sum of the investment commitments from all investors does not equal or exceed the target offering amount at the time of the offering deadline, no securities will be sold in the offering, investment commitments will be cancelled and committed funds will be returned.

In addition, we may cap at 450 the total number of investors who will be allowed to invest through the offering that are not "accredited investors," as defined in Rule 501(a) of Regulation D under the Securities Act of 1933. In the event that more than 450 non-accredited investors are initially accepted into an offering in step (2) described in Question 11, the Company may cancel investments based on the order in which payments by investors were received, or other criteria at the discretion of the Company, before the offering deadline.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **units** in the Company ("Units"), when and if the Company sponsors an equity offering that involves **Units**, on the standard terms offered to other investors.

Conversion to Equity. Based on our SAFEs, when we engage in an offering of equity interests involving

Units,

investors will receive a number of Units calculated using the method that results in the greater number of **Units**:

(i) the total value of the investor's investment, divided by (a) the price of **Units** issued to new investors multiplied by (b) the **discount rate** (85%) , or
(ii) if the valuation for the company is more than **\$7 million** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of (a) the Valuation Cap divided by (b) the total amount of the Company's capitalization at that time.

(iii) for investors who invest within the first ten business days up to an aggregate amount of **\$250,000** of the securities, those investors ONLY will receive a valuation cap of **\$6,000,000** and a discount rate of 75%.

Additional Terms of the Valuation Cap.

For purposes of option (ii) above, the Company's capitalization will be measured as all

units outstanding at the time,

not including any SAFEs or convertible notes, plus any

units reserved and

available for future grant under any equity incentive or similar plan of the Company or to be created or increased in connection with our equity offering at

that time.

Investors who receive **Units** subject to the Valuation Cap will also receive dividend rights.

No Voting Rights.

Investors will have no voting rights.

Instead,

the Company's CEO will be provided a proxy to vote on the Investor's behalf.

Private Sales for Major Investors. Investors who invest at least \$25,000 and are "accredited investors" will receive the right to purchase a pro-rata share of privately placed securities occurring after an equity offering covered by the SAFEs.

Major Investor Threshold

Definition: A major investor is one who invests a minimum of \$25,000.00 and are "accredited investors" as defined by Rule 501 of Regulation D (17 C.F.R. §230.501(a)).

Execution. Investors who invest less than \$25,000.00 will typically not execute transaction documents in order to receive Units at the time of an applicable equity offering. Instead, a "Designated Lead Investor" will execute the documents for them, provided that the documents are consistent with the Units received by new investors in the Company, modified, if applicable, based on the terms of the SAFE.

Liquidity Events.

If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Units**, Investors will receive

- units equal to the amount invested by the Investor in the SAFEs divided by the quotient of (a) the Valuation Cap divided by (b) the number of outstanding **Units**, but excluding any **units** reserved and available for future grant under any equity incentive or grant, SAFEs, and/or convertible promissory notes.

Termination of the Company.

If the Company ceases operations, liquidates, dissolves, winds up or has its assets assigned to creditors prior to an issuance of securities involving **Units**, the Company will pay first the other holders of existing **Units**, based on the terms of the Company's certificate of incorporation, and then holders of the SAFEs. If there are not sufficient Company assets to pay holders of the SAFEs the amount of their investments, as determined by the Company's management, payments will be made on a pro-rata basis. In this case, Investors may not recoup part or all of their investment from the Company.

Repurchases.

If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended, as required by Section 12(g) thereof, the Company shall have the option to repurchase this instrument from the Investor for the greater of (i) the Purchase Amount and (ii) the fair market value of this instrument, as determined by an independent appraiser of securities chosen by the Company.

(i) if the Investor is not a Major Investor, any provision of this instrument (other than the Valuation Cap) may be amended, waived or modified only upon the written consent of the Company and either (A) the Designated Lead Investor or (B) the holders of a majority of the Purchase Amounts payable to the Cash-Out Investors; (ii) if the Investor is a Major Investor, any provision of this instrument (other than the Valuation Cap) may be amended, waived or modified only upon the written consent of the Company and the holders of a majority of the Purchase Amounts payable to the Cash-Out Investors who are Major Investors; and (iii) regardless of whether the Investor is or is not a Major Investor, the Valuation Cap may be amended, waived or modified only (i) upon the written consent of the Company and the holders of a majority of the Purchase Amounts payable to the Cash-Out Investors or (ii) as contemplated in the definition of Valuation Cap.

The securities being offered may not be transferred by any purchaser of such securities during the one year period beginning when the securities were issued, unless such securities are transferred:

1. to the issuer;
2. to an accredited investor;
3. as part of an offering registered with the U.S. Securities and Exchange Commission; or
4. to a member of the family of the purchaser or the equivalent, to a trust controlled by the purchaser, to a trust created for the benefit of a member of the family of the purchaser or the equivalent, or in connection with the death or divorce of the purchaser or other similar circumstance.


NOTE: The term "accredited investor" means any person who comes within any of the

categories set forth in Rule 501(a) of Regulation D, or who the seller reasonably believes comes within any of such categories, at the time of the sale of the securities to that person.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

Overview

We make convenient, frozen, plant-based foods known for incredible flavor and quality. Grocery store consumers all across the country love our East-Mediterranean inspired line of Falafel Street Wraps and Gluten-Free stuffed Falafel Poppers

Based on our historical growth and knowledge of the industry we anticipate expanding our North America national footprint to 15,000 - 20,000 retail locations, increase our product count from 7 to 14-21 SKUs, and grow our top-line revenue to \$25 million in five years.

Milestones

Eat Good Do Good, LLC was incorporated in the Commonwealth of Virginia in March 2010. The company intends to convert to a C-corp prior to the close of the Wefunder campaign.

Since then:

- With over \$8.5 million in life-time sales, TaDah has proven that consumers all across the country not only want to eat healthy foods, but also delicious, plant-based foods.
- We are on pace to exceed \$2.0 million in sales in 2020.
- 2 billionaire Sharks fought for a chance to invest in TaDah! during the Season 11 premiere.
- With over national distribution in more than 2,500 retailers, Tadah is one of the fastest-growing product lines in our specific category and the Company is poised for explosive 5-yr growth
- Excluding the millions that watched the Company's SharkTank episode on prime time television, TaDah has received 146 million online media impressions
- With over 15 years experience in consumer pre-packaged foods, our team has the experience, relationships, and infrastructure to scale TaDah! Foods to new heights.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2018, the Company had revenues of \$640,935 compared to the year ended December 31, 2017, when the Company had revenues of \$785,663. Our gross margin was 7.96% in fiscal year 2018, compared to 35.81% in 2017.
- *Assets.* As of December 31, 2018, the Company had total assets of \$95,954, including \$6,540 in cash. As of December 31, 2017, the Company had \$216,699 in total assets, including \$14,302 in cash.
- *Net Loss.* The Company has had net losses of \$236,016 and net losses of \$60,878 for the fiscal years ended December 31, 2018 and December 31, 2017, respectively.
- *Liabilities.* The Company's liabilities totaled \$537,331 for the fiscal year ended December 31, 2018 and \$422,060 for the fiscal year ended December 31, 2017.

Liquidity & Capital Resources

To-date, the company has been financed with \$336,853 in debt, \$200,000 in convertibles, \$50,000 in SAFEs, and \$300,000 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 7 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 7 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Eat Good Do Good, LLC cash in hand is \$30,000, as of January 2020. Over the last three months, revenues have averaged \$25,000/month, cost of goods sold has averaged \$15,000/month, and operational expenses have averaged \$42,000/month, for an average burn rate of \$32,000 per month. Our intent is to be profitable in 3 months.

We experienced a significant issue with one of our key suppliers in 2018 that led to an inability to meet customer demand. Although the issue was ultimately rectified, it resulted in a drop in revenue for 2018. We have since addressed the issue and are actively working to further diversify our supply chain in order to meet our growing post Shark Tank demand and reduce COGs.

Our monthly burn is a function of business development and marketing activities. We believe we have the ability to throttle those back as necessary to accommodate working capital constraints. We have access to short-term funding sources to meet working capital needs. In addition, we are actively speaking to other long-term investors to provide growth/expansion capital. The Wefunder effort is part of that effort.

Since Dec 31, 2018, the Company appeared on Shark Tank and received a tremendous amount of positive publicity and momentum. The Company plans to successfully add 280 - 850 new distribution outlets in 2020, but this will require a significant amount of up-front working capital investment to fill the shelves of these new outlets. As a result, our orders strained our existing suppliers and we have sought new co-packers to fill the gap in supply. The addition of new co-packing suppliers has strained the Company's working capital (due to the upfront investments required) and thus slowed down sales growth. Nevertheless, the Company is very optimistic about its near-term prospects and remains very bullish about 2020. If we're able to reach our funding goal, we think (but cannot guarantee) we'll be able to generate 1.75 million - \$2.2 million in revenue by the

end of the year.

If the Company receives the minimum funding requirement, it hopes that revenues will grow quite significantly over the next 6 - 12 months. In accordance with revenue growth, it is expected that cost of goods sold will grow proportionately, albeit profitably. We do intend on making 1-2 significant and much needed hires in the next few months to manage key accounts and grow top-line revenue. Other than that, it is management's intention to run very lean.
