Maintaining proper inventory to consistently supply consumer demand is paramount to a high growth food cpg brand. If we do not hit our fund-raising targets we may not be able to adequately fund our production and meet the growing national purchase orders of our distribution and retail customers.



The Company relies heavily on the relationships it has with its contract manufacturers. If any of these co-packers are unable to consistently provide on-spec product on commercially reasonable terms, this could adversely affect the business.

The Company has approximately \$200,000 of debt maturing in 2020. If the Company cannot raise the necessary capital it is seeking or it does not achieve its growth objectives, it may not be able to meet debt maturity payments.

Although we have never had a product recall in 9 years of doing business, product contamination is a risk for all food companies.

Delivery times for production or shipment of our product may be adversely affected by delays due to pandemics, such as COVID-19, and the effects of this cannot be accurately estimated. This may cause delays in the recognition of revenue and have an adverse effect on our cash flow.

On February 16, 2021, the Company was notified of a class action lawsuit filed against the Company in the Circuit Court of the City of St. Louis, Missouri alleging the Company's packaging was deceptive. The firm representing the Plaintiff has filed many similar lawsuits and makes a practice of bringing such claims.

In the summer of 2020 and prior to the suit being filed, the Company had already modified its packaging and the language in question. While there can be no guarantees, the Company has engaged counsel to address the matter and believes it will resolve the matter favorably.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Mark Guirgis is a part-time officer. While Mr. Guirgis devotes a substantial amount of time to the success of the Company, at some point in the future and when the Company reaches a certain level of revenue, it will need to consider hiring a full-time CFO.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:**

1. the total value of the Investor's investment, divided by
  1. the price of Preferred Stock issued to new Investors multiplied by
  2. the discount rate (92%), or
2. if the valuation for the company is more than \$12,500,000.00 (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time.
3. for investors up to the first \$581,000.00 of the securities, investors will receive a valuation cap of \$10,000,000.00 and a discount rate of 88.0%.

The company has not yet authorized preferred stock which, if the SAFE converts, investors in the SAFE will receive. Preferred stock will not have voting rights but will have liquidation preferences over common stock holders.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. #### Overview

We make convenient frozen plant-based foods known for incredible flavor and quality. Grocery store consumers all across the country love our East-Mediterranean inspired line of Falafel Street Wraps and Gluten-Free stuffed Falafel Poppers. Our product have a 4.8 out of 5 stars in consumer reviews.

The key for us in 2021 and beyond is to be able to support the growth of our existing national retail base and accelerate our growth by strategically expanding into new retail locations while improving our profitability. Based on our historical growth and knowledge of the industry, in 5 years we plan to expand our North America national footprint to 15,000 - 20,000 retail locations, increase our product count from 7 currently to 14-21, and grow our top line revenue to \$25M+. These projections cannot be guaranteed.

#### Milestones

Eat Good Do Good, Inc. was incorporated in the State of Delaware in November 2020. The Company was originally established in June 2010 in the Commonwealth of Virginia as a limited liability company and doing business as TaDah! Foods. In 2020, the Company converted from an LLC in the Commonwealth of Virginia to a corporation domiciled in the State of Delaware.

Since then, we have:

- Over \$10M in sales from consumers who are regular and consistent customers of TaDah's flavor focused plant-based line.
- The company is on track to do over \$2.5M in top line revenue in 2021 (not guaranteed).

- 2020 gross profit (revenue less cost of revenue) up over 250% from 2019.
- Two billionaire Sharks fought to invest in TaDah! during the season 11 premiere.
- Sold nationwide at marquee retailers like Target, Whole Foods, Sprouts, Kroger, Publix, Harris Teeter and Wegmans.
- Found in 3500+ retail locations, Tadah! Foods is poised for 14-16X growth over next 5 yrs
- Primetime news report told our story and helped TaDah! connect to millions of viewers
- Leveraged Shark Tank exposure to gain an additional 146M+ of online impressions 40+ media outlets

#### **Historical Results of Operations**

Our company was organized in November 2020 and has focused operations upon which prospective investors may base an evaluation of its performance. The original LLC was organized on June 16, 2010 before Tadah! Foods converted to a C Corp in Nov, 2020.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$1,537,884. For the period ended December 31, 2019, the Company had revenues of \$544,566.
- *Assets.* As of December 31, 2020, the Company had total assets of \$512,930, including \$118,588 in cash. As of December 31, 2019, the Company had total assets of \$218,867, including \$93,128 in cash.
- *Net Loss.* The Company has had net losses of \$371,706 for 2020 and 290,037 for 2019.
- *Liabilities.* The Company's liabilities totaled \$1,534,765 for 2020, of which \$50,000 is a SAFE investment, \$109,172 is an SBA EIDL loan and \$23,200 is a PPP loan expected to be forgiven by the SBA in the second quarter 2021. The Company's liabilities totaled \$868,996 for 2019.

#### **Liquidity & Capital Resources**

To-date, the company has been financed with \$951,242 in debt, \$300,000 in equity, and \$50,000 in a SAFE.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

Eat Good Do Good, Inc. cash in hand is \$36,162, as of February 2021. Over the last three months, revenues have averaged \$248,345/month, cost of goods sold has averaged \$194,735/month, and operational expenses have averaged \$70,000/month, for an average burn rate of \$16,390 per month. Our intent is to be profitable in 3 months.

The Company has partnered with a new co-packer and is in the process of

implementing a new "delivered" model that will improve the Company's cost structure and thus, profitability. In addition, we have one very significant new retailer that is expected to put our product on its shelves in the next 3 - 6 months, driving significant revenue growth and we have one existing retailer who will expand our product offering in an additional 400 locations nation-wide.

Based on current shipment trends and orders, the Company anticipates (but not guarantees) revenues in the next three to six months to average \$175,000 per month. This is lower than the average monthly revenue in the fourth quarter 2020 due to the fact the Company was meeting pent up demand from prior months when production was delayed. Nevertheless, this average monthly revenue for the next three to six months is higher than the average monthly revenue for all of 2020, that was \$128,000 per month.

The Company has always managed cash flow judiciously; that said, the proceeds from this fund-raising campaign are necessary to expand inventory levels, make key hires and enable strategic sales and marketing initiatives.

While the Company is always speaking to interested investors and lenders, currently the Company does not have any other sources of capital on which to rely.

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor.
