8. Discuss the material factors that make an investment in the issuer speculative or risky:

Pizza and logistics are highly competitive industries. Some of our competitors, including third-party delivery platforms like UberEats and GrubHub, are highly capitalized and more ubiquitous.

Labor costs in San Francisco are rising. As of November 2019, the minimum wage in San Francisco is \$15.69. We pay more than minimum wage to retain good talent and remain competitive. Turnover is more expensive than keeping good team members. We are dependent on local labor, so these costs have a high impact on our margins. This trend is also happening in other markets.

Long term (3-5 years) we are banking on using automation for repetitive tasks and utilization of robotics to amplify EBIDTA as labor costs continue to increase. Autonomous vehicles will also be part of this. If these technologies are not available or if the current downward trend on expense for these technologies does not continue it could be difficult to reduce increasing labor costs.

Like all businesses, and specific to food operations, we are subject to health and supply chain risks. Should there be an issue with producing or distributing our food, our revenues will be impacted. If there is a global pandemic, staffing would not be available to provide our products or services. If there is a global shortage of wheat or other products that we use, this would interrupt our supply chain.

Currently, being undercapitalized, our future success depends on the efforts of a small management team, namely our founder. The loss of services of him may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

General economic downturn. If there is a recession, consumers may have less discretionary income and may order less delivery food.

We are betting that demand for high-quality pizza and faster delivery will continue. This cannot be guaranteed.

We use wood for cooking fuel. This underscores quality, brings higher cooking speeds, and differentiates our brand. Food operations in San Francisco and Los Angeles are exempt from regulations regarding burning wood. If regulations should change Firepie would possibly be required to use natural gas or install filtration systems, creating substantial expense.

For our growth plans, in which any performance is not guaranteed, we will need to raise \$2M and eventually \$10M to approach exit or IPO. We are raising funds in a fluid investment environment and we do not know what this will look like when we go to raise each round.

3. Investor Transfer of Funds. ## Ownership and Capital Structure

### THE OFFERING

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

(i) the total value of the Investor's investment, divided by (a) the price of **Preferred Stock** issued to new Investors multiplied by (b) the **discount rate** (80%) , or (ii) if the valuation for the company is more than **\$4.5 million** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of (a) the Valuation Cap divided by (b) the total amount of the Company's capitalization at that time. (iii) for investors up to the first **\$25,000** of the securities, investors will receive a valuation cap of **\$4,000,000** and a discount rate of 80%

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization will be measured as all **shares of stock** outstanding at the time, not including any SAFEs or convertible notes, plus any **common stock** reserved and available for future grant under any equity incentive or similar plan of the Company or to be created or increased in connection with our equity offering at that time.

Investors who receive shares subject to the Valuation Cap will receive a per share liquidation preference and conversion price designed to provide protection against the price of the **Preferred Stock** being diluted to a value below the price per share at the time they receive **Preferred Stock**. This dilution would mainly occur due to the issuance of additional stock by the Company.

Investors who receive **Preferred Stock** subject to the Valuation Cap will also receive dividend rights.

*No Voting Rights.* Investors will have no voting rights. Instead, the Company's CEO will be provided a proxy to vote on the Investor's behalf.

*Private Sales for Major Investors.* Investors who invest at least \$25,000 and are "accredited investors" will receive the right to purchase a pro-rata share of privately placed securities occurring after an equity offering covered by the SAFEs. *Major Investor Threshold Definition:* A major investor is one who invests a minimum of \$25,000.00 and are "accredited investors" as defined by Rule 501 of Regulation D (17 C.F.R. §230.501(a)). Execution. Investors who invest less than \$25,000.00 will typically not execute transaction documents in order to receive Units at the time of an applicable equity offering. Instead, a "Designated Lead Investor" will execute the documents for them, provided that the documents are consistent with the Units received by new investors in the Company, modified, if applicable, based on the terms of the SAFE. *Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- shares of common stock equal to the amount invested by the Investor in the SAFEs divided by the quotient of (a) the Valuation Cap divided by (b) the number of outstanding shares of the Company's **common stock and Preferred Stock**, but excluding any shares of **common stock** reserved and available for future grant under any equity incentive or grant, SAFEs, and/or convertible promissory notes.

*Termination of the Company.* If the Company ceases operations, liquidates, dissolves, winds up or has its assets assigned to creditors prior to an issuance of securities involving **Preferred Stock**, the Company will pay first the other holders of existing **Preferred Stock**, based on the terms of the Company's certificate of incorporation, and then holders of the SAFEs. These payments will occur before any distributions to holders of common stock. If there are not sufficient Company assets to pay holders of the SAFEs the amount of their investments, as determined by the Company's board of directors, payments will be made on a pro-rata basis. In this case, Investors may not recoup part or all of their investment from the Company. *Repurchases.* If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended, as required by Section 12(g) thereof, the Company shall have the option to repurchase this instrument from the Investor for the greater of (i) the Purchase Amount and (ii) the fair market value of this instrument, as determined by an independent appraiser of securities chosen by the Company.

Because the Investor holds no voting rights, the holders of a majority-in-interest of voting rights in the Company could limit the Investor’s rights in a material way. For example, those interest holders could vote to change the

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

#### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2018, the Company had revenues of \$1,282,750 compared to the year ended December 31, 2017, when the Company had revenues of \$1,037,724. Our gross margin was 21.65% in fiscal year 2018, compared to 44.88% in 2017.

- *Assets.* As of December 31, 2018, the Company had total assets of \$191,173, including \$4,042 in cash. As of December 31, 2017, the Company had \$142,757 in total assets, including \$4,271 in cash.

- *Net Loss.* The Company has had net losses of \$290,320 and net losses of \$131,075 for the fiscal years ended December 31, 2018 and December 31, 2017, respectively.

- *Liabilities.* The Company's liabilities totaled \$803,798 for the fiscal year ended December 31, 2018 and \$465,030 for the fiscal year ended December 31, 2017.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$409,700 in convertibles and \$26,000 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Fasty Fresh, Inc. cash in hand is \$12,000, as of January 2020. Over the last three months, revenues have averaged \$80,000/month, cost of goods sold has averaged \$16,000/month, and operational expenses have averaged \$72,000/month, for an average burn rate of \$8,000 per month. Our intent is to be profitable in 6 months.

We've been decreasing our burn rate by decreasing expenses and growing revenues. We hope to become break even by mid-2020. Around the same time, we're going to increase our marketing spend and position ourselves for growth (opening node #2). We hope to expand our footprint by the end of 2020, potentially through node #2 or a ghost kitchen. We'd like to reach 1.2M of revenue per location. Each additional node costs about \$87k to build.

We plan to raise a larger round potentially from equity crowdfunding or institutional investors for about \$2M. If needed, the founder could issue loans to the company to fund short-term operations.
