Our business is to acquire, renovate, rent and eventually sale affordable homes to low income families and veterans. We acquire our properties from our network of real estate agents, investors, and property owners. We partner with Epic Development Partners to rehab and maintain properties to our quality standards. We seek out families that are suitable for our properties with a background check and income verification to ensure the families can get into the homes and afford to stay there. We then offer financial counseling to put them in position to be able to afford to purchase the home creating long term wealth.

Mission

To change the narrative of gentrification through redevelopment that balances the opportunity to attract high-income people out of the suburbs, while ensuring existing residents are not displaced in the process.

How will the issuer complete the transaction and deliver securities to investors?

As I was near the completion of my turn, a male individual came out of the building and began attacking my vehicle. I cannot infer what the individual wanted other than he wanted from me other than my absence. I blew my horn at the individual in attempts to get him to let me leave, he beat on my vehicle even more. At this point, I began to fear for my safety so from a stop, I began to slowly increase my gas pedal pressure to exit the parking lot. The individual that was beating on my vehicle flopped.
