Business and Anticipated Business Plan

In short, our business is to acquire, redevelop, and rent multifamily properties and sale rehabbed affordable homes, especially those eligible for the federal and state historic tax credit program which allow us to recoup up to 40% of qualified restoration expenses.

Our Business Plan Process:

1. **ACQUISITION:** We purchase value-add properties that qualify for historic tax credits and OZ investments, below market value through our network of real estate agents, wholesalers, investors, contractors, government partnership, and property owners.
2. **CONSTRUCTION:** We partner with CORE Construction Management to execute beautiful renovations to our quality standards through private lending or construction loans and place properties back into commerce for the community.
3. **MONETIZATION:** We monetize the tax credits generated through the company's projects and distribute the return of capital to investors on a pro-rata basis.
4. **STABILIZATION:** We source great tenants and achieve over 90% occupancy within the first 3 months of lease-up. Or we sell new or rehabbed single family homes at market rate and take advantage of the forced appreciation.
5. **REFINANCE:** We refinance our rental properties into Fannie Mae/Freddie Mac, multi-family loans and issue a return to investors based on the cash received

from the refinance.

6. **MANAGEMENT:** We continue to manage and maintain the properties by taking care of our tenants through responsive property management and ongoing maintenance to upkeep the structural integrity of the properties we own.

Buy Back Baton Rouge, LLC ("Company") is offering securities under Regulation CF, through Buy the Block Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 3% of the value of the securities sold through Regulation CF plus a 2% equity stake. The Company plans to raise between \$107,000 and \$1,070,000 through an offering under Regulation CF. In entering into an agreement on the Buy the Block Funding Portal to purchase securities, both investors and Buy Back Baton Rouge, LLC must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed).
