Industry Risks – DRONEDEK requires commercial logistic supply chain and other companies to participate in fully developing the DRONEDEK business plan which may occur slower than anticipated, or may not occur at all.

Funding Risks - DRONEDEK requires significant funding to execute its business plan. The successful execution of the business plan may be delayed or hindered by the company access to future funding requirements.

Financial Risks – DRONEDEK's use of assumptions and estimates, though are conservative and reasonable at time of preparation, may be materially different then estimates used in forward-looking financial forecasts.

Execution Risks - DRONEDEK requires a comprehensive organization and company infrastructure development including departmental support from sales, marketing, installation, customer service, technical, regulatory, human resources, accounting and legal to execute its business plan which may occur slower than anticipated.

COVID-19 can materially impact our business. It is unclear how long the COVID-19 pandemic will last and to what degree it could hurt our ability to generate revenues. For example, it could complicate our ability to procure materials and partnerships. There may be other effects stemming from this pandemic that are deleterious to our company which we have not yet considered.

Daniel S. O'Toole, John Ritchison and Richard B. Ohrn II are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case. However, 2 of the 3 officers will move to full-time upon funding.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.
