The cost of manually rating news articles is high, and the market for news content ratings is still developing. While we have gained traction with early customers in various industries for our data across several target markets, the potential size of these markets is unknown, and may not align with our projections.

It is very difficult to accurately replicate human content analysis, especially in the manner we do it (rating reliability and bias) at scale using AI. Current technology that tries to rate content using AI are 1) limited to heuristics that are easy to measure (such as counting certain types of words) or 2) have the current accuracy limitations of natural language processing technology.

Our ability to truly scale to the point where we can rate all news content accurately and mostly automatically will require us to have technological breakthroughs in this area, and there is no guarantee that we can do that. It is likely that the cost of developing these breakthroughs will be high, requiring significant investment in data science and algorithm development.

Certain news and news-like sources that dislike our mission because they receive low ratings according to our method may attempt to disrupt our work in one or more ways. For example, third parties may undertake negative online social media campaigns, hacking, or frivolous litigation.

There are several competitors entering the field of news source ratings, each of whom has different approaches. We are betting that our two-dimensional rating taxonomy of bias and reliability will provide us a competitive advantage, but this may not be the case. Several of our competitors are better funded and therefore may be further ahead in developing their technology.

Market conditions may limit our ability to fundraise from traditional venture capital markets in the next 12 months.

The company currently does not have any C-suite officers besides the founder and CEO, who is a first-time founder and CEO. Her lack of experience may inhibit her ability to foresee other risks and manage them.

Detractors may attempt cybersecurity attacks such as DDOS, ransomware attacks, and data theft.

Disruptive and unforeseeable changes to existing advertising markets, search engine platforms, and social media infrastructure may limit our opportunities in various markets

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Common Shareholders are entitled to one vote per share and can receive dividends at the discretion of the Board of Directors.

Preferred Shareholders have 1 vote for every common share they could own if converted and are entitled to receive dividends when and if declared by the Board of Directors. Dividends on Preferred Stock are in preference to and prior to any payment of any dividend on Common Stock and are not cumulative.

In the event of any liquidation, dissolution or winding up of the Company, the

holders of the Preferred Stock are entitled to receive prior to, and in preference to, any distribution to the Common Shareholders.

Lastly, Preferred Shareholders have the right to convert to shares of Common Stock at conversion ratios specific to each series of Preferred Stock as described in the amended Articles of Incorporation.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

##### **Runway & Short/Mid Term Expenses**

Ad Fontes Media, Inc. cash in hand is \$45,000, as of September 2022. Over the last three months, revenues have averaged \$24,112/month, cost of goods sold has averaged \$9,798/month, and operational expenses have averaged \$87,575/month, for an average burn rate of \$73,261 per month. Our intent is to be profitable in 8 months.

Since the date of our financials, we have amended our Articles of Incorporation to increase the number of authorized shares of Common Stock to 14,000,000 shares at no par value.

We expect our revenues to increase to \$100,000 per month within three months and \$150,000 per month within six months, and our expenses to increase to \$200,000 per month in those months.

We are not yet profitable, but we anticipate being able to reach profitability by raising this current portion (\$400K) on Wefunder, plus an additional \$500K we are seeing from investments through Reg D. With that total funding (nearly \$1M new), we expect to reach profitability within 8 months.

We are raising additional funds through Reg D simultaneously and between those funds and available debt options, we will be able to cover short-term burn

throughout this campaign.
