The current PPE market is in flux with an unknown future. While research shows the mask market has grown from 4.35 Billion Units in 2018 to 81.19 Billion in 2020, and is expected to reach 166.64 Billion Units by 2026, there is no way to guarantee this growth.

Competition from China has already driven the price per mask to below pre-COVID numbers. While we continue to sell masks at 8x-10x Chinese prices there is no assurance that this will continue. We are betting on American's desire to purchase here in the United States.

Manufacturing has inherent risks such as mechanical and human error all of

which can effect outputs and delivery dates.

Raw material costs are outside of our control and can change our cost of goods sold. While we have estimated these costs high, it is still something that could adversely affect the business.

We have to store large quantities of raw materials and finished product at our warehouse outside Austin, TX. While we follow all applicable laws around safety and hold the proper amounts of insurance, these materials represent a risk of temporary loss to the business due to damage, fire, or theft.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Use of Proceeds: 13% buying automated mask assembly line; 7% for air freight and tariffs; 17% for installation and American design upgrades; 27% relevant share of factory's Meltblown, Spunbond, Cleanroom, and Packaging lines; 28.5% for additional automated assembly lines, and 7.5% to Wefunder

The Company is issuing Convertible Promissory Notes (the "Notes") and Royalty Participation Rights (the "Royalty Participation Rights" and, together with the Notes, the "Securities").

Interest rate: 2%

Maturity date: 48 months from the Effective Date.

Payment of Principal and Interest. Commencing with the calendar quarter in which Production Unit Profit is realized, the Company shall make payments on this Note within 20 calendar days of the end of each calendar quarter, until this Note, together with all accrued and unpaid interest, shall have been paid in full, in an amount equal the Holder's Pro Rata Share of **65%** of accrued Production Unit Profit for such calendar quarter. Notwithstanding the foregoing, the entire principal balance of this Note then unpaid, together with all accrued and unpaid interest, shall be due and payable in full on the Maturity Date. All payments on this Note shall be applied first to the payment of accrued but unpaid interest hereon and then to the payment of all or any portion of the principal balance outstanding hereunder.

Source, Amount and Timing of Royalty Payments. Commencing with the calendar quarter that ends immediately after the Note has been repaid in full, the Company shall pay to Investor within 20 calendar days of the end of each calendar quarter, royalty payments equal to the applicable percentage set forth on Exhibit B attached hereto (for the avoidance of doubt, such applicable percentage to be based on the cumulative Royalty Payments made to date) of accrued Production Unit Profit for such calendar quarter (the "Royalty Payments"). For the avoidance of doubt, any amounts paid pursuant to Section 2 of the Note shall be deducted from the Royalty Payments otherwise required to be paid for the quarter under this Agreement in which the Note has been repaid in full.

Financing Conversion. The entire outstanding principal amount of this Note, any accrued but unpaid interest and any other amounts payable under this Note may be converted, at the discretion of the Holder, into Qualified Financing Securities upon the closing of a Qualified Financing. In the event of such conversion, this Note shall be converted into that number of the applicable securities determined by dividing (i) the original principal amount of this Note by (ii) the Note Conversion Price.

Conversion or Payment upon Change of Control:

(a) Notwithstanding any other provision of this Note, if a Change of Control occurs where the consideration paid by an acquiring person (or persons) to the Company's stockholders or equity interest holders consists entirely of equity securities that are not publicly traded and listed on a national securities exchange, the then-outstanding principal amount of this Note and all accrued and unpaid interest on this Note shall automatically convert as of immediately prior to such Change of Control into a number of equity securities of the Company that represents a percentage ownership of the Company determined by dividing (expressed as a percentage) (i) the original principal amount of this Note by (ii) the Change of Control Value multiplied by 0.90.

(b) Notwithstanding any other provision of this Note, if a Change of Control occurs where the consideration paid by an acquiring person (or persons) to the Company's stockholders or equity interest holders does not consist entirely of equity securities that are not publicly traded and listed on a national securities exchange, the then-outstanding principal amount of this Note and all accrued and unpaid interest on this Note shall automatically convert as of immediately prior to such Change of Control into a number of equity securities of the Company that represents a

percentage ownership of the Company determined by dividing (expressed as a percentage) (i) the original principal amount of this Note by (ii) the lower of (x) the Change of Control Value multiplied by 0.80 and (y) \$25,000,000.

“Change of Control” means a change in ownership or control of the Company effected through any of the following transactions, in each case excluding a bona fide financing transaction effected primarily for capital raising purposes:

- (a) a merger, consolidation or other reorganization approved by the Company’s stockholders, unless securities representing more than fifty percent (50%) of the total combined voting power of the voting securities of the successor corporation or its direct or indirect parent entity are immediately thereafter beneficially owned, directly or indirectly and in substantially the same proportion, by the persons who beneficially owned the Company’s outstanding voting securities immediately prior to such transaction;
- (b) a stockholder-approved sale, transfer or other disposition of all or substantially all of the Company’s assets in liquidation or dissolution of the Company;
- (c) the acquisition, directly or indirectly by any person or related group of persons (other than the Company or a person that directly or indirectly controls, is controlled by, or is under common control with, the Company), of beneficial ownership (within the meaning of Rule 13d-3 of the Securities Exchange Act of 1934, as amended) of securities possessing more than fifty percent (50%) of the total combined voting power of the Company’s outstanding securities pursuant to a stock purchase transaction or a tender or exchange offer made directly to the Company’s stockholders; or
- (d) the exclusive licensing of all or substantially all of the Company’s intellectual property in a single transaction or series of related transactions.

“Note Conversion Price” means the lowest per share purchase price paid for the Qualified Financing Securities by the investors of new money in the Qualified Financing.

“Qualified Financing” means the next transaction (or series of related transactions) after the date of this Note and before Maturity in which the Company issues and sells shares of its equity securities in exchange for aggregate gross proceeds of at least \$5,000,000 (excluding amounts deemed received upon conversion of the Notes and any other indebtedness or similar convertible securities), with the principal purpose of raising capital.

Source, Amount and Timing of Royalty Payments. Commencing with the calendar quarter that ends immediately after the Note has been repaid in full, the Company shall pay to Investor within 20 calendar days of the end of each calendar quarter, royalty payments equal to the applicable percentage set forth on Exhibit B attached hereto (for the avoidance of doubt, such applicable percentage to be based on the cumulative Royalty Payments made to date) of accrued Production Unit Profit for such calendar quarter (the “Royalty Payments”). For the avoidance of doubt, any amounts paid pursuant to Section 2 of the Note shall be deducted from the Royalty Payments otherwise required to be paid for the quarter under this Agreement in which the Note has been repaid in full.

SAFE Conversion. At any time after (a) the Note has been repaid in full, and (b) the board of directors of the Company determines to change the strategic direction of the Company, the Company at its discretion and upon notice to the Investor, may convert this Right to an uncapped, undiscounted Simple Agreement for Future Equity (SAFE) substantially in the form as referenced in Exhibit A, with a principal amount equal to the Investment Unit Price.

Applicable Percentage of Production Unit Profit payable and Total Royalty Payment made:

- **20%: Until 1x** in cumulative Royalty Payments have been made- **15%: Until 2x** in cumulative Royalty Payments have been made

We manufacture FDA-Registered Surgical and N95 Masks in our own custom-built 45,000 square foot factory--located just outside of Austin, TX.

In less than 5 months, we built an automated factory capable of producing millions of masks per day. In 5 years, we hope to be producing over 1,000 products--all that take advantage of huge macro trends happening today like Automation, Direct to Consumer, Environmentalism, low energy costs, USA Made, and a changing US Job Market that needs a manufacturing rebirth to survive.

Milestones

Armbrust Inc. was incorporated in the State of Delaware in October 2018.

Since then, we have:

- We are proven team with several previous exits, lead by a former Y Combinator founder who has raised over \$10M and built multiple companies with revenues in the tens of millions annually.
- We took less than five months to build the second-largest mask factory in the United States, making over \$6M in revenue with \$14M annual run rate.
- We received FDA-Registration and ASTM Level 2 certification to sell Surgical Masks faster than anyone has before, and we are 60 days away from N95 approval.
- In the three months since launching our website, we have processed more than 3.5M direct to consumer orders, and have direct deals with the State of Texas, the States of Illinois, and large hospital systems like Kaiser Permanente.

Historical Results of Operations

Our company was organized in October 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

Liquidity & Capital Resources

To-date, the company has been financed with \$4,542,297 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, we expect to continue to be cashflow positive.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Armbrust Inc. cash in hand is \$1,687,453.88, as of September 2020. Over the last three months, revenues have averaged \$1,883,457.64/month, cost of goods sold has averaged \$1,006,015.46/month, and operational expenses have averaged \$1,095,452.02/month, for an average burn rate of \$218,009.84 per month.

We started producing masks, selling direct to consumers and to governments and institutions. This has caused us to generate \$7.27mm in less than six months of operation.

We hope revenues will increase to over \$3mm per month breaking \$36mm annual run rate before Q1 2021. These projections cannot be guaranteed.

We primarily fund the business from sales direct from over 50,000 consumer accounts and hundreds of enterprise accounts. If existing consumer sales were to evaporate we could sustain the business on current capital and enterprise contracts for the next 24 months.
