Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

T2M operates in the video games market focused on the mobile sector, which is the largest (\$77Bn) and fastest growing sector within video games (\$160Bn). The management team pioneered this sector when they developed the very first dedicated mobile device for iPhone (Gamevice). The company's key product is the Rotor Riot Gamepad Controller that is sold in all Apple stores worldwide as well as the top 800 Best Buy stores and is scheduled for the top 900 Target stores starting in Q4. The Rotor Riot Gamepad Controller is also the number one best seller (in standard controllers) on Amazon. Sales of this controller accounts for 99% of the Company's revenue. In addition to the controller sales, the Company also operates an RMA (return to manufacturer authorization) that "renews" the customer "buyer remorse" returns and then sells then on our Amazon store front at a reduced price with a 90-day Amazon guarantee. This RMA center is staffed by young adults with diverse abilities. Finally, the company is looking to grow the financial opportunities/possibilities via its companion app "Ludu Mapp" which has been downloaded in more countries than the hardware is present. The plan is to make the app "sticky" by offering more content than just the curated games that are controller compatible. The next steps for the Company are to create a platform that offers news and other social media functions to encourage daily usage. Part of the vision is also to integrate ESL's tournament software so that tournament participants would access via Ludu Mapp.

T2M currently has 12 employees.

Risk Factors

- 1. If the Company is unable to raise additional capital on acceptable terms, it may be unable to maintain sufficient growth or commercialize its products. The Company may require substantial future capital in order to continue to conduct the research, product development, and marketing required to scale the business. There can be no assurance that additional funding will be available on acceptable terms. Failure to satisfy our capital requirements may adversely affect the Company's business, financial condition, and results of operations because the Company would be left without the capital required to complete product development or establish sales and marketing capabilities.
- 2. The United States and other countries have experienced and may experience in the future, major health epidemics related to viruses, other pathogens, and other unforeseen or catastrophic events, including natural disasters, extreme weather events, power loss, acts of war, and terrorist attacks. For example, there was an outbreak of COVID-19, a novel virus, which has spread to the United States and other countries and declared a global pandemic. The global spread of COVID-19 has created significant volatility and uncertainty in financial markets. Although COVID-19 is currently not material to our results of operations, there is significant uncertainty relating to the potential impact of COVID-19 on our business. The extent to which COVID-19 impacts our current capital raise and our ability to obtain future financing, as well as our results of operations and financial condition, generally, will depend on future developments which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of COVID-19 and the actions taken by governments and private businesses to contain COVID-19 or treat its impact, among others. If the disruptions posed by COVID-19 continue for an extensive period of time, our business, results of operations, and financial condition may be materially adversely affected.
- 3. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. - 6. We are highly dependent on the Services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if he fails to perform in his current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 7. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses

- 8. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
- 9. The Company's success also depends on the Company's ability to attract, train, and retain qualified personnel, specifically those with management and product development skills. In particular, the Company must hire additional skilled personnel to further the Company's research and development efforts. Competition for such personnel is intense. If the Company does not succeed in attracting new personnel or retaining and motivating the Company's current personnel, the Company's business could be harmed.
- 10. We operate in an emerging market that is characterized by rapid changes in customer requirements, frequent introductions of new and enhanced products, and continuing and rapid technological advancement. Our technology may under perform the technology utilized by our competitors.
- 11. Intense competition in the markets in which we compete could prevent us from generating or sustaining revenue growth and generating or maintaining profitability.
- 12. Our future growth depends to a large extent on our ability to effectively anticipate and adapt to customer requirements and offer services that meet customer demands. If we are unable to attract customers and/or retain customers, our business, results of operations and financial condition may be materially adversely affected.
- 13. Maintaining our reputation is critical to our ability to attract and retain users, and our failure, or perceived failure, to appropriately operate our business or deal with matters that give rise to reputation risk may materially and adversely harm our business, prospects and results of operations. Our failure to deliver appropriate standards of service and quality could result in customer dissatisfaction, litigation and heightened regulatory scrutiny, all of which can lead to lost revenue, higher operating costs and harm to our reputation. Further, negative publicity regarding us, whether or not true, may be detrimental to our business.

Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. The Company may extend the Offering Deadline beyond what is currently stated herein. Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

18. The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

- 21. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. The Offering

T2M LLC ("Company") is offering securities under both Regulation D, through Livingston Securities, LLC ("Livingston") and Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Livingston is a registered broker-dealer, and member FINRA/SIPC. Livingston will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation D. Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities made under both Regulation D and Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

This offering is considered a side-by-side offering, meaning that the Company is raising capital under two offering types. The Company plans to raise between \$10,000 and \$2,500,000 through concurrent offerings under Regulation CF and Regulation D – Rule 506(c). Specifically, if we reach the target offering amount

of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). T2M, LLC is registered in Minnesota and has 80% membership interest held by founders and staff. 15% is held by 3 angel investor groups (5% each) with a remaining 5% membership interest being sold in this transaction. If the total amount of the offering is raised, 10% of the proceeds will be allocated to new tooling to enhance our product line, 40% to operating the company, 48% to inventory as we gear up for the Christmas selling season, and 2% for consulting fees.

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and T2M LLC must agree that a transfer agent, which keeps records of our outstanding Membership Units (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Financial Condition of the Issuer

The company had cash and cash equivalents of \$283,174 as of 12/31/19. Total assets were \$1.5 million, of which inventory represented 43%. Total liabilities were \$1.1 million. T2M generated revenues of \$937,782 in 2019, an increase of 552% over 2018 revenues of \$143,860. The company generated an operating loss of (\$804,961) vs. a loss of (\$279,826) in the previous year. Payroll of \$464,961 represented the majority of operating expenses. Operating cash flow was negative at (\$1.7 million) vs. (\$487,784) in the previous year. This change was driven primarily by an increase in inventory investment of almost \$590,000. In subsequent events, the term for the company's \$500,000 loan was extended an additional 12 months to May of 2021, and the company's lender also agreed to an extension of the maturity date on its \$1 million revolving credit facility through October of 2021.
